Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Roofers and Slaters Local Union No. 248 Annuity Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Roofers and Slaters Local Union No. 248 Annuity Fund's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2024 and 2023, and for the year ended November 30, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C)

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Roofers and Slaters Local Union No. 248 Annuity Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Roofers and Slaters Local Union No. 248 Annuity Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets held at year end for the year ended November 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. 1. DESCRIPTION OF THE PLAN

The following description of the Roofers and Slaters Local Union No. 248 Annuity Fund Annuity Fund (the Fund) provides only general information. Participants should refer to the Fund Agreement for a more complete description of the Fund's provisions.

General – The Fund is a plan participant directed non-contributory defined contribution profit sharing plan covering substantially all employees subject to the provisions of the collective bargaining agreement between Roofers and Slaters Local Union No. 248 Annuity Fund and participating employers. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits – Benefits are paid out upon an eligible employee's retirement, termination, disablement or death. Payments to participants and beneficiaries are recorded upon distribution. Participants should refer to the Fund agreement for a complete description of the Fund's provisions covering benefits.

Contributions – Participating employers contribute to the Fund based on hours worked by covered employees at rates, as specified in the collective bargaining agreement, in effect for the year. Participants direct the investment of their contributions into various options offered by the Fund. The Fund currently offers a guaranteed investment contract and various pooled separate accounts as investment options for the participants.

Participants accounts – Each participant's account is credited with the participating employer's contribution and an allocation of Fund earnings(losses) and is charged with an allocation of administrative expenses. Allocations are based on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All accounts are participant directed.

Vesting – Participants are immediately vested in their accounts.

Notes receivable from participants – Participants may borrow from their fund accounts a maximum amount equal to the lower of \$50,000 or 50% of their account balance. Participants may have up to two loans outstanding at one time. The loans are secured by the balance in the participants' account and bear an interest rate of 4.25% - 9.50% for 2024 and 2023. Principal and interest is paid ratably monthly. Loans are for five years or less unless proceeds are used for the purchase of a principal residence.

Administrative expenses – The Fund is responsible for payment of the investment and other administrative expenses and fees. These expenses and fees are paid by the plan by reducing the balances of the participant accounts. For the years ended November 30, 2024 and 2023, these fees were \$17,391 and \$19,565, respectively.

Priorities upon termination of the fund – In the event of a termination of the Fund, the participants have certain specific rights. Participants should refer to the Fund Agreement for a complete description of the Fund provisions covering the priorities upon the termination of the Fund.

2. SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Fund is presented to assist in understanding the Fund's financial statements. The financial statements and notes are representations of the Fund's management, who are responsible for their integrity and objectivity. These accounting policies conform to generally accepted accounting principles and have been consistently applied in the preparation of the financial statements.

2. SIGNIFICANT ACCOUNTING POLICIES (continued)

Business activity – The Fund is responsible for administering annuity funds for employees of contractors who are affiliated with the Local Union No. 248 Roofers and Slaters Union. The Fund collects contributions from the affiliated contractors and transfers these to John Hancock Life Insurance Company who invests and distributes the annuity funds.

Basis of accounting – The Fund uses the accrual basis of accounting. Under the accrual basis of accounting, revenues are recognized when earned and expenditures are recognized when incurred rather than when collected or paid.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and of contingent assets and liabilities disclosure. Accordingly, actual results could differ from those estimates.

Investments – Quoted market prices are used to value investments, except for the Stable Fund, which is valued at contract value.

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions receivable – The Fund uses the allowance for credit losses method for uncollectible accounts based on management's evaluation of outstanding contributions receivable. It is management's opinion that all accounts recorded on the books are collectible.

Tax status – The Fund is a tax-exempt entity under Section 501(a) of the Internal Revenue Code. The Fund obtained its latest determination letter on July 9, 2015, in which the Internal Revenue Service stated that the Fund, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Fund has been amended since receiving the determination letter. However, the plan administrator believes that the Fund is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Service. Therefore, no provision for income taxes is included in the Fund's financial statements.

The Fund has adopted Accounting Standards Codification, "Accounting for Uncertainty in Income Taxes." Accounting Standards Codification prescribes a comprehensive model for the financial statement recognition, measurement, classification and disclosure of uncertain tax positions. Management has not identified any uncertain tax positions and, therefore, no liability has been recorded in the financial statements.

The Fund's income tax filings are subject to audit by the Internal Revenue Service.

Fair value - Accounting Standards Codification provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification are described as follows:

- Level 1 valuations reflect quoted market or exchange prices for the actual or identical assets or liabilities in active markets.
- Level 2 valuations reflect inputs other than quoted prices in Level 1 which are observable. The inputs can include some or all of the following into a valuation model:
 - quoted prices on similar assets in active markets
 - quoted prices on actual assets that are not active
 - inputs other than quoted prices such as yield curves, volatilities, prepayments speeds
 - inputs derived from market data
- Level 3 valuations reflect valuations in which one or more of the significant valuation inputs are not observable in an active market, there is limited if any market activity, and/or are based on management inputs into valuation model.

The Fund maintains policies and procedures to value instruments using the best and most relevant data available. In addition, the Fund has an investment management team that reviews valuation, including independent price validation for certain instruments. Further, in most instances, management develops internal valuations of the assets and instruments held in the Fund.

Subsequent events – Management has evaluated subsequent events through August 8, 2025, the date which the financial statements were available to be issued.

3. INVESTMENTS

The following section describes the valuation methodologies the Fund uses to measure investments at fair value.

Mutual funds – Valuations are done on a daily basis. The Trustee receives net asset values directly from mutual funds. Based on the above definition, the Funds’ assets have been classified as NAV investments.

The following section describes the valuation methodologies the Fund uses to measure investments at contract value.

Stable fund – The stable fund is invested primarily in benefit responsive insurance contracts. Under the terms of the contract, a crediting rate is established for amounts invested in the GAC and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant fair value measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value as stipulated by Accounting Standards Codification. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if there were to initiate permitted transactions under the terms of the Plan.

The Trust contributes funds to John Hancock Life Insurance Company for each covered participant. The insurance company maintains the contributions in a guaranteed interest account and various pooled separate accounts. The accounts are credited with earnings on the underlying investments and charged for withdrawals and administrative expenses. The contract is included in the financial statements at fair value, as reported to the Fund by John Hancock Life Insurance Company.

4. RELATED PARTY TRANSACTIONS

John Hancock Life Insurance Company is the Plan's custodian and, as such, transactions with the custodian qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions.

Payroll, payroll taxes, and employee benefits are reported and paid by the Health and Welfare Fund for the Health and Welfare Fund, the Annuity Fund, and the Pension Fund. An annual allocation is made, and funds are transferred to apportion these costs based on the time spent working on each Fund.

The amounts included as "Due to Other Funds" represent certain administrative expenses paid on behalf of the Annuity Fund by an affiliate of the Fund.

5. ERISA SECTION 103(A)(3)(C) AUDIT

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at November 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan.

6. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available.
