Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the ENSCO, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We have performed audits of the financial statements of the ENSCO, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For

Notes to Financial Statements

1. Description of the Plan

The following description of the ENSCO, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of ENSCO, Inc. (the Plan Sponsor or Employer). The following categories of employees are not eligible to participate in the Plan:

- Employees covered under a collective bargaining agreement (i.e., union employees).
- Non-resident aliens who have no earned income from sources within the United States.
- Leased employees.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees are eligible to participate on their first day of employment.

Custodian, Trustee, and Administration of the Plan

The custodian and recordkeeper of the Plan is The Vanguard Group, and the trustee of the Plan is Vanguard Fiduciary Trust Company (collectively referred to as Vanguard). The administrator of the Plan is the Company. Vanguard holds all assets of the Plan in accordance with the service provider contract with the Company. The Retirement Plan Executive Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

On an annual basis, non-highly compensated participants may make pre-tax or Roth contributions up to 100% of annual compensation. Highly compensated participants may make pre-tax or Roth contributions up to 18% of pre-tax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions), as defined in the Plan's provisions. Effective January 2, 2024, the Plan was amended to include an automatic deferral amount of 3% of Plan compensation for eligible employees hired on or after January 1, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan makes nondiscretionary employer matching contributions up to 6% of eligible compensation for all participants regardless of their years of service. Additional discretionary employer profit-sharing contributions may be made at the discretion of the Company's Board of Directors. No such contributions were made for the year ended December 31, 2024.

Participants direct the investment of their contributions and employer matching contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions including amounts rolled over from other qualified plans, the contributions made on his or her behalf by the Company, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on fixed quarterly recordkeeping fees and specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary, rollover and Employer profit sharing contributions, as well as actual earnings and losses thereon. If hired prior to January 1, 2022, a participant is 40% vested in Company matching contributions after completing two years of service, which then vests an additional 20% per year for each of the next three years. The Company amended the Plan to provide for a three-year graded vesting schedule for Company matching contributions for all active employees hired or rehired on or after January 1, 2022. Prior to January 1, 2022, a year of service was defined in the Plan's provisions as a plan year in which a participant completes at least 1,000 hours of service as an employee of the Company. The Company amended the Plan to define one year of vesting service as 80 hours of service within a plan year effective January 1, 2022. Upon retirement at age 65, disability, or death, while an employee of the Company, participants or their beneficiary are immediately entitled to 100% of Company matching contributions.

Payment of Benefits

Benefits are payable upon retirement at age 65, disability, death or termination of employment. In-service withdrawals upon reaching age 59½ are also permitted, subject to provisions stipulated in the Plan document. In-service withdrawals at the age of 59½, from a participant's elective deferral and rollover contributions into the Plan are permitted. Benefits are payable via lump-sum, partial distribution, installment payments, or rollover payments to another qualified plan.

Any time after termination of service, if the vested value of a participant's account is less than \$1,000, his or her account will be distributed in a single lump-sum payment if the participant has not elected a rollover or cash out within 90 days of termination. If the vested value of a participant's account exceeds \$1,000, he or she may elect to leave their assets in the Plan until distribution is required by law, or to receive either a lump-sum amount or have all the distribution paid in a direct rollover to another qualified plan, or a combination of the above.

Forfeited Accounts

The Company maintains a separate forfeiture account with Vanguard. After an employee terminates prior to full vesting, the Plan's cumulative, unvested matching contributions made on behalf of the participant, as well as earnings and losses thereon, are transferred to the Company's forfeiture account after five consecutive breaks in service or upon account distribution, whichever occurs first. Additionally, the forfeiture account includes uncashed and/or undelivered distribution checks. At December 31, 2024 and 2023, forfeited accounts totaled \$308,384 and \$307,675, respectively. Forfeited accounts are utilized to reduce employer contributions and pay administrative expenses. Forfeitures of \$151,069 were used to reduce employer contributions during the year ended December 31, 2024.

Notes Receivable from Participants

Participants may borrow from their vested account balances a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding balance on any loan to the participant during the one-year period before the date of the new loan, or 50% of their vested account balance on the date the loan is requested. Loan terms range from one to five years or longer if the loan proceeds were used to purchase a primary residence. Notes are secured by the vested balance in the participant's account and bear interest at the prime interest rate plus two percentage points, determined at the inception of the note. These rates are consistent with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Each participant may only have one loan outstanding at one time. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Retirement Executive Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for additional information about fair value measurements.

Purchases and sales of securities are recorded principally on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds - Money market funds are valued at amortized cost, which approximates fair value.

Self-Directed Brokerage Accounts - These accounts are comprised of common stock, mutual funds, and cash and cash equivalents. Common stock is valued at the published market price on an active market. The mutual funds are valued as described above.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan Administrator performs on-going due diligence of the funds which includes reviewing and comparing to the reports from Vanguard.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Brokerage account-related expenses are included in net appreciation of fair value of investments. The Plan also pays for recordkeeping and information management, and investment advisory fees for certain participants on the accounts managed by the custodian.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

5. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Vanguard and its subsidiaries or affiliates. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA.

6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to suspend or discontinue contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of complete or partial Plan termination, participants would become 100% vested in their account balances.

8. Income Tax Status

The Plan uses a pre-approved plan document sponsored by Vanguard. Vanguard received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related Trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

9. Subsequent Events

The Plan Administrator has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
