INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Mentor Technical Group, Corp. Profit-Sharing and Savings Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). 1) Description of plan and summary of significant accounting policies -

- A) **Description of Plan** - The following description of the Mentor Technical Group, Corp. Profit-Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a profit-sharing and defined contribution plan covering all full-time employees of Mentor Technical Group, Corp. (the Company) who are residents of Puerto Rico, have completed three months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute deferral contributions, as defined in the Plan or in accordance with law (\$15,000 for 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes a matching contribution of \$.25 of each dollar contributed by employees to up to 6% of base compensation as defined by the Plan. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors and are invested in a portfolio of investments as directed by the Company. Contributions are subject to certain limitations.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan's earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is one hundred percent vested after 3 years of credited service.

Participant loans - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lower of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Plan termination - Although it has not expressed any intent to do so, the Plan's Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Forfeitures - As established by the Plan document, forfeitures may be used to reduce Plan's administrative expenses or future Company's contributions. As of December 31, 2024 and 2023, forfeitures contributions amounted to approximately \$69,000 and \$65,000, respectively.

Party-in-interest - During the years ended December 31, 2024 and 2023, certain Plan assets are investments funds managed by Empower Trust Company, LLC. and subsidiaries which acted as the trustee of the Plan. Accordingly, transactions qualify as party-in-interest under ERISA regulations.

- B) Summary of significant accounting policies** - The accounting and financial reporting policies of the Plan conform with accounting principles generally accepted in the United States of America and to prevailing practices within its industry. The following is a description of the most significant of these policies:

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates - Preparing the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Operating expenses - The majority of expenses of maintaining the Plan are paid by the Company.

Subsequent events - The Plan has evaluated subsequent events through September 9, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 fair value measurements - Separate accounts investing in mutual funds or equity securities are measured using quoted prices in active markets for identical assets.

Level 2 fair value measurements - Separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

The fully-benefit responsive contract is invested in the general account of the insurance company issuing the contract. It has no maturity value. The effective credit interest rate is set monthly and effective on the first day of the month, during which a new interest rate is applied daily to the total outstanding balance of the investment.

The Plan evaluated the significance of the transfers between levels based upon the nature of the financial information and size of the transfer relative to total net assets available. There were no transfers in the levels classifications during the years ended December 31, 2024 and 2023.

Plan's fiduciary of the Mentor Technical Group, Corp. Profit-Sharing and Savings Plan set investment policies, and strategies for trust. Long-term strategic investment objectives include preserving the funded status of the trust and balancing risk and return. Plan's fiduciary oversees the investment allocation process, which includes selecting investment managers, commissioning periodic asset-liability studies, setting long-term strategic targets and monitoring asset allocations. Target allocation ranges are guidelines, not limitations, and occasionally Plan's fiduciary will approve allocations above or below a target range.

3) Investment contract with insurance company -

The Plan has entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America. The insurance company maintained the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as certified to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 1) B, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the guaranteed investment contract. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract as of December 31, 2024 and 2023 amounted to approximately \$202,000 and \$197,000, respectively. The effective credit interest rate is set monthly and effective on the first day of the month during which a new interest rate is applied daily to the total outstanding balance of the investment. The guaranteed investment contract has no maturity date.

4) Tax status -

The Puerto Rico Treasury Department (the Department) has determined and informed the Plan Sponsor by letter dated March 18, 2015, that the Plan and the related trust, as designed, qualified for tax-exempt status under the provisions of the “Código de Rentas Internas para un Nuevo Puerto Rico”, as amended, and the Circular Letter No. 11-10 of December 16, 2011 issued by the Department.

Accounting principles generally accepted in the United States of America require Plan’s management to evaluate tax positions taken by the Plan and recognize tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department. The Plan administrator has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

5) Risk and uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets.
