### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cousins Properties Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("the financial statements").

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. PLAN DESCRIPTION

**General**—The following description of the Cousins Properties Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

The Plan is a defined contribution benefit plan established by Cousins Properties Incorporated under the provisions of Sections 401(a) and 401(k) of the Internal Revenue Code ("IRC") for the benefit of eligible employees of Cousins Employees, LLC, a wholly owned subsidiary of Cousins Properties Incorporated (collectively the "Company"). The Company serves as Plan administrator. Principal Trust Company ("Principal") is the trustee of the Plan (the "Trustee"). Participants may elect to make pre-tax contributions to the Plan. The Company may also elect to make contributions to the Plan at its discretion. Each of these types of contributions is described below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Participant Contributions**—Employees are eligible to participate in the Plan beginning on the date of hire. Participants may elect to make pre-tax contributions through payroll deductions subject to the maximum dollar amount under Section 402(g) of the IRC, as adjusted annually. All eligible employees who have attained the age of 50 before the close of the Plan year are eligible to make catch-up contributions in accordance with, and subject to, the limits of the IRC, as adjusted. Participant contributions are recorded when withheld.

In December 2022, the SECURE 2.0 Act of 2022 was enacted. Among other things, included in this act is the requirement that catch-up eligible participants meeting the IRS higher-income participant threshold make any catch-up contributions to a workplace plan into a Roth 401K beginning January 1, 2026. The Company is amending the Plan to comply with the above requirements and does not anticipate material changes to the Financials or the Plan related to this act.

Participant contributions to the Plan may also include participant rollovers from other plans.

**Employer Contributions**—The Company has discretion over the amount it contributes to the Plan during the Plan year. A participating employee is eligible to receive employer contributions subject to the provisions described below. Employer contributions will be allocated among investment options as specified by the participant. Employer contributions are made when earned.

Contributions made on behalf of a participant including pre-tax employee contributions and employer contributions cannot exceed the annual limit under Section 415(c) of the IRC, and the Plan is required to return any contributions made during the Plan year in excess of these annual limits.

For the year ended December 31, 2024, the Company contributed 3% of each employee's eligible pre-tax earnings, subject to certain IRC limits. Eligible pre-tax earnings include base salary, overtime, bonuses and commissions. The Company may change this policy at

its discretion, and, in addition, the Company may decide to make additional or replacement discretionary contributions in the future.

**Investment Options**—Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers two options. The first option offers investment options in various mutual funds and collective trust funds. The second option is a participant-directed brokerage account that allows participants to directly purchase money market funds, corporate bonds, mutual funds, and preferred and common stocks of any company, other than Cousins Properties Incorporated.

**Payment of Benefits**—Upon termination of service, death, disability, retirement, or the attainment of age 59 1/2, a participant or his or her beneficiary becomes eligible to receive an amount equal to the value of the participant’s account.

**Vesting**—Participants are immediately vested in their elective contributions and the earnings thereon.

Vesting in any employer contributions is based on years of service with the Company based on the following schedule of service.

**Participant Accounts**—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution, the employer contributions, and allocations of Plan earnings or losses, and is reduced by certain administrative expenses and any withdrawals. Allocations of Plan earnings (losses) are made based on relative account balances, as well as investment selections.

**Participant Notes Receivable**—A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance, with a minimum loan amount of \$1,000, and participants may not have more than two loans outstanding at any time. Principal and interest on participant notes receivable are paid ratably through payroll deductions over periods ranging up to 30 years for notes used for purchase of a primary residence and up to 60 months for other notes. The loans are secured by an assignment of a participant’s vested interest in the Plan, and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan administrator. Any interest paid is credited to each participant's respective account in the Plan. As of December 31, 2024, participant notes receivable have maturities through 2051 and interest rates ranging from 4.25% to 9.50%. Delinquent participant notes receivable are recorded as distributions based on the terms of the Plan document.

**Forfeitures**—Unvested account balances from employer contributions are generally forfeited five years after an employee's termination unless a distribution of vested funds occurs sooner. The proceeds from these forfeitures can be used to reduce subsequent employer contributions or to pay administrative fees of the Plan. As of December 31, 2024 and 2023, there were \$99,000 and \$18,000 of unapplied forfeitures invested in holding accounts, respectively. During 2024, administrative fees were reduced by \$48,000 from forfeited unvested accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**Risks and Uncertainties**—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

**Valuation of Investments and Income Recognition**—Money market funds are stated at cost, plus accrued interest, which approximates market value. Collective trusts are stated at net asset value, which is used as a practical expedient to estimate fair value. Marketable securities, including mutual funds, preferred stock, common stock, and other securities held in participant-directed brokerage accounts, are stated at fair value based on quoted market prices. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized gains (losses) and unrealized appreciation (depreciation) of investments are combined and recorded as net appreciation (depreciation) in fair value of investments.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Administrative Expenses**—The Plan incurs administrative expenses from the plan trustee and third parties related to the administration of the Plan. Administrative costs of the trustee, which include recordkeeping and information management fees, notes receivable processing fees, self-directed brokerage account investment management fees, redemption fees, and securities brokerage commissions and fees, are included in the plan financials and are paid for by the Plan with forfeited contributions with the remainder paid by Plan participants. Third-party administrative expenses, such as expenses for the review of plan financials by independent auditors and outside legal counsel, are paid for by the Company and, therefore, not recorded in the accompanying Plan financial statements.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023, there were no participants who elected to withdraw from the Plan but had not yet been paid.

**Subsequent Events**—Subsequent events were evaluated through September 9, 2025, the date the financial statements were available to be issued, with no events requiring disclosure.

### 3. INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule that was prepared by, or derived from, information prepared by the Trustee and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Trustee that such information is complete and accurate. In addition to the table below, the Trustee has certified to all investment balances and information on the supplemental schedule and to the detail of investment balances and information included in Note 3 (except for the fair value leveling) herein.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs into valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowers priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

**Level 1**—Observable inputs such as quoted prices in active markets.

**Level 2**—Inputs other than quoted prices in active markets that are either directly or indirectly observable.

**Level 3**—Unobservable inputs for which little or no market data exists, therefore, requiring the Plan to develop its own assumptions.

The following is a description of the valuation methodologies used for assets measured at fair value. The Company evaluates the leveling of the Plan's investments each year and notes there has been no change in valuation methods used as of December 31, 2024 or 2023 compared to prior periods.

1. Participant directed brokerage accounts. Accounts primarily consist of mutual funds, as well as common and preferred stocks. All of the holdings in the self-directed brokerage accounts are publicly traded securities for which prices are publicly available.
2. Mutual funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
3. Collective trust funds. Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV as provided by the Trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.
4. Stable value funds. Valued at the NAV of the investments. NAV is used as a practical expedient to estimate fair value and represents contributions made to the Fund, plus earnings, less participant withdrawals, and administrative expenses and is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan.
5. Separate accounts. Valued at NAV calculated in a manner consistent with GAAP for investment companies. The NAV is the basis for current transactions and is calculated basis on security prices obtained from a pricing service less any redemption fees under the terms of the Plan.

For the investments valued at NAV, there were no notice period requirements (other than described above), restrictions on redemptions, or unfunded commitments as of December 31, 2024 and 2023.

## 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

## **6. FEDERAL INCOME TAX STATUS**

Principal has provided a letter to the Company from the IRS dated June 30, 2020 indicating that the amended Plan and related trust were designed in accordance with applicable regulations of the IRC. The Company and Plan management continues to believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

At December 31, 2024 and 2023, certain Plan investments were units or shares of collective trust funds and stable value funds managed by an affiliate of the Trustee, which qualify as party-in-interest transactions. Fees paid by the Plan for investment management services of these investments were included in administrative expenses on the Statement of Changes in Net Assets Available for Plan Benefits.

Also, the Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.
