Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

December 31, 2024

1. Description of Plan

The following description of The 401(k) Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan designed to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is intended to assist employees of Bayberry Financial Services Corporation; Liberty Lane Partners II, LLC; Elucid, LLC; and Great Hill Horticultural Education Foundation (collectively, the "Company") in a long-range program of savings to be used as a means of adding to their retirement income and to aid in meeting financial emergencies that may arise. The administration committee of The Plan and the plan administrator manage the operation and administration of the Plan. Bayberry Financial Services Corporation is the Plan sponsor.

Eligibility and Participation

The Plan primarily covers employees who are 18 years of age. Minimum service requirements apply to certain employee groups. Leased employees, collectively bargained employees, non-resident aliens and employees who are residents of Puerto Rico are excluded from participating in the Plan.

Contributions

The Plan provides for employees to contribute pretax and post-tax earnings up to 100 percent of eligible compensation, as defined in the Plan, subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the plan in the form of a rollover of funds from another qualified plan.

The Plan provides for a safe harbor match equal to 100 percent of the first 3 percent of compensation contributed and an additional 50 percent of the next 2 percent of compensation, for a maximum of 4 percent. Safe harbor matching contributions, net of forfeitures, made to the plan in 2024 totaled approximately \$214,361.

Participant Accounts

Each participant's account is credited with the participant's contributions and withdrawals, as applicable, and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined.

The 401(k) Retirement Plan

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Description of Plan (continued)

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their deferral and matching contributions, including the earnings on those amounts.

Notes Receivable from Participants

The Plan allows participants to borrow against their accounts. Such loans shall not exceed the lesser of \$50,000 or 50% of the participants' vested interest in their account. The Plan has established a minimum loan request of \$1,000 per loan. Loans can be for any purpose with a term not to exceed 5 years, unless it is for the purchase of a primary residence. The interest rates on outstanding loans at December 31, 2024 ranged from 3.25% to 8.50% with various maturities through June 2031. The interest rates on outstanding loans at December 31, 2023 ranged from 3.25% to 8.00% with various maturities through June 2031. Principal and interest are paid ratably through monthly payroll deductions.

Plan Administration

The Company is the Plan's Administrator and has the authority to appoint person(s) or entities to carry out the operations of the Plan. T. Rowe Price Retirement Plan Services serves as the recordkeeper for the Plan and T. Rowe Price Trust Company serves as the Plan's trustee. The Company pays certain expenses of the Plan, except for certain administrative costs of mutual funds and loan processing fees which are paid by the Plan. In addition, certain fees incurred by the Plan are covered through a revenue sharing agreement.

Benefits

Upon death, disability, or retirement on or after the age 65, participants are entitled to a distribution of the balance of their accounts. Participants may also be entitled to a hardship withdrawal as determined in accordance with the Plan's provisions. Participants may also withdraw any or part of their rollover contributions, at any time and at any age. In addition, participants who have attained the age of 59 ½ may elect to withdraw all or part of their vested account balance from the Plan without penalty. The Plan provides for the direct rollover to an individual retirement account for balances greater than \$1,000 and not more than \$5,000, unless directed otherwise by the participant. The Plan allows the Plan Administrator to automatically distribute to terminated participants their entire vested balance which does not exceed \$1,000 in the form of a single-sum payment.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their total balances.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, as described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, liquidity, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent Events

Events occurring after the statements of net assets available for plan benefits date are evaluated by the Plan to determine whether such events should be recognized or disclosed in the financial statements. The Plan Administrator has evaluated subsequent events through July 15, 2025 the date the financial statements were available to be issued.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

3. Information Certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by T. Rowe Price Trust Company, the trustee, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedule. The Plan Administrator has obtained certifications from T. Rowe Price Trust Company, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the information provided to the Plan Administrator by the trustee is complete and accurate. Such certified Plan information includes investments, notes receivable from participants, net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, investment transactions and note receivable transactions.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active exchange markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active exchange markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the quoted net asset value of shares held by the Plan at period end which are traded in an active market.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

4. Fair Value Measurements (Continued)

Collective Trust Fund: The collective trust fund is valued at net asset value per share (or its equivalent) of the funds, which is based on the fair value of the fund's underlying assets. The stable value investments have a limitation that delays redemption or withdrawal requests for either a 12- or 30-month period for the Plan in its entirety. The delay period may be shortened or waived by the trustee in its sole discretion. There is no such limitation on a participant-level basis. The stable value investments impose a 90-day equity wash provision on exchanges to competing funds. These investments are interest-rate sensitive; therefore, direct exchanges from the stable value investments to money market funds and certain short-term bond funds are not permitted. Permissible investment options include most common stock funds and any fixed income funds with a duration that is equal to or greater than three years. Exchanges from the stable value investments must remain invested in permissible investment options for at least 90 days before exchanging into a competing fund. There are no unfunded commitments or other redemption notice requirements for the collective trust fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. **Tax Status**

The underlying pre-approved defined contribution plan has received an opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. **Related-Party and Party-in-Interest Transactions**

Certain administrative expenses are included in net appreciation in fair value of investments on the state of changes in net assets available for benefits, as they are paid through revenue sharing, rather than direct payment. Certain plan assets are in investment funds managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, loans to participants qualify as party-in-interest transactions. Other direct administrative expenses paid to record keeper and the investment advisor were charged to the Plan as of December 31, 2024, totaling \$15,512.
