### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of Shelby Gravel, Inc. Employee 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Shelby Gravel, Inc. Employee 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document or Summary Plan Description agreement for a more complete description of the Plan's provisions, which are available from the Plan administrator.

**Participating Companies**

The following Companies (the "Companies" or "Employer"), which are related parties, are participating employers in the Plan:

- Shelby Gravel Inc. ("Plan Sponsor")
- Shelby Materials, LLC
- Shelby Transport, LLC
- Shelby Equipment Leasing, LLC
- Shelby Production, LLC

**Plan Amendments**

Effective January 1, 2023, the Plan was amended to allow eligible employees of Shelby Gravel, Inc. Columbus Union 401(k) to participate in the Shelby Gravel, Inc. Employee Retirement Plan.

**General**

The Plan is a defined contribution plan covering all employees of the Companies who have six months of employment and have completed 500 hours of service. An employee is eligible to enter the Plan semi-annually on the first day of the first month and of the seventh month of the Plan year immediately following completion of the eligibility requirements. Non-resident aliens, leased employees and independent contractors are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by the Shelby Materials 401(k) Investment Committee (the "Committee"), which is a committee appointed by the Trustees of the Companies. The Committee has overall fiduciary responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Companies' Trustees. The Committee has directed Empower Retirement, LLC ("Empower") as recordkeeper and administrative service provider to the Plan.

**Contributions**

Each year, participants may contribute up to 100% of annual eligible compensation as pre-tax, Roth, or after-tax contributions, as defined in the Plan. Participants may also contribute rollover amounts representing distributions from other qualified plans. Participants, age 50 or older, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Contributions (Continued)**

Each Plan year, the Companies contribute a nonelective safe harbor matching contribution up to 4% of eligible participant compensation. In addition, the Companies may make discretionary additional matching contributions or nonelective contributions to the Plan at the option of the Company's Board of Directors. For the year ended December 31, 2024, the discretionary additional matching percentage was 0.35% for every 1% the employee defers up to 6% of eligible compensation. The combined maximum employer match offered is 6.1% if all above conditions are met. For the Plan year ended December 31, 2024, the Companies did not make a nonelective contribution.

**Participant Investment Account Options**

The Plan currently offers various mutual funds, fixed annuities and similar funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contributions, (b) plan earnings and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions and nonelective safe harbor matching contributions and actual earnings thereon. Vesting of employer's discretionary additional matching contributions and nonelective contributions plus earnings thereon is based on years of service. The vesting schedule is as follows:

<u>Years of Service</u>	<u>Vested %</u>
Less than 1 year	0%
At least 1 year, but less than 2	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 4 years, but less than 6	80%
6 years or more	100%

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$8,000 or 50% of their vested account balance. All loans are to be repaid over a period not to exceed five years, unless the loan proceeds are used to purchase a participant's principal residence. The loans are collateralized by the participant's vested account and bear interest at 2.00% above the USA Today Prime Rate at the time of issuance. Principal and interest are paid ratably through weekly payroll deductions. The Plan will treat a loan in default if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. If not repaid, the Plan will offset the participant's vested account balance by the outstanding loan balance. A participant may have no more than one loan outstanding at any time.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, partial payment, or installment payment only if the participant is subject to lifetime RMDs. Account balances that do not exceed \$5,000 on the participant's date of termination may result in an involuntary distribution to an IRA or in the form of a lump sum payment. In addition, the Plan allows in-service distributions for hardship reasons and in-service distributions if the participant is 59 1/2 or older and if the participant meets service and participation requirements as defined in the Plan.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$36,040 and \$45,763, respectively. Forfeitures shall be used as elected by the Employer to pay Plan expenses, reduce any Employer contributions, or act as additional Employer contributions. At December 31, 2024, approximately \$34,500 of forfeited nonvested accounts were used to pay administrative expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determine the Plan's valuation policies utilizing information provided by the recordkeeper. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions**

Contributions from Plan participants and the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of the Plan are paid by the Employer and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE RECORDKEEPER**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, "Empower") have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASU") Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in inactive markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

**NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed annuities:* The value is based on the fair value of the underlying investments held by the fund. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the fixed annuity, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly manner.

**NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments managed by Empower. Empower is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the recordkeeper by the Plan for the year ended December 31, 2024, total approximately \$44,500.

Morgan Stanley Smith Barney LLC is the investment advisor of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the investment advisor by the Plan for the year ended December 31, 2024, totaled approximately \$75,000.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

**NOTE 7- TAX STATUS**

The Employer has adopted a pre-approved Plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although, the Plan has been amended since adopting the pre-approved Plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS, UNCERTAINTIES, AND CONCENTRATIONS**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 37% and 35% of the Plan's investments were invested in three target date investments, respectively.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
