## Independent Auditors' Report

To the Participants and Trustees of  
Ernst Enterprises Retirement Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Ernst Enterprises Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ernst Enterprises Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Ernst Enterprises Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing retirement plan sponsored by Ernst Enterprises, Inc. (the Company and Plan Sponsor) and covers substantially all eligible employees of the Plan Sponsor and affiliated companies. The Plan is subject to the provisions ERISA.

Eligibility

Those employees who have completed 30 days of service, and are at least 21 years of age are eligible to become participants in the Plan.

Those employees who have completed 1,000 hours of service, and are at least 21 years of age are eligible to receive Profit Sharing contributions from the Plan.

Those employees who have completed 30 days of service, and are at least 21 years of age are eligible to participate in the 401(k) elective deferrals as of the first day of the calendar month which coincides with or next follows the date eligibility requirements are satisfied.

Contributions

- (a) *Participant's voluntary salary reductions.* Participants may elect to contribute up to 100% of their compensation, as defined in the Plan. Each participant's contribution may not exceed the federal maximum amount pursuant to limits of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, the Plan provides for catch-up contributions for participants age 50 or older. The Plan contains an automatic deferral feature (3% default rate) with an opt-out provision. The automatic deferral will increase by 1% annually up to a maximum of 10%.
- (b) *Employer discretionary matching contribution.* The matching contribution, if any, will be equal to a percentage of the amount of salary deferrals elected, which will be determined each year by the Plan Sponsor. The employer match for 2024 was 100% of participant deferrals, up to a maximum match of 6% of participant wages. Total matching contributions were \$3,976,466 for the year ended December 31, 2024.

Contributions (Continued)

- (c) *A discretionary profit sharing contribution.* The Plan Sponsor may make annual discretionary contributions to the Plan in an amount determined by the Board of Directors of the Plan Sponsor. Profit sharing contributions are allocated among eligible participants of the Plan based on each participant's points compared to that of all participants. Each participant will receive twenty-five points for each Plan Year of service and two points for each \$200 of compensation earned for such Plan Year. The discretionary profit sharing contribution for the year ended December 31, 2024, was \$11,093,938, which was fully funded by the employer subsequent to year-end.
- (d) *A non-elective contribution.* The Plan Sponsor may elect to make a non-elective contribution. Non-elective contributions are allocated to each qualified participant who is not a highly compensated employee in the proportion that each employee's compensation bears to all such qualified participants' compensation. There were no non-elective contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's own contributions, employer contributions, rollover contributions, and a share of the Plan's investment income and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all funds in their accounts.

Investment Options

Upon enrollment in the Plan, a participant may direct employee deferrals, employer contributions, and direct rollovers in any of several different mutual fund investment options or to the common collective trust.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of the participant's non-forfeitable account balance as of the date of the loan. Loan terms range from one to ten years. The loans are collateralized by the balance in the participant's account and bear interest at the prime rate plus one percent at the time the loan is issued. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are 100% vested in employee and rollover contributions and employer non-elective contributions. In addition, a participant will become fully vested upon attainment of normal retirement age or upon death or disability while an employee of the Plan Sponsor. All other employer contributions vest according to the following schedule:

5 or more	100%

Forfeited Accounts

Forfeitures of non-vested contributions will be used to restore any forfeitures for vested balances on rehired participants meeting the break-in-service rules. The remaining forfeitures will be used to offset the Plan Sponsor's contributions and pay administrative expenses. For the years ended December 31, 2024 and 2023, forfeitures of non-vested accounts were \$519,876 and \$370,552, respectively. Forfeitures of \$334,095 were used to fund employer matching contributions for the year ended December 31, 2024. At December 31, 2024, unallocated forfeitures totaled \$602,997.

Payment of Benefits

Benefits are recorded when paid. Rollovers are not included when determining whether a cash-out distribution may be paid to a terminated participant. Upon termination of service, a participant may elect to receive a lump sum distribution equal to the value of their account.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances. No allowance for credit losses has been recorded at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan a distribution, the note balance is reduced and a withdrawal is recorded.

Administrative Fees

Administrative fees are paid for by both the Plan and the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

**NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America, N.A., the Trustee of the Plan.

**NOTE D - FAIR VALUE MEASUREMENTS**

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below.

*Level 1* - Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the closing price of the shares held by the Plan at year-end reported on the active market on which the individual securities are traded.

*Common Collective Trust Funds:* Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. As of December 31, 2024, the Plan's collective investment trusts have no unfunded purchase commitments and immediate redemption frequency.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fees paid by the Plan to the trustee, Bank of America, N.A., qualify as party-in-interest transactions.

**NOTE F - INCOME TAX STATUS**

The Plan obtained its latest favorable tax determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended and restated since receiving the determination letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE I - SUBSEQUENT EVENTS**

Subsequent events were evaluated through August 28, 2025, which is the date the financial statements were available to be issued.
