We have performed audits of the financial statements of the Non-Union Employees 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. ### 1. Description of Plan

The following description of the Non-Union Employees 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all non-union employees of Megalodon Midco, LLC d/b/a Shiloh Industries, Inc. (the Company) and its domestic subsidiaries. The Plan was effective November 1, 1988. The Plan was amended and restated effective July 15, 2022. The administrator of the Plan is the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company has given Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the Trustee) the authority to hold the assets of the Plan and to invest, control, and disburse all assets of the Plan in accordance with the service provider contract. The Retirement Plan Investment & Employee Benefits Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance in addition to monitoring the Plan's operations.

On August 3, 2023, the Company's battery enclosure facility in Muscle Shoals, Alabama was sold to the Linamar Corporation. There was no transitional agreement and employees were immediately terminated as of August 3, 2023.

#### *Eligibility*

Employees may become participants and are eligible for matching contributions in the Plan after attaining the age of 18 and as of the first of the month following their hire date, except (1) employees covered by a collective bargaining agreement; (2) nonresident aliens; (3) leased employees; and (4) employees who are residents of Puerto Rico. Eligible employees are automatically enrolled in the Plan after 30 days of hire if they have not made an affirmative election.

#### *Contributions*

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan agreement. Unless a different percentage is selected, new participants are automatically enrolled to defer 4% of compensation, and the automatic elective deferral contribution shall be automatically increased each January 1 by 1%, up to a maximum automatic elective deferral contribution of 10%. Additionally, participants with deferral elections less than 4% will be automatically increased to 4% each January 1.

Participants may also contribute amounts representing distributions from other qualified plans. Eligible participants may make additional catch-up contributions to the Plan. The Plan also allows for Roth elective deferral contributions.

The Company shall make matching contributions in an amount equal to 100% of elective deferral contributions up to 3% of compensation, plus 50% of elective deferral contributions in excess of 3% of compensation, but do not exceed 5% of compensation. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. No such contribution was made for the year ended December 31, 2024. Contributions are subject to certain limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, and Plan earnings (net of administrative expenses) and charged with the participant's withdrawals and an allocation of net Plan losses. Allocations are based on participant contributions, earnings, or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in all Company contributions.

### ***Investment Options***

Participants direct the investment of contributions into their accounts into the various investment options offered under the Plan.

### ***Payment of Benefits***

On termination of service, participants are entitled to receive the value of the entire interest in their accounts. On termination of service due to death, disability, or retirement, participants may elect to receive a lump-sum amount, annual installments, or various annuity options. For terminations of service due to other reasons, participants will receive their benefit as a lump-sum distribution. Participants may also receive a distribution for reasons of proven financial hardship, up to the amount the employee has deferred (including earnings thereon) under the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participants may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account. The interest rate for the loan is computed at the prime rate, as published in *The Wall Street Journal*, as of the date the loan is made, plus 1%. The notes are paid ratably or less, unless used to purchase a principal residence, whereby the repayment period will not be longer than the repayment period currently in effect for a commercial home loan. These loans are subject to certain restrictions, as defined by the Plan agreement, and applicable restrictions under the Internal Revenue Code (IRC). Principal and interest are paid through payroll deductions over a period of five years.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Investment & Employee Benefits Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the period.

### *Notes Receivable from Participants*

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

### *Benefit Payments*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are included in net appreciation (depreciation) in fair value of investments.

## **3. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit risks, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 5. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, a qualified institution.

### 6. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts (PSAs)* - PSAs are valued at the NAV of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of common stock, mutual funds, or short-term securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Principal Life Insurance Company, is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments.

*Collective Investment Trusts (CITs)* - Units held in CITs are valued at the NAV, as reported by the Trustee. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. The CITs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to these investments. The CITs file as a Direct Filing Entity (DFE).

*Stable Value Fund (SVF)* - The Principal Stable Value Z Fund is a common/collective trust composed primarily of fully benefit-responsive investment contracts. The SVF is valued at the NAV, which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily with no advance notice and no restrictions. Redemptions will be made 30 days after written notice is received by the SVF. All plan-sponsored direct requests for full or partial withdrawals may be subject to the 12-month advance written notice requirement. There are no unfunded commitments related to these investments. The SVF files as a DFE.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 7. Related Party and Party-in-Interest Transactions

Certain PSAs are managed by Principal Life Insurance Company, an affiliate of the Trustee, and certain CITs are managed by Principal Global Investors Trust Company, an affiliate of the Trustee. Participant loan and distribution processing fees are paid to the Plan by participants. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. Fees for the administration of the Plan are paid to the Trustee by the Plan and Company. Investment management fees are paid for by the Plan to investment managers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

## 8. Tax Status

The Plan uses a pre-approved plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved plan agreement adopted by the Plan, as then designed, satisfies the applicable sections of the IRC and is exempt from federal income tax. Although the Plan has been amended since receiving the opinion, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

### **9. Subsequent Events**

Effective January 1, 2025, the Plan implemented a “super catchup” for participants that are aged 60-63. This allows these participants to contribute the greater of \$10,000 or 150% of their regular catch-up amount. Also, participants will now be able to “self-certify” hardship withdrawals and the new 401(k) contribution limit increased by \$500 to \$23,500.

The financial statements and related disclosures include an evaluation of events up to and including September 8, 2025, the date the financial statements were available to be issued.
