### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Benchmark, Inc. Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Description of the Plan**

The following brief description of the Benchmark, Inc. Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions.

The Plan is a defined contribution 401(k) plan covering any employee of Benchmark, Inc. (the Company or Plan Sponsor) who is at least 18 years of age and has completed at least one month of service. Employees become participants the beginning of the first pay period immediately following meeting the eligibility requirements. The Plan allows participants to designate all or a portion of their elective deferrals as Roth deferrals, which are accounted for separately in the participant's account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan is funded by participant contributions and Company matching contributions, both of which are limited to the maximum amount deductible under the Internal Revenue Code. Participants can contribute up to 100% of eligible compensation to the Plan and may also rollover or transfer amounts representing distributions from other qualified retirement plans. Participants are eligible for employer matching contributions if they are actively deferring into the Plan.

During the years ended December 31, 2024 and 2023, Company matching contributions were fixed at 50% of up to 6% of each participant's elected salary deferrals (maximum total match of 3%). Effective January 1, 2025, Company matching contributions are discretionary; the Board of Directors has set such for 2025 at 50% of up to 7% of each participant's elected salary deferrals (maximum total match of 3.5%).

The Plan includes an automatic deferral provision whereby eligible employees are enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their pre-tax deferral rate set at 6% (7% effective January 1, 2025) of eligible compensation, with annual increases of 1% each August 1<sup>st</sup> until the automatic deferral reaches 20% or the participant elects to change their percentage. Automatic contributions are invested in a target date fund based on the participant's age until changes are made by the participant.

Participant accounts

Each participant's account is credited with the participant's contributions, an allocation of employer matching contributions, Plan earnings, and charged with an allocation of any administrative expenses. Allocations are based on participants' compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, including rollovers, and actual earnings thereon. Vesting in Company matching contributions and actual earnings thereon is based on years of continuous service, with 100% vesting after three years, or upon the participant's death, disability, or attaining normal or early retirement age, as defined in the Plan Agreement.

Investment options

Upon enrollment in the Plan, participants direct their contributions into various investment options offered by the Plan. Participants may change their investment options at their discretion; changes become effective on the next business day. Additional investment options are periodically added to the Plan to provide more diversification for participants.

## **Note 1. Description of the Plan, Continued**

### Forfeited accounts

During 2024 and 2023, forfeited nonvested accounts totaled \$3,326 and \$5,537, respectively. Forfeitures, to the extent available, are used to reduce Company matching contributions and then to pay administrative expenses of the Plan. The Company used forfeitures of \$3,326 and \$5,410 to reduce Company matching contributions in 2024 and 2023, respectively; no forfeitures were used to pay administrative expenses in 2024 or 2023. As of December 31, 2024 and 2023, there were no unallocated forfeitures available for future use.

### Payment of benefits

Upon retirement, death, disability, or termination of service, participants receive an amount equal to the value of their vested benefit. The Plan provides for lump-sum distributions or installment payments in the case of lifetime required minimum distributions. Effective January 1, 2024, if no benefit payment election form is completed, participants receive automatic lump-sum distributions for accounts with a value of \$1,000 or less and participant accounts with balances between \$1,000 and \$7,000 are automatically rolled into an individual retirement account. Distributions of balances greater than \$7,000 are made at the election of the participants.

### Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

## **Note 2. Summary of Significant Accounting Policies**

### Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures in the financial statements. Actual results may differ from those estimates.

### Concentrations of investment risk

Approximately 74% and 75% of the Plan's investments were held in Principal sponsored or affiliated investments as of December 31, 2024 and 2023, respectively. In addition, approximately 11% and 12% of the Plan's investments were held by one mutual fund family as of December 31, 2024 and 2023, respectively. Such concentrations represent holdings in excess of 10% of the Plan's total investments.

### Investment valuation and income recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by its investment advisors, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis, interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Payment of benefits

Benefits are recorded when paid.

**Note 2. Summary of Significant Accounting Policies, Continued**

Income tax status

The Plan is a non-standardized prototype plan. The Internal Revenue Service (IRS) has determined and informed the custodian by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC; the Plan administrator therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events

Plan management has evaluated subsequent events through August 5, 2025, the date the financial statements were available to be issued.

**Note 3. Information Prepared and Certified by Principal Life Insurance Company or Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), Parties-in-interest**

All investment assets of the Plan were held by Principal, a party-in-interest discussed at Note 8, as of December 31, 2024 and 2023. All investment transactions during 2024 and 2023 were executed under formal custody agreements between the Plan and Principal. All securities bought, sold, or exchanged were executed under these agreements. Such financial information has not been audited by independent auditors.

In accordance with the provisions of Section 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, Principal has certified the following unaudited financial information to be complete and accurate with respect to the Plan's assets held by them as of December 31, 2024 and 2023, and investment activity for the years then ended:

#### **Note 4. Risks and Uncertainties**

The Plan provides for investments in various securities, which generally are exposed to risks such as interest rate, credit, and overall market risks. Amid persistent inflation, tariff and trade policy uncertainty, geopolitical tensions, reduced consumer demand, and labor market shifts, current economic uncertainty is leading to substantial variability in market forecasts contributing to market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **Note 5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Guaranteed interest accounts: Valued based on contract value adjusted to reflect current market interest rates to the extent such market interest rates exceed contract crediting rates.

Pooled separate investment accounts: Valued at the net asset value (NAV) of shares held by the Plan in the pooled separate account at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments. Investments in the pooled separate accounts can be redeemed immediately at the current NAV per share. There are no unfunded commitments or significant restrictions on redemptions.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5. Fair Value  
Measurements, Continued**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 6. Guaranteed Interest Accounts**

The Plan has an insurance contract with Principal Life Insurance Company (Principal Life). Principal Life maintains the Plan's contributions in an unallocated fund and provides a guaranteed interest rate for a three-year period. The account is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses, including surrender charges for participant withdrawals prior to maturity. Principal Life is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. Account balances are subject to early withdrawal charges if the contract is terminated or transferred by the Company.

### **Note 7. Administrative Expenses**

Administrative expenses paid by the Plan totaled \$60,121 and \$14,848 for 2024 and 2023, respectively, of which \$4,432 and \$1,860 for certain participant directed transactions were charged to the respective participant's account balance in 2024 and 2023, respectively. The Plan Sponsor pays other administrative expenses of the Plan, including audit fees.

Effective October 1, 2023, an asset-based fee of 0.27% was instituted by Principal for investment advisory and other administrative services in conjunction with lower expense ratios at the investment level.

### **Note 8. Related Party and Party-in-interest Transactions**

The Plan Sponsor has an agreement with Principal Life Insurance Company to provide recordkeeping, administrative, custodial, and transaction processing services for the Plan's investments. Additionally, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company provides custodial services to the Plan. Other related party and party-in-interest transactions are described in Notes 3, 6, and 7.
