Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of HRL Retirement Savings Plan for Non-Bargained Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF THE PLAN

The HRL Retirement Savings Plan for Non-Bargained Employees (the “Plan”) is a defined contribution plan that covers all eligible non-bargained employees, as defined in the Plan, of HRL Laboratories, LLC (the “Company”). The Plan was established on January 1, 2003 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Investment fund options are participant-directed.

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. Eligibility

All non-bargained employees are eligible to participate in the Plan. Participants may enter the Plan on any business day.

To be eligible for employer non-elective contributions, a participant must either have been a participant in the HRL Pension Plan for Non-Bargained Employees with a frozen benefit as of December 31, 2009 or be an employee hired on or after January 1, 2010 who would have been a participant in the HRL Pension Plan for Non-Bargained Employees but for the freeze.

B. Contributions

The Plan permits each participant to defer up to 20% of his or her compensation, as defined in the Plan, as a pre-tax, after-tax or Roth contribution, up to the statutory maximum as determined by the Internal Revenue Code (the “Code”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching is equal to 100% of each participant’s contributions of up to 4% of eligible compensation deferred to the Plan.

In addition to matching contributions, the Company makes non-elective contributions to the Plan equal to a percentage of eligible participants’ compensation based upon date of hire and age as of the first day of the Plan year. Contributions are subject to regulatory limitations.

C. Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Vesting

A participant is fully vested immediately as to voluntary salary deferrals, rollover contributions, and related earnings. Company matching and non-elective contributions will not be vested until the end of the participant’s third year of service, when they become 100% vested.

E. Notes Receivable from Participants

A participant may borrow up to the lesser of 50% of his or her vested account balance or \$50,000. The loans are issued by the Plan and secured by the balance in the participant's account. The repayment period for loans cannot exceed five years unless the proceeds are used to purchase the participant's principal residence in which case longer terms are allowed, up to 10 years. Loans bear interest at a rate determined by the plan administrator based upon the prime rate of interest on the last business day of each calendar quarter, plus one percent. Principal and interest payments are made through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans were 4.25% to 9.50%; loans mature through December 2028.

F. Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in his or her account, or elect to receive quarterly or annual installments over a period not to exceed the life expectancy of the participant and his or her designated beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

G. Administrative Expenses

In 2024, administrative expenses paid by the Plan comprised the following:

H. Forfeitures

Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and may be used to pay Plan administrative expenses and to reduce future Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,410 and \$32,567, respectively. During the year forfeiture contributions totaled \$372,445. The Company used \$352,954 and \$40,086 to offset match and administrative expenses, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

B. Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

D. Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Plan investments consist of mutual funds which are valued at closing market prices. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

NOTE 3 - TAX STATUS

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated November 6, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan.

NOTE 6 - PARTY IN INTEREST TRANSACTIONS

Vanguard Fiduciary Trust Company, the trustee of the Plan, and its related entities issue investments held by the Plan. Transactions in these investments, while considered party in interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination all participants would become 100% vested, and net assets would be distributed based upon the participants' account balances at that time.

NOTE 8 - COMMON/COLLECTIVE TRUST

The Retirement Savings Trust III is a common/collective trust that invests solely in Vanguard Retirement Savings Master Trust, which in turn invests in a pool of investment contracts issued by insurance companies and commercial banks and in contracts backed by bond funds. Because the fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion

of the net assets available for benefits attributable to the fund. The fund is presented in the statements of net assets available for benefits at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals and administrative expenses. The Plan is credited earnings on underlying investments and charged for participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment in the fund at contract value.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 4, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
