#### Significant risks identified

The following is a summary of significant risks identified during the course of our audit and procedures performed to address those risks.

- 1) Management override of internal controls. To address the risk of management override of controls we:
  - Designed procedures to incorporate an element of unpredictability in our audit.
  - Obtained an understanding of the process and related controls over journal entries and other adjustments.
  - Reviewed the selection and application of significant accounting principles.
  - Examined significant and unusual journal entries.
  - Reviewed accounting estimates for bias.

- Evaluated business rational for unusual transactions.
  - Inquired of known or alleged fraud and noncompliance.
- 2) Misappropriation of cash. To address the risk of misappropriation of cash, we:
- Agreed total contributions received by the Trust to payroll summary reports for the year from the payroll provider.
  - Tested a selection of contributions for participants and traced from payroll records into the deposits for the Plan.
  - Vouched distributions to canceled checks or other documentation for selected transactions.

#### Planned scope and timing of the audit

We conducted our audit consistent with the planned scope and timing we previously communicated to you in our engagement letter and during the course of the audit.

#### Qualitative aspects of accounting practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during during the year. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. We did not note any such sensitive accounting estimates during the course of our audit.

The financial statement disclosures are neutral, consistent, and clear.

#### Significant unusual transactions

Professional standards require us to communicate to you significant unusual transactions identified during our audit. We did not identify any significant unusual transactions during the course of our audit.

#### Difficulties encountered in performing the audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and uncorrected misstatements

Professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. There were no uncorrected misstatements noted during the course of our audit.

In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Internal control deficiencies and reportable findings

In planning and performing our audit of the financial statements of the Plan as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Company's internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Company's internal control. Accordingly, we do not express an opinion on the effectiveness of the Company's internal control.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected, on a timely basis.

A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- Reasonably possible. The chance of the future event or events occurring is more than remote but less than likely.
- Probable. The future event or events are likely to occur.

Our consideration of internal control was for the limited purpose described in the first paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Company's internal control to be significant deficiencies:

*Finding 1:*

During our audit, we noted several instances where participants with cell phone allowances did not have the allowances deducted from their eligible compensation for deferrals.

*Recommendation 1:*

We recommend that the Company implement procedures to ensure that eligible compensation is correctly calculated each pay period in payroll. Any necessary corrections should be made as soon as possible.

*Finding 2:*

During our audit, we noted a participant did not have their perfect attendance bonus excluded from eligible compensation for deferrals.

*Recommendation 2:*

We recommend that the Company implement procedures to ensure that eligible compensation is correctly calculated each pay period in payroll. Any necessary corrections should be made as soon as possible.

Disagreements with management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.
