Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Schimberg Co. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Schimberg Co. Note 1 - Plan Description

The following is a brief description of the Schimberg Co. Profit Sharing Plan (the “Plan”) and provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all full-time employees of Schimberg Co. (“the Company”) who are age 21 or older and have completed two years of service. Union employees are not eligible to participate. Employees that meet the requirements are eligible to participate in the Plan on the next available entry date of January 1 or July 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company and Plan share the costs of the plan administration, including the audit and fiduciary fees.

Contributions - Each year participants receive an annual profit-sharing contribution in an amount not to exceed a specific dollar amount determined by the Internal Revenue Service. The contribution is based on eligible compensation. Participants must be employed on the last day of the plan year to receive the profit-sharing contribution. The Plan does not accept rollover contributions.

Participant Accounts - Each participant’s account is credited with an allocation of (a) the Company’s contribution, (b) plan earnings, and (c) netted with any expenses incurred by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant Loans - Participant loans are not allowed in the Plan.

Vesting - A participant is fully vested upon entering the Plan after two years of service to the Company.

Payment of Benefits - A participant or their beneficiaries may elect to receive all or a portion of their vested interest attributable to contributions made by the employer upon termination of employment, retirement, disability, or death. Benefits may also be withdrawn if (a) the Plan is terminated and no successor plan is established within one year, or (b) the employer is a Corporation, in the case of certain corporate restructuring. Participants with an account balance of less than \$5,000 will receive a distribution of the vested balance, regardless of consent, as soon as administratively feasible following termination of employment.

Funding Policy - The amount of the Company’s contribution to the Plan is discretionary and is determined annually by the Board of Directors but cannot exceed the amount deductible by the Company for federal income tax purposes.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value as determined by quoted market prices, except for fully benefit-responsive investment contracts (Transamerica Guaranteed Investment Option). Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value approximates fair value for the fully-benefit responsive investment contracts held by the Plan.

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net unrealized losses on investments include the Plan's gains and losses on investments held during the year.

Payment of Benefits - Benefits are recorded when paid or accrued when requested but not actually paid in the same period in which the request was made.

Administrative Expenses - The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Plan Sponsor contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants. Although it is under no obligation to do so, the Plan Sponsor has also historically paid for the annual financial statement audit of the Plan. Administrative expenses incurred and paid by the Plan include investment management fees and third-party administrator fees which are netted against investment returns.

Subsequent Events - In preparing the accompanying financial statements, management evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued, for material subsequent events requiring recognition or disclosure.

Note 3 - Fair Value Measurement

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Note 3 - Fair Value Measurement (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value per share (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the net realizable value of assets at the date of termination shall be distributed proportionately to the participants' accounts and each participant shall then be entitled to receive the full value of their account.

Note 5 - Tax Status

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however there are currently no audits for any tax periods in progress.

Note 6 - Information Prepared and Certified by Trustees

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest, and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (mutual funds) and Transamerica Life Insurance Company (Stable Value Advantage Option), the trustees of the Plan.

Note 7 - Investment Contract with Insurance Company

Transamerica maintains the contributions in a general account. The account is credited with interest and charged for participant withdrawals and administrative expenses. The fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the fund is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fund. The fund is presented on the face of the statement of net assets available for benefits at contract value which approximates fair value. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable – for example, a significant decline in creditworthiness of Transamerica, the Guaranteed Investment Option investment choice may no longer be considered fully benefit responsive.

The terms of Transamerica's Group Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Permitted participant-initiated transactions are those allowed by the underlying defined contribution plan such as withdrawals for benefits or transfers to other investment choices within the Plan.

Note 7 - Investment Contract with Insurance Company (Continued)

Since the Guaranteed Investment Option investment choice is an obligation of Transamerica, the occurrence of an event that limits the ability of the investment to transact at contract value between Transamerica and a participant holding the investment is not probable.

The Guaranteed Investment Option investment choice allows a participant reasonable access to their assets.

Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period and, as such, average yield equals credited rate. The average interest rate yield by the Plan and interest rate credited to the Plan during the period ended December 31, 2024 and 2023 was 3.1% and 1.35%, respectively. There is no stated minimum or maximum interest rate for the Guaranteed Investment Option investment choices.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 - Party-in-Interest Transactions

ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain administrative functions are performed by officers or employees of the Company who are also participants in the Plan. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees and investment advisory fees are paid directly by the Plan. Administrative expenses for the Plan's audit are paid directly by the Plan Sponsor.

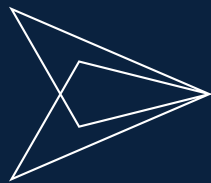
