The Plan was originally established on March 31, 1992. The Plan was subsequently amended for the adoption of a prototype plan and trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was amended and restated as of January 1, 2022 to update certain Plan definitions. Subsequent to year-end the Plan was amended to change the Trustee of the Plan.

##### ***Eligibility:***

All employees of Intigral, Inc. (“Company” or “Plan Sponsor”) age eighteen and older and who are employed for six months are eligible to participate in the Plan. Leased employees are excluded from the Plan.

##### ***Contributions:***

Eligible employees may contribute from 1 to 100 percent of compensation through payroll deductions on a pretax basis, not to exceed Internal Revenue Service limitations. In addition, eligible employees may also make Roth contributions. Newly eligible employees who do not make an active election to participate in the Plan are automatically enrolled in the Plan with a contribution amount of 3% of their annual compensation. Catch up contributions are allowed under the Plan.

The Company contributes safe-harbor contributions to each eligible participant’s account by matching 100% of the first 1%, and 50% that exceeds 1%, but does not exceed 6% of their total compensation. The Company may elect to make additional non-elective discretionary contributions for eligible participants.

The Plan also provides for the investment of qualified rollover contributions.

##### ***Participants’ Accounts:***

Each participant’s account is credited with the participant’s elective contributions, employer discretionary matching contributions, earnings and losses thereon.

##### ***Vesting:***

All participants are 100% vested in elective deferrals and rollover contributions made to the Plan.

Vesting in safe harbor contributions of the Plan shall be 0% until the employee has completed two years of vesting service, at which time they will become 100% vested.

***Vesting, Continued:***

Vesting in the employer non-elective and discretionary matching contributions is based on years of service. A participant is vested as follows:

***Forfeitures:***

As of December 31, forfeited non-vested accounts totaled \$36,690 (2024) and \$56,279 (2023). Future employer contributions will be reduced by these amounts.

***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed five years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at rates established by the Company. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits:***

Normal retirement age is 65. There is no early benefit distribution feature. Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account.

***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

***Investment Options:***

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

## 2 Summary of Significant Accounting Policies

### *Basis of Accounting:*

The Plan's transactions are reported on the accrual basis of accounting.

### *Valuation of Investments:*

Investments are stated at fair value. Marketable securities (pooled separate accounts) are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. Participants can transact with the pooled separate accounts daily and there are no unfunded commitments. The fair value of the guaranteed investment contract (VOYA Fixed Account) is based on the fair value of the underlying assets of the contract (contract value of the fund approximates fair value).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold and held during the year.

### *Use of Estimates:*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

### *Administrative Fees:*

Substantially all administrative fees are paid by Intigral, Inc., if not paid by the Plan.

### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### *Risks and Uncertainties:*

The Plan's investments include investments in pooled separate accounts and a guaranteed investment contract with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

#### **2 Summary of Significant Accounting Policies, Continued**

##### *Contributions:*

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued.

#### **3 Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### **4 Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets.
- \* Quoted prices for identical or similar assets or liabilities in inactive markets.
- \* Inputs other than quoted prices that are observable for the asset or liability.
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Pooled Separate Accounts:***

The fair value of the pooled separate accounts is based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. These fall into the Level 2 category of the valuation hierarchy. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments of the plan for these funds. The pooled separate accounts invest in various investment strategies as defined by the underlying mutual funds of the investments.

***Guaranteed Interest Contract (VOYA Fixed Account):***

The fair value of the guaranteed interest account is based on the underlying assets of the contract (contract value of the fund approximates fair value). The fair value is expressed in units. The guaranteed interest account is not fully benefit responsive and is classified in the Level 3 category of the valuation hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. In 2024, the Company corrected the late remittances in accordance with the appropriate correction guidelines.
