### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Coeur Mining Defined Contribution and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### 1. Plan Description

The following summary of the Coeur Mining Defined Contribution and 401(k) Plan (the Plan) is provided for general information purposes only. For a complete description of the Plan and its specific provisions, a copy of the Plan documents should be obtained directly from the Company.

#### *General*

The Plan was adopted by Coeur Mining Inc., its subsidiaries and affiliates (collectively referred to as the Company) effective January 1, 1984 and has been subsequently amended and restated effective January 1, 2021. The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee, Custodian and Administration of the Plan*

The custodian, recordkeeper and trustee of the Plan is Vanguard Fiduciary Trust Company (Vanguard). The administrator of the Plan is the Company. The custodian holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

There is no age or service requirement to participate in the Plan. Employees of the Company are eligible to participate in the Plan regardless of age or service, except for temporary and leased employees. Employees are eligible for the employer matching contribution upon participation in the Plan.

#### *Contributions*

Participants may elect to contribute to the Plan on a pre-tax or Roth basis through payroll deductions subject to certain limitations of the Internal Revenue Code (the IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as specified by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation.

The Company contributes a safe harbor matching contribution equal to 100% of the first 6% of a participant's eligible compensation contributed as defined by the Plan Document. For the year ended December 31, 2024, the Company made safe harbor matching contributions of \$7,756,659.

In addition to the safe harbor matching contribution, management may, at their discretion, contribute a profit-sharing contribution to employees based on eligible compensation. For the year ended December 31, 2024, the Company made no discretionary profit-sharing contributions.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses and employer profit-sharing contribution. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are fully vested in their contributions, the Company safe harbor matching contributions, and earnings thereon at all times. Vesting in the Company profit sharing contribution is based on years of continuous service. The Plan vesting schedule starts with an increase of 25% each year, until their fourth year of employment at which time they become 100% vested. Participants become fully vested in the event of death or disability as defined by the plan.

### ***Payment of Benefits***

When a participant terminates employment with a vested balance less than \$1,000, a lump sum distribution to the participants will be made as soon as administratively practicable. Participants are given the option to receive the lump sum distribution or roll over the distribution into another retirement plan at the time of termination. Account balances greater than \$1,000 are paid in a lump sum or in equal installments, any time after the termination date at the individual's request. The lump sum payments can be cash or a direct rollover to another qualified plan or individual retirement account at the election of the participant. In addition, hardship distributions are permitted if certain criteria are met.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate at the prime rate plus 1% or at local prevailing rates as determined by the Plan Administrator, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence up to ten years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC. Each participant may not have more than one loan outstanding at any time.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$162,783 and \$98,250, respectively. Forfeitures may be used to pay administrative expenses and reduce future employer contributions. During the year ended December 31, 2024, \$2,650 of forfeitures were used to pay administrative expenses and \$18,682 to reduce employer contributions.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of the financial statements in conformity with the accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could materially differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Participant contributions and any related employer safe harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

#### *Notes Receivable from Participants*

Notes receivable from participants are valued at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments beyond the applicable cure period and the loan is deemed a distribution, based on the terms of the loan document, the participant's loan balance is reduced, and a benefit payment is recorded in the financial statements in the year the determination is made.

#### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Other administrative expenses are recordkeeping fees, managed account fees, legal fees, investment advisor fees and audit fees. Investment related expenses are included in net appreciation of fair value of investments.

### **3. Information Certified by Vanguard**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023, except for \$1,297,236 and \$1,552,636, respectively, in self-directed brokerage accounts.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024, except for net depreciation of \$276,576 related to self-directed brokerage accounts.
- Investment information included in the Schedule H, Line 4i -Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Funds:* Valued at the daily closing price as reported by the fund.

*Mutual Funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily without advance notice. There were no unfunded commitments or trading restrictions as of December 31, 2024 and 2023. Further, this fund is a direct filing entity.

*Self-Directed Brokerage Accounts:* These accounts are comprised of common stock, mutual funds, exchange traded funds, cash and cash equivalents. The investments are valued at the published market price on an active market.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Related Parties and Parties in Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Vanguard. Participant loan and distribution processing fees are paid to Vanguard by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit-sharing contributions.

### 7. Tax Status

The Plan uses a pre-approved non standardized profit-sharing plan document from Vanguard, which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, and which states that the volume submitter plan, as then designed, satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market fluctuation and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect the amounts reported in the financial statements and participant account balances.

### 9. Subsequent Events

The Plan has evaluated subsequent events through August 6, 2025, the date the financial statements were available to be issued.
