**Note 1 – Description of Plan:**

The following description of the Keplr Vision 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. Effective January 1, 2020, the Plan is sponsored by Imperial Optical Midco, Inc. (the “Plan Sponsor”). Prior to January 1, 2020, the Plan was sponsored by HW Holdings, LLC D/B/A All About Eyes and the name of the Plan was HW Holdings, LLC D/B/A All About Eyes 401(k) Plan. There are various participating employers in the Plan.

General

The Plan was established to provide retirement benefits for employees of the Company. Eligible employees become participants in the Plan following three months of service. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan contains an elective 401(k) deferred compensation component. Eligible participants may elect to contribute up to 90% of their eligible compensation, subject to limitations to the 401(k) component of the Plan. The Plan is subject to a non-elective, safe-harbor matching contribution of 4%. The Plan Sponsor’s safe-harbor matching contributions for the plan year ended December 31, 2024 were \$4,814,981.

Rollover contributions are permitted under the Plan and shall be accepted from participants and non-participants, regardless of whether they have satisfied the eligibility requirements set forth in the Plan. There were \$456,647 of rollover contributions received by the Plan during the plan year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the employer’s contributions, and the earnings attributable to the participant’s account.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Participant Notes Receivable

Participants may borrow from their accounts according to the Plan document. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**Note 1 – Description of Plan – Continued:**

Vesting

Participants are immediately vested in their 401(k) and ROTH 401(k) contributions, which also include rollover contributions, and safe-harbor employer matching contributions, plus actual earnings thereon. That portion of the participants' account attributable to discretionary employer contributions is fully vested after completion of six years of service. Amounts forfeited by terminating participants of the Plan are to be used to reduce the Plan's ordinary and necessary administrative expenses for the Plan year. Any remaining forfeitures are then to be used to reduce Employer contribution obligations for such plan year.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited accounts totaled \$-0- and \$1,172, respectively. Amounts forfeited by terminating participants of the Plan will be used to reduce the Plan's ordinary and necessary administrative expenses and/or employer contributions.

Distributions to Participants

Amounts credited to an individual participant's account are distributed at termination of employment as a lump sum or in installments. Distributions may be deferred until the later of the participant's actual retirement date or the attainment of age 65, if the value of the distribution is not less than \$5,000. However, the Plan agreement stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the age of 73, unless the participant is not a 5% owner of the Company and is still employed by the Company. In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to their vested account balance.

Plan Amendments

During the plan year ended December 31, 2024, the Plan was amended to include the prior service of and include the employees of certain employers purchased and merged into the Plan Sponsor.

**Note 2 – Summary of Accounting Policies:**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are held in a trust. The custodian values all investments at fair value. Investments are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Assets Available for Benefits

Net assets available for benefits at both December 31, 2024 and 2023 included \$-0- allocated to the accounts of persons who, prior to that date, had withdrawn from participating in earnings and operations of the Plan.

**Note 3 – Tax Status:**

The Plan Document was restated on January 1, 2020 and obtained its latest determination letter during 2020 (prototype Plan Document), in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator and the Plan's Sponsor believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 4 – Investments:**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$80,715,913 and \$67,656,236 as of December 31, 2024 and 2023, respectively.
- b. Total investment income (loss) as shown in the accompanying statement of changes in net assets available for benefits is \$9,534,058 for the year ended December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 5 – Common Collective Trust Fund:**

The Plan has a fully benefit-responsive common collective trust fund (“stable value fund”). The custodian maintains the contributions in a general account that is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the stable value fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The stable value fund is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2024 and 2023 was \$1,559,798 and \$4,660,261, respectively. The crediting interest rate is based on a formula agreed to with the issuer.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

The stable value fund does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

**Note 6 – Fair Value Measurement:**

The Plan has determined the fair value of certain assets and liabilities through application of ASC 820. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value are classified and disclosed in one of the following three categories:

- Level 1 – Valuations for assets and liabilities traded in active exchange markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.
- Level 2 – Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or similar assets or liabilities.
- Level 3 – Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets.

Mutual funds and money market mutual funds listed on a national market or exchange are valued at the last sales price, or if there is no sale and the market is still considered active at the last transaction price before year end.

**Note 8 – Related Party Transactions and Party-In-Interest Transactions:**

Certain Plan investments are shares of mutual funds managed by various fund companies. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor absorbs some of the administrative costs of the Plan.

**Note 9 – Uncertain Tax Positions:**

Accounting principles generally accepted in the United States of America require the Plan's management evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by applicable taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax years prior to 2021 are closed.

**Note 10 – Subsequent Events:**

No events have occurred subsequent to December 31, 2024 which would require accrual or disclosure in these financial statements. This evaluation was made as of September 3, 2025, the date these financial statements were available to be issued.
