For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Description of Plan**

The following description of the 2<sup>nd</sup> Adventure Payroll Services LLC (“Company”) 401(K) Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan covering all employees of the Company who have three consecutive months of service and are age 18 or older. Once employees are eligible, employees can enter the Plan at the beginning of the next quarter. Employees not eligible for the Plan include union employees, nonresident aliens, leased employees, and temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours of service. The Plan was amended effective January 1, 2004 to become what is referred to as a “safe harbor 401(k) plan.” It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions* - Each year, participants may contribute an amount not to exceed a specific dollar amount determined by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2021, newly eligible employees are automatically enrolled in the Plan with a 5% deferral rate. The Plan currently offers various mutual funds and insured investment contracts as investment options to participants. Effective January 1, 2015, the Company contributed 100% of the participant’s elective deferrals that did not exceed 5% of the participant’s compensation. The matching Company contribution is invested into various investment options offered by the Plan and is referred to as an enhanced matching contribution. Additional amounts may be contributed at the option of the Company's board of directors and are invested in the same investment options as mentioned above for participants and Company matching contributions.

*Participant Accounts* - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are immediately vested in their contributions, the enhanced matching contribution and the Company’s discretionary contribution, plus actual earnings thereon.

*Notes Receivable from Participants* - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through bi-weekly payroll deductions.

*Payment of Benefits* - Active participants may take a withdrawal from the Plan in the event of a financial hardship. A hardship withdrawal will result in a six-month suspension of contributions to the Plan. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not to exceed the life expectancy of the participant or survivor. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan will make a mandatory distribution following severance from employment for balances less than \$1,000. Amounts due to participants who have elected to withdraw from the Plan at December 31, 2024 and 2023 totaled \$0 and \$0, respectively.

*Forfeited Accounts* - At both December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. These accounts, when there are balances, will be used to reduce the earliest Company contribution made after the forfeitures are determined.

**Note 2 - Summary of Accounting Policies**

*Basis of Accounting* - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Changes in fair value of investments are recognized when the investments appreciate or depreciate in value.

*Investment Valuation and Income Recognition* - Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* - Benefits are recorded when paid.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

*Date of Management Review* - Management has evaluated subsequent events through September 4, 2025, the date which the financial statements were available to be issued.

**Note 3 - Fair Value Measurement**

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

*Mutual funds:* Mutual funds are reported at fair value based on the quoted market price of the fund, which represents the net asset value of shares held by the Plan at year end. The fair values of mutual funds are classified within Level 1 of the hierarchy.

*Common collective trusts:* Common Collective Trusts (CCTs) are valued at the net asset value (NAV) of units held by the Plan at year-end, as reported by the trustee. The NAV is based on the fair value of the underlying assets of the trust, minus its liabilities, and is considered a readily determinable fair value. Although the NAV is not publicly quoted on an active exchange, it is calculated in a manner consistent with the measurement principles of investment companies. As such, these investments are classified as Level 2 in the fair value hierarchy.

*Common Collective Trust (Stable Value Fund):* Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The fund does not have a readily determinable fair market value and as a result is not classified within the fair value hierarchy.

The following tables present by level, within the fair value hierarchy, the plan investment assets at fair value, as of December 31, 2024 and 2023. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

**Note 4 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**Note 5 - Tax Status**

The Internal Revenue Service has determined and informed the Company by an advisory letter dated August 19, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the advisory letter. However, the plan administrator and the Plan's tax advisory counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Administrative Expenses**

Substantially all administrative expenses associated with the Plan are paid directly by the Company.

**Note 7 - Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 – Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments and notes receivable from participants held at December 31, 2024, and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport and T. Rowe Price (the trustees of the Plan).

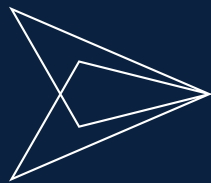
