## Independent Auditor's Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the United Brass Works, Inc. Employee Savings Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP")
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### 1. Description of Plan

The following description of the United Brass Works, Inc. Employee Savings Retirement Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of United Brass Works, Inc. (the “Company”). To be eligible to participate in the Plan, an employee must have attained age 21 (amended to age 18 effective December 2024) and completed one month of service. Employees may begin participation as of the first day of the plan quarter coinciding with or following the date on which the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Eligible employees are automatically enrolled at a 6% deferral percentage unless they elect an alternative percentage or decline participation. Participants may otherwise elect to contribute to 95% of their pre-tax and/or after-tax (“Roth”) compensation as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

The Company may make discretionary matching contributions and/or discretionary profit sharing contributions to the Plan as determined annually. The Company made discretionary matching contributions of 25% of participant contributions up to 15% of eligible compensation in 2024 and 2023.

For 2023, the Company also made a discretionary profit sharing contribution of 2% of eligible participants’ compensation, amounting to approximately \$133,000. There was no discretionary profit sharing contribution for 2024. The discretionary profit sharing contribution is allocated to eligible participants who are active as of year-end and have 1,000 hours of service in the plan year based upon the percentage of their compensation to total compensation for all eligible participants. In lieu of the Company’s discretionary profit sharing contribution, eligible union employees of the Company’s Keystone Foundry division receive a Company contribution equal to \$0.40 per hour worked, which amounted to approximately \$26,000 and \$24,000 for 2024 and 2023.

Upon enrollment in the Plan, a participant may direct contributions to various investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the affected participant’s vested account balance.

#### ***Vesting***

Participants are immediately vested in their contributions and Company discretionary matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions and Company contributions for eligible union employees is based on years of continuous service according to the following schedule.

#### ***Notes Receivable from Participants***

Participants may borrow from the Plan a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms are generally up to five years and only one note may be outstanding at a time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest based upon prevailing interest rates. Principal and interest are paid ratably through payroll deductions.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, participants may elect to receive a lump-sum amount equal to the value of the vested interest in his or her account or installment payments over a specified period of time. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified by the Plan.

#### ***Forfeitures***

Forfeitures from non-vested participant accounts may be used to offset plan administrative expenses or future Company discretionary matching contributions. During 2024, forfeitures of approximately \$50 and \$11,000 were used to reduce administrative expenses and Company discretionary matching contributions. During 2023, forfeitures of approximately \$4,000 and \$7,000 were used to reduce administrative expenses and Company discretionary matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts were approximately \$23,000 and \$11,000.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Certain plan expenses, such as recordkeeping expenses, are permitted to be paid from the Plan's assets. Distribution and loan fees are paid from the affected participant's account. Participants may elect to receive certain investment advisory services from Strategic Advisors, Inc. Fees for such services are paid from the related participant accounts in 2024 and 2023. See Note 7.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through July 23, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity").

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Tax Status

The Plan has adopted a prototype plan document sponsored by FMR LLC ("FMR"). The IRS has determined and informed FMR by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### 7. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Fidelity. Fees paid by the Plan to Fidelity for administrative services were approximately \$2,000 and \$3,000 in 2024 and 2023. Fidelity serves as the Plan's recordkeeper and trustee and, as such, these transactions qualify as party-in-interest.

Fees paid by the Plan to Strategic Advisors, Inc. for investment advisory services were approximately \$4,000 and \$5,000 in 2024 and 2023.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

### 8. Fair Value Measurements (Concluded)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer using the estimated fair value of the underlying assets, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
