

NOTE 1 – DESCRIPTION OF PLAN

Lexitas 401(k) Plan (the Plan) is a defined contribution 401(k) profit sharing plan adopted by Deposition Solutions, LLC dba Lexitas (the Company), originally effective on January 1, 2016, to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was amended effective August 1, 2024, to modify the Trust Declaration page the Plan Document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is administered by the Company. The summary of significant provisions of the Plan presented below provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: All nonexcluded employees of the Company who have completed at least 60 days of service and have attained the age of 21 are eligible to participate in the Plan. The Plan's entry date is the first day of the month coinciding with or next following the date an employee satisfies the eligibility requirements.

Contributions: Participants may elect to defer up to 100% of their eligible compensation into the Plan as a pre-tax 401(k) or Roth 401(k) deferral, not to exceed the dollar limit set by law. Participants who are age 50 or over may also defer an additional amount called a catch-up contribution. Participants may revoke their salary deferral election at any time during the Plan year. Participants may be permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

The Company may make a discretionary matching contribution equal to a uniform percentage of participants' salary deferrals. Each year, the Company will determine the amount of the discretionary percentage. During 2024, the Company matched 50% up to 3% of participants' salary deferrals.

The Company may also make a discretionary profit-sharing contribution to the Plan. The profit-sharing contribution will be allocated or divided among participants eligible to share in the contribution for the Plan year. For 2024, the Company did not make a discretionary profit-sharing contribution.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their salary deferrals and rollover contributions, plus any Plan earnings thereon. A participant's vested percentage in their accounts attributable to employer discretionary matching and profit sharing contributions, plus actual Plan earnings, thereon is based on years of vesting service. Participants will become 100% vested after five years of service.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan upon termination of employment, normal retirement, disability, or death. If a participant's vested account balance does not exceed \$5,000, then the participant's vested account balance may be distributed in a single lump-sum payment, or it may be rolled into an IRA by the Plan if the participant's vested account is more than \$1,000, the participant has not reached normal retirement age, and the participant does not elect to have their vested account paid to them in a single sum or rolled to another retirement plan or an IRA of their choice. If a participant's vested account balance exceeds \$5,000, the participant must consent to any distribution before it may be made.

Participants may receive an in-service distribution from their vested accounts, provided they have attained age 59½. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Notes Receivable From Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over the participant's current outstanding balance of loans as of the date of the new loan. Loans are secured by the balance in a participant's account. All loans bear a reasonable rate of interest. Principal and interest are paid ratably through payroll deductions or payment by check. The term of the loan may not exceed five years unless it is for the purchase of a participant's principal residence.

Forfeited Accounts: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. The Company may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. At December 31, 2024 and 2023, the forfeited nonvested account totaled \$5,867 and \$4,264, respectively. During 2024, approximately \$13,000 of forfeitures were used to reduce employer matching contributions.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credit to participants' accounts will become 100% vested.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 5, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) required the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company dba Principal Trust Company and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (adjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – GUARANTEED INVESTMENT CONTRACT

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (“Principal”). Under the terms of the group annuity contract (Contract No. GA 6-13953), Principal maintains the contributions in its general account. The contract is non-participating and provides fixed dollar benefits to participants.

The contract is credited with interest at a rate declared annually in advance by Principal. The crediting rate is based on a formula defined in the contract, which considers prevailing market interest rates, including the average of 5-year Constant Maturity Treasury Rates reduced by 1.25%, and is subject to a contractual minimum of 1.00%. The interest rate is reviewed and reset annually and was not less than the minimum guaranteed rate during the periods presented.

Principal is contractually obligated to repay the principal and credited interest to the Plan under the terms of the contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, the contract includes “Equity Wash” provisions, which require that any transfers from the guaranteed investment contract to competing investment options (such as money market or short-term bond funds) must first be directed to a non-competing option and held for a specified period, as defined in the contract.

Additionally, the contract contains provisions that allow Principal to impose restrictions or charges under certain plan-level circumstances. For example, if the Plan sponsor elects to terminate the contract or initiates large-scale withdrawals unrelated to participant-directed events (e.g., in connection with a plan termination, merger, or employer bankruptcy), a surrender charge of up to 5% may be imposed. These surrender charges may be waived under certain conditions, including sufficient advance notice and compliance with contract thresholds. During periods of significant market disruption, the contract allows Principal to defer payment of non-participant withdrawals for up to 30 business days to ensure orderly liquidation of assets. Interest continues to accrue at the contract rate during such deferral periods.

At December 31, 2024 and 2023, the contract value of the guaranteed investment contract was \$941,016 and \$919,639, respectively.

The Plan’s ability to receive amounts due is dependent on Principal’s ability to meet its financial obligations. Principal’s ability to satisfy its obligations under the contract may be affected by future economic and regulatory developments. As of the financial statement date, management is not aware of any events that would limit the Plan’s ability to transact at contract value.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds interest in various collective trust funds managed by Principal Life Insurance Company on behalf of Principal Global Investors Trust Company and an unallocated investment contract with Principal. Principal is a service provider and, therefore, these transactions and the Plan’s payment of fees to Principal qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved profit-sharing plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
