Note 1—Description of the Plan

The following description of the Curant, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a safe harbor, defined contribution plan maintained by Curant, Inc. (the “Company” or “Employer”). The Plan covers all employees who are age 21 or older and have completed six consecutive months of service, except certain union employees and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – Ascensus Trust Company (“Ascensus Trust”) serves as the “Custodian” of the Plan, while Ascensus, LLC (“Ascensus”) serves as the “Recordkeeper” of the Plan. The Employer is the administrator of the Plan, and certain administrative functions are performed by employees of the Employer. These employees do not receive compensation from the Plan.

Fidelity Bond – The Plan was covered by a \$500,000 fidelity bond during 2024.

Contributions – Participants may elect to contribute a portion of their compensation as a pre-tax deferral or Roth deferral subject to certain Internal Revenue Code (“IRC”) limitations. The sum of participants’ pre-tax and Roth contributions is subject to the annual limitation of \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Company may make three types of contributions: Actual Deferral Percentage (“ADP”) test safe harbor contributions, Actual Contribution Percentage (“ACP”) test safe harbor matching contributions, and profit sharing contributions. Employees are eligible to receive the ADP test safe harbor contribution made by the Company once they become eligible to contribute a portion of their compensation as a pre-tax deferral or Roth deferral. The Company is required to make an ADP test safe harbor contribution of 100% of employee contributions up to 4% of employee compensation. The ACP test safe harbor matching contribution and profit sharing contribution are discretionary contributions. The Company may make ACP test safe harbor matching contributions if necessary to timely allocate forfeitures in any given Plan year. The Company may make profit sharing contributions to the Plan in the years and in the amounts determined each year by the Company’s governing body. The Company has only made ADP test safe harbor contributions for the year ended December 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution, the Company's contribution, and allocations of: (a) the Company's discretionary contributions, and (b) Plan earnings and is charged for withdrawals and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants – Participants are only allowed one outstanding loan at a time and may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only take loans from mutual funds. Loan terms range from one to five years but may be longer if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest rates at 5.25% to 10.50% as of December 31, 2024. If a participant defaults on the loan, the outstanding loan balance plus accumulated interest is deemed a distribution and reported as income to the participant, subject to early withdrawal penalty.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. ADP test safe harbor contributions and ACP test safe harbor matching contributions are always fully vested and cannot be forfeited. Profit sharing contributions will fully vest after six years as follows:

Distributions – Vested amounts may be withdrawn by or distributed to a participant only upon: (1) termination of employment, (2) attaining the age of 59½, (3) retirement, (4) disability, (5) a hardship distribution, or (6) death (benefits distributed to beneficiary in accordance with the Plan document). Upon proof to the satisfaction of the Plan administrator of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes. Hardship withdrawals may be taken out of participant contributions, ADP test safe harbor contributions, and ACP test safe harbor matching contributions. However, hardship withdrawals may not be taken out of profit sharing contributions. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½. The participant is required to begin taking minimum distributions no later than April 1 of the calendar year following the calendar year the participant turns the required aged per the Internal Revenue Service (“IRS”) or terminates employment, whichever is later. If the participant reaches age 70 ½ in calendar year 2020 or later, the participant is required to begin taking minimum distributions no later than April 1 of the calendar year following the calendar year the participant turns 72 or terminates employment. A participant who is a 5% owner of the Company upon reaching the required aged needs to begin taking distribution payments, even if still employed with the Company.

Investment Options – Upon enrollment in the Plan, a participant may direct contributions into various investment options offered by the Plan. Participants may change their investment options at their discretion.

Forfeited Accounts – Forfeitures are retained in the Plan and will be used to reduce administrative expenses under the Plan or reduce future Employer contributions to the Plan. As of December 31, 2024 and 2023, forfeited nonvested account balances are \$24 and \$-0-, respectively. During the year ended December 31, 2024, \$20 was used to reduce administrative expenses under the Plan or reduce future Employer contributions to the Plan.

Administrative Expenses – The Company provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Company, including audit and legal fees, and are excluded from the accompanying financial statements.

Basis of Accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. The net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments. Securities transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan related to investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Note 2—Summary of significant accounting policies

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates of the Plan include the methods used to estimate the fair value of investments.

Payment of Benefits – Benefit payments are recorded as deductions from the net assets when they are approved for payment and paid by the Plan.

Risks and Uncertainties – The Plan's investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Contributions Receivable – The amount of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but that have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Employer contributions receivable in the Plan's financial statements.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Agreement.

Fair Value Measurements – The Plan follows the Fair Value Measurements topic of the Financial Accounting Standards Board Accounting Standards Codification 820, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in the situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 2—Summary of significant accounting policies (continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual Funds and Money Market Fund – Shares of mutual funds and the money market fund are valued at the net asset value (“NAV”) of shares held by the Plan at year-end. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

The Plan believes its valuation method is appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Recently Issued Pronouncements – Plan management is not aware of any recently issued accounting pronouncements that would have a material impact on the Plan's financial statements.

Note 3—Fair value of financial investments

See *Fair Value Measurements* in Note 2 for discussions of the methodologies and assumptions used to determine fair value of the Plan's investments. The Plan's financial instruments carried at fair value on a recurring basis by the fair value hierarchy levels described in Note 2 as of December 31 are as follows:

Note 5—Tax status of Plan

The Plan adopted a prototype standardized profit sharing plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax. Therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6—Related party and party-in-interest transactions

The Company provided certain administrative services without compensation from the Plan during the year ended December 31, 2024, which are not reflected in the accompanying financial statements.

The Plan invests in mutual funds and a money market fund managed by The Vanguard Group, Inc., who subcontracted its recordkeeping service agreement with the Employer to Ascensus. Transactions in such investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Notes receivable from participants also qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

Note 7—Information prepared and certified by the agent on behalf of the Custodian (unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Ascensus, LLC, a qualified institution, and an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule:

- Investments, at fair value, in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Notes receivable from participants in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income from investments, and interest income on notes receivable from participants in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

Note 8—Subsequent events

The Plan has evaluated subsequent events for potential recognition and disclosure through September 3, 2025, the date the financial statements were available to be issued.
