### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of VAMAC, Incorporated 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Notes to Financial Statements

**1. Description of Plan:**

The following description of the VAMAC, Incorporated 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement or summary plan description for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of VAMAC, Incorporated (the “Company”). Employees become eligible to participate immediately after attaining the age of 18. All employees are eligible for entry to the Plan on the entry day coinciding with or immediately following the date the employee completes the age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Participant accounts are administered by Fidelity Management Trust Company, the trustee, and Fidelity Workplace Services, an affiliate of the trustee and third party administrator of the Plan.

**Contributions:** The Plan provides for participant contributions of pre-tax annual compensation, as defined in the Plan. The Company may make matching contributions equal to a discretionary percentage and an annual profit sharing contribution based on participant compensation at the approval of the Company’s Board of Directors. During 2024 and 2023, the Board of Directors approved a profit sharing contribution of \$630,000, which was paid in February 2025 and March 2024, respectively. Participants of qualifying age may make additional “catch-up” contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

**Participant Accounts:** Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options:** Participants direct Fidelity Management Trust Company, the trustee, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s contributions is based on years of continuous service. Participants are fully vested in Company contributions after attaining five years of credited service.

**1. Description of Plan, Continued:**

**Notes Receivable from Participants:** Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate of interest. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary. Delinquent notes receivable from participants that the Plan administrators considers to be in default are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits:** Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. Participants with a vested balance less than \$5,000 are required to receive a lump-sum payment, while participants with a vested balance that exceeds \$5,000 may elect to receive a lump-sum payment or installment payments in an amount equal to the vested value of his or her account.

**Forfeitures:** Forfeited balances of terminated participants' non-vested accounts are first utilized to cover requisite administrative expenses, with any residual balance credited toward Company matching or profit sharing contributions. Forfeitures used to reduce Company contributions were \$48,126 for 2024 and \$38,000 for 2023. There were \$15,614 and \$33,504 in forfeited balances available at December 31, 2024 and 2023, respectively.

**2. Summary of Significant Accounting Policies:**

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**2. Summary of Significant Accounting Policies, Continued:**

**Use of Estimates:** The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued, and has determined that no additional disclosures are necessary.

**3. Fair Value Measurements:**

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Mutual funds:** Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/collective trust:** Valued daily at the NAV of shares or units held by the Plan. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determinable to be probable that the fund will sell the investment for an amount different than the reported NAV.

**3. Fair Value Measurements, Continued:**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Risks and Uncertainties:**

The Plan provides for investments in various securities. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

**5. Related-Party Transactions:**

The Plan invests in several funds sponsored by affiliates of Fidelity Management Trust Company, which are related-party transactions and identified as parties-in-interest in the accompanying schedule of assets held for investment purposes. The Plan paid administrative fees to the trustee totaling \$28,083 during 2024 and \$10,778 during 2023.

**6. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**7. Financial Information Certified by a Qualified Institution:**

Fidelity Management Trust Company, the trustee of the Plan, has certified that the following information is complete and accurate:

- Investments, at fair value;
- Investment income;
- Schedule of assets (held at end of year);
- Notes receivable from participants; and
- Interest income on notes receivable from participants.

**8. Tax Status:**

The Internal Revenue Service has determined and informed the prototype sponsor by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax jurisdiction.

**9. Administrative Expenses:**

Although not required by the Plan, a portion of the costs of the Plan administration is paid by the Company. The Company utilizes the assistance of an investment advisor with the Company paying half of the fee and the Plan paying the remaining half. Fees paid by the Plan to the investment advisor amounted to \$14,594 for 2024 and \$11,707 for 2023.
