We have performed audits of the accompanying financial statements of Clise Agency, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN:

The Clise Agency, Inc. 401(k) Profit Sharing Plan (the Plan) is a contributory, defined contribution plan for the benefit of the employees of Clise Agency, Inc. and an affiliated company, Eighth Avenue Inn LLC (collectively “the Company”). The Plan is administered by the Company and the Plan assets are held in a trust by Voya Retirement Insurance and Annuity Company (“Voya”). The funds must be used for the exclusive benefit of Plan participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan includes a 401(k) feature whereby employees may contribute a portion of their pre or post tax compensation, as defined in the Plan and subject to statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employer matching contributions are discretionary, but, effective January 1, 2009, must meet the safe-harbor contributions as defined in the Plan. Matching contributions are 100% of the first 4% deferred and 50% of deferrals that exceed 4% but are less than or equal to 6%. Contributions to the Plan are generally made with each payroll and a true-up matching contribution is made annually, if needed.

The Plan also contains provisions allowing the Company to make discretionary profit sharing or non-elective contributions. No discretionary contributions were made in respect of 2024 and 2023.

Non-union employees are eligible for participation in the deferral portion of the Plan upon attaining the age of twenty-one years. In order to be eligible for matching or other employer contributions, the participant must have completed six months of service.

Each participant's account is credited with the participant’s contribution, and allocations of the related matching contribution and net plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Other employer contributions and allocated earnings thereon, if any, vest with individual participants based upon years of service, with 100% vesting after six years of service or at normal retirement age. Unvested benefits of terminated participants are forfeited and used to reduce employer matching contributions or to pay administrative expenses of the Plan. Forfeited non-vested accounts were \$899 and \$856, respectively, at December 31, 2024 and 2023.

Vested benefits are payable upon the retirement, death, disability or termination of a participant. In limited circumstances, participants may also take in-service withdrawals.

NOTE 1 - continued:

Employee contributions, employer matching contributions, and earnings thereon are invested as directed by the participants. The investment options include guaranteed interest contracts, and various mutual funds and target retirement date funds held through pooled separate accounts. Target retirement date funds are managed portfolios of the various funds available for individual investment. Participants may change their investment options at will.

Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance, with a minimum loan of \$1,000. The loans bear interest at a reasonable rate, are secured by the participants' vested account balances and are repaid ratably through payroll deductions. Outstanding loans are generally due within five years, or upon termination of a participant.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:**Valuation of investments-**

The Plan's investments in the pooled separate accounts are stated at fair value as determined by Voya based on the market value of the underlying investments.

For the guaranteed interest contract, contract value is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Accordingly, the Statement of Net Assets Available for Benefits presents the contract value of the guaranteed interest contract.

Recognition of income and expenses-

The Plan records income and expenses on the accrual basis of accounting. In accordance with generally accepted accounting principles, benefits are recorded in the period paid. Purchases and sales of securities are recorded on a trade-date basis.

Net appreciation (depreciation) in fair value of investments represents the net increase (decrease) in the fair value of investments sold during the year or held at year-end over (1) the fair value of investments held at the prior year-end, or (2) the cost of investments acquired during the current year.

Certain administrative costs of the Plan are borne by the sponsor. In addition, the sponsor may provide services to the Plan for which the sponsor receives no compensation. The costs borne by the Plan include investment advisory fees, third party administration and other direct and indirect administrative costs.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance. Interest is based on the prime rate in effect at the date of the loan's inception plus 1%. Principal and interest are paid with each pay period. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses is provided due to adequate collateral underlying the notes receivable.

NOTE 2 - continued:**Use of estimates-**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets and net assets available for benefits at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

NOTE 3 - INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan's investments include a fixed income account (guaranteed investment contract) that has features of a fully benefit-responsive investment. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract as participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the fixed income account at contract value.

Certain events may limit the ability of the Plan to transact at contract value with Voya. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Withdrawals from the fixed income account for payments of benefits to participants are permitted, however, the Plan is restricted to limit other withdrawals and transfers from this investment, and if it does so, it may incur surrender charges and market value adjustments. The Plan administrator does not believe the occurrence of any event which would limit the Plan's ability to transact at contract value is probable.

The guaranteed investment contract does not permit Voya to terminate the agreement prior to scheduled maturity date.

NOTE 4 - FAIR VALUE MEASUREMENTS:

Fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability. There are three levels, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

NOTE 4 - continued:

As of December 31, 2024 and 2023, the fair value of pooled separate accounts was determined using Level 1 inputs, which are based on the market value of the underlying investments.

NOTE 5 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN:

The following information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared and certified as complete and accurate by the custodian:

1. Value of investments as of December 31, 2024 and 2023,
2. Investment income for the year ended December 31, 2024.

NOTE 6 - FEDERAL INCOME TAXES:

The Plan trustees adopted a non-standardized pre-approved plan. A determination letter dated June 30, 2020 from the Internal Revenue Service has been obtained by the plan sponsor that states that the form of the plan qualifies under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable IRC requirements. Therefore, the Plan's management believes that the Plan is qualified and the related trust was tax exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 - continued:

There are no Internal Revenue Service examinations in progress and there are no uncertain tax positions that should be disclosed or accrued in the Plan's financial statements. Tax returns for years prior to 2021 are no longer subject to examination.

NOTE 7 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS:

Voya Retirement Insurance and Annuity Company acts as custodian and trustee for investments of the Plan. Therefore, transactions with Voya, including its management of the pooled separate accounts, qualify as party-in-interest transactions. In addition, Hunnex and Shoemaker is the Plan's third-party administrator. Fees paid to Hunnex and Shoemaker are party-in-interest transactions.

NOTE 9 - RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS:

Management has evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued.

The Plan was amended on January 1, 2025, which remove the service requirement to be eligible for safe-harbor contributions.

The Plan was amended on July 1, 2025, which allowed participants to convert all or any portion of his/her non-Roth vested account balance to an in-Plan Roth conversion account.
