#### **1 Description of Plan**

The following description of the Vintage Wine Retirement Savings Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

***General:***

The Plan, which began January 1, 1997, is a defined contribution plan covering all non-union employees of Vintage Wine Distributor, Inc. ("Company") who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was restated, effective February 17, 2022, in order to comply with the legislative and regulatory changes set forth in IRS Notice 2017-37 Cycle 3 Restatement.

***Eligibility:***

All non-union employees of the Company who are employed for at least 60 days are eligible to begin participation in the Plan.

***Contributions:***

Employee Deferral - Participants may elect a portion of their compensation, up to the maximum allowed by law, to be contributed to the Plan by the Company.

Employer Matching Contributions - The Company makes safe matching harbor contributions to each eligible participant's account by matching 100% of the salary deferral contributions, not to exceed 4% of compensation for the Plan year.

Employer Discretionary Contributions - The Company may also make additional contributions. Such additional contributions, if any, shall be allocated to each participant in proportion to his or her compensation for the calendar year. The Company did not make any additional contributions in 2024 and 2023.

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

***Participants' Accounts:***

401(k) Accounts - Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, and earnings and losses thereon.

**1 Description of Plan, Continued**

***Vesting:***

All participants are 100% vested in elective deferrals, employer matching contributions, and rollover contributions made to the Plan.

Vesting in employer discretionary contributions is based on years of service. A participant is vested as follows:

Years of Service	Vested %

2	20%
3	40%
4	60%
5	80%
6	100%

***Forfeitures:***

Forfeited non-vested accounts totaled \$0 (2024 and 2023). Forfeitures can be used to pay administrative expenses or reduce future employer contributions.

***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed five years, with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at rates established by Principal Trust Company. Principal and interest are paid ratably through payroll deductions.

***Other Plan Provisions:***

Normal retirement age is 65; however, a participant may elect early retirement on or after age 55 and the attainment of 6 years of vesting service. The Plan also provides for early payment of benefits after reaching age 59-1/2.

***Payment of Benefits:***

Upon termination of service by reason of termination of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account.

#### **1 Description of Plan, Continued**

##### ***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

##### ***Valuation of Investments:***

Investments are stated at fair value. Mutual funds are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The pooled separate accounts are valued based on net asset value as the practical expedient as determined by the asset custodian on a daily basis. The fair value of the common collective trust is based on the underlying assets of the fund. The fair value is expressed in units and they can be redeemed at their net asset value on their measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net unrealized/realized appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Administrative Fees:***

Substantially all administrative fees are paid by the Company.

## 2 Summary of Significant Accounting Policies, Continued

### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### *Risks and Uncertainties:*

The Plan's investments include investments in mutual funds, pooled separate accounts and a common collective trust holding investment contracts with varying degrees of risk, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

### *Contributions:*

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through August 29, 2025, which is the date the financial statements were available to be issued.

## 3 Tax Status

The Plan adopted a pre-approved prototype plan from Principal Financial Group. On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets;
- \* Quoted prices for identical or similar assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability; and
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

##### ***Mutual Funds:***

The fair values of the mutual funds are based on quoted market prices and are classified in the Level 1 category of the valuation hierarchy.

##### ***Common Collective Trust:***

The fair value of the common collective trust is based on the underlying assets of the contract. The fair value is expressed in units. The common collective trust is classified in the Level 2 category of the valuation hierarchy, as units can be redeemed at their net asset value on their measurement date. The common collective trust units can be redeemed on a daily basis, and there are no unfunded commitments.

##### ***Pooled Separate Accounts:***

The pooled separate accounts are valued based on the net asset value as a practical expedient (“NAV”) of shares held by the Plan at year-end. The pooled separate accounts can be redeemed on a daily basis and there are no unfunded commitments.
