## INDEPENDENT AUDITORS' REPORT

### *Opinion*

**1. DESCRIPTION OF PLAN**

The following description of Baxter Healthcare of Puerto Rico LLC DBA Baxter Healthcare of Puerto Rico Welfare Wrap Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan is a contributory health and welfare plan designed to provide certain medical and dental services, as well as prescription drug coverage to plan participants. It is a self-funded plan with non-stop loss coverage.

The Plan is sponsored by Baxter Healthcare of Puerto Rico LLC (formerly Baxter Healthcare SA) and related entities, which have adopted the particular Plan on behalf of their Puerto Rican employees (“Baxter”).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Stop-Loss Provision***

The Plan does not carry a stop-loss provision; therefore, any additional obligations exceeding the Plan’s net assets available for benefits will be covered by the Plan’s sponsors.

***Plan Administration***

The Plan is administered by the Administrative Committee of Baxter International, Inc. the members of which are appointed annually by the Compensation Committee of Baxter International Inc.’s Board of Directors.

***Plan Expenses and Administration***

Baxter is responsible for the general administration of the Plan and for carrying out the provisions thereof. Medical service claims are administered through Medical Card System (“MCS”) and all pharmacy and drug prescription claims are administered through CVS Caremark Puerto Rico, LLC (“CVS”) for a management fee.

### ***Contributions***

Plan participants authorize Baxter to make payroll deductions under the Plan depending on the desired coverage. Baxter makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by Baxter on a pay-as-you-go basis.

### ***Plan Participation***

The Plan covers all employees under Baxter's payroll who work for a Baxter subsidiary, division, or facility which has adopted the Plan on behalf of their employees. Eligible employees must be scheduled to work at least 20 hours per week and must not be members of a collective bargaining unit (unless participation in the Plan is part of the bargaining agreement). Employees may choose from various coverage options.

### ***Medical Coverage***

Uniform coverage is provided to all participants and their eligible dependents. Participants share the cost of services through co-payments that vary depending on the service as well as the provider.

Medical coverage of the Plan is provided through a Preferred Provider Organization ("PPO"), where the participants have a choice of using a participating network of providers or providers outside the network. The Plan covers eligible charges at pre-negotiated rates with participating PPO providers. For services received outside of the PPO network, the participants are responsible for paying the service and filing a claim with MCS for reimbursement at pre-negotiated PPO rates. Special provisions apply for services received outside of Puerto Rico.

### ***Dental Coverage***

The Plan and the participants share the cost of dental coverage. The Plan pays 100%, 70%, or 50% of pre-negotiated rates depending on the service received by the participant. The Plan pays eligible charges up to \$1,000 per participant per calendar year.

### ***Prescription Drug Coverage***

Pharmacy benefits are administered by CVS. Medications prescribed may be obtained through the CVS Pharmacy Network when an ongoing condition exists. The Participants share the cost through co-payments.

### ***Plan Termination***

Although it has not expressed any intent to do so, Baxter has the right to terminate the Plan at any time.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***Basis of Accounting***

The Plan's financial statements are prepared under the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

### ***Claims Incurred but not Reported***

Plan obligations at December 31, 2024 for health claims incurred by active participants but not reported ("IBNR") at this date and for the accumulated eligibility of participants are estimated by Baxter's management based on an analysis of historical claims-cost data and reserve as estimated by the Plan's third-party administrator (MCS) using actuarial methods which take into consideration prior claims experience and the expected time period from the date such claims are incurred to the date that the related claims are submitted and paid.

Based on the above, management recognized an adjustment to correct the IBNR as of December 31, 2024 of approximately \$8.6 million significantly reducing net assets available for benefits, as they concluded the balance materially overstated. The effect of this correction is included in the statement of changes in net assets available for benefits.

## **3. THIRD PARTY ADMINISTRATION AGREEMENTS**

The Plan has an agreement with MCS, under which MCS provides administrative services for certain functions of the Plan. MCS reviews, evaluates, refers, adjusts, and pays or rejects all claims, within the authority granted by the agreement. Also, MCS maintains all records of claims for services provided to participants.

In addition, the Plan has an agreement with CVS, under which CVS provides pharmacy benefit management services. To the extent authorized by the agreement, CVS processes requests for payments of prescription drug claims submitted by participants directly to CVS. Also, CVS maintains all records of claims for services provided to participants.

Total management fees charged to the Plan for the year ended December 31, 2024 under the terms of these agreements amounted to approximately \$639,000.

#### 4. POST-RETIREMENT BENEFITS

The Plan does not provide post-retirement benefits.

#### 5. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500 OF THE U.S. DEPARTMENT OF LABOR

Amounts currently payable for participants, beneficiaries, and dependents are recorded on Schedule H of Form 5500 for benefit claims that have been processed and approved for payment prior to December 31<sup>st</sup> but not yet paid as of that date.

## **6. TAX STATUS**

As mentioned in Note 1 to the financial statements, benefits paid under the Plan are funded by Baxter when claims are due. Therefore, the Plan has no interest income and no revenues; consequently, no determination letter on the Plan's tax status has been requested from the Puerto Rico tax authorities. As a result, no provision for income taxes has been included in the Plan's financial statements for the year ended December 31, 2024.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities.

The Plan's Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

## **7. SUBSEQUENT EVENTS**

Management evaluated all activities of the Plan through August 26, 2025 (the date the financial statements were available to be issued) and concluded that no other subsequent events have occurred that would require recognition and/or disclosure in the notes to the financial statements as of December 31, 2024.
