***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed audits of the accompanying financial statements of DCA Outdoor, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### NOTES TO FINANCIAL STATEMENTS

#### YEARS ENDED DECEMBER 31, 2024 AND 2023

#### 1. DESCRIPTION OF PLAN

The following description of the DCA Outdoor, Inc. 401(k) (Plan) provides only general information. Participants should refer to the Plan document for more complete description of the Plan's provisions. The Plan covers eligible employees of DCA Outdoor, Inc., Anna Evergreen, LLC, Colonial Gardens, LLC, KAT Wholesale Outdoor, LLC, Utopian Transport, LLC, Schwope Brothers Tree Farm, LLC, Utopian Trees, Inc., BreHob Nurseries, LLC, Utopian Plants Indiana, LLC, Rio Verde Holdings, LLC, Schwope Brothers West Coast, LLC, and PlantRight, LLC.

General — The Plan is a Safe Harbor 401(k) profit sharing plan covering all non-leased employees of the participating sister companies. For all contributions, employees become eligible after completing one month of service and are age twenty-one or older. Eligible participants enter the plan as of the first day of each month immediately following or coincident with date of eligibility. The Participants may elect to defer a percentage of their eligible pay each pay period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Contributions — Participants may contribute a portion of pretax annual compensation, as defined in the Plan, not to exceed \$23,000 for 2024 and \$22,500 for 2023. Participants may also rollover amounts from other qualified defined benefit or contribution plans.

The Company will match 100% of employee contributions up to 4 per cent. The Company will make safe harbor contributions to eligible participants beginning on their plan entry date. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. Participants' contributions are subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan.

Participants over age 50 are eligible to defer an additional \$7,500, for 2024 and \$7,500 for 2023 as a catch-up contribution, under the Economic Growth and Tax Relief Reconciliation Act of 2001 (EGTRRA).

Credit Risk — The Plan evaluates its receivables for potential credit losses. At year end, the Plan did not consider any open accounts receivable as potential bad debts.

Participant Accounts — Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

Vesting — Participants are vested immediately in their contributions plus actual earnings thereon, safe harbor contributions and any amounts rolled over into the Plan. Vesting in the Company's profit sharing contribution is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Employees that terminate employment due to death, disability, or attainment of the Plan's Normal Retirement Age, currently age 59 1/2, are 100% vested in their total account balance.

Distributions — Upon termination of service due to death, disability, or retirement, a participant will receive a lump sum amount equal to the value of the participant's vested interest in their account. For transferred pension assets, a participant may receive the value of their interest in an annuity form of payment.

Participant Loans — Loans are available under the plan. The loan will be limited to the amount the participant can borrow without being treated as a taxable distribution. Generally, that may not be more than 50% of their vested account, or \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates that are commercially reasonable. Principal and interest is paid ratably through payroll deductions.

Participant Investment Rollovers — Participants are allowed to transfer or rollover funds into the Plan from other qualified or 401(k) plans.

Forfeited Accounts — At December 31, 2024, the Plan had no non-allocated forfeitures. Forfeitures are used to reduce the employer matching contribution or to pay plan expenses in accordance with the Plan and amounted to \$3,037 for the 2024 plan year.

Hardship Distributions — Hardship withdrawals are available under the plan. Withdrawals are subject to certain restrictions included in the Plan. There is a six month waiting period for additional deferrals after a hardship withdrawal.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, except for distributions paid to participants which are prepared on the cash basis of accounting.

Use of Accounting Estimates — The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid balance, plus and accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition — The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Contributions — Contributions from employees and the Company are recorded in the period in which the Company makes the payroll deductions from participant earnings.

Distributions - Distributions are recorded when paid. At December 31, 2024 there were no benefits processed and approved for payment, but not paid.

Expenses — Certain of the Plan's administrative expenses are paid by the Company. Other expenses are paid from plan assets and deducted from participant accounts in accordance with the plan document.

### 4. FAIR VALUE MEASUREMENTS

ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). *Common stocks, corporate bonds and U.S. government securities:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants remain 100% vested in their accounts.

**6. INCOME TAX STATUS**

The Internal Revenue Service has determined that the prototype plan agreement under which the Plan operates meets the requirements under the applicable sections of the Internal Revenue Code; however no request for a specific determination on the Plan has been made, nor is it required. The Plan administrator believes the Plan, as currently designed and operated, is qualified and the related trust is tax-exempt as of the financial statement date.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
