INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of the
UAW Group Health and Welfare Plan

Opinion

We have audited the financial statements of the UAW Group Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. The supplemental Schedule of Assets Held at End of Year and Schedule of Reportable Transactions is supplemental information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of the Plan’s management and was derived from the relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF PLAN

Effective May 17, 2011, The Plan changed its name from the UAW Local 2326 Health and Welfare Plan to the UAW Group Health and Welfare Plan. The UAW Group Health and Welfare Plan (the Plan) provides health and welfare benefits for eligible members of the UAW Local 2326, as well as employees of employers who have been accepted for participation in the Plan, including employees of the Union and the Plan itself.

The Plan is a multiemployer health and welfare benefit plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on January 1, 2001 by an Agreement and Declaration of Trust. The Plan is maintained pursuant to collective bargaining agreements between the UAW Local 2326 and various employers, as well as under agreements with the UAW International Union.

The Plan provides health, medical, prescription, dental, vision benefits as well as life insurance coverage to eligible participants. The health, medical, prescription and vision benefits are all provided to participants through Horizon Blue Cross Blue Shield of New Jersey. The dental benefits are provided through Dental Services Organization, LLC, and Dentcare Delivery Systems. The life insurance benefits are provided through Aetna, Inc. The Plan provides both short term and long term disability benefits to one employer group that is provided through Mutual of Omaha on a fully insured basis.

Effective July 2011, the Plan became self-insured for medical benefits.

The member begins participation in the Plan pursuant to the eligibility requirements set forth in the collective bargaining agreement between the members' employers and UAW Local 2326, or in participation agreements.

The Plan is funded by employer and employee contributions as specified in the collective bargaining agreements. The hourly contribution rates vary by employer. Employer and employee contributions are accounted for as exchange transactions.

Stop loss insurance is provided by The Union Labor Life Insurance Company. The attachment point was \$250,000 from January 1, 2024 to June 30, 2024, and \$300,000 from July 1, 2024 through December 31, 2024.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting.

Contributions Receivable - Contributions due and not paid prior to the year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

Investment Valuation and Income Recognition - Certificates of deposit are valued at fair value which is cost plus accrued interest. Corporate obligations and mutual funds are carried at fair value, which generally represents quoted market prices or the net asset value of the mutual fund as of the last business day of the year. The Fixed Rate Fund is valued at contract value which approximates fair value. Contract value consists of money received under a funding agreement issued by Empower Annuity Insurance Company, to which the insurance company added interest at guaranteed crediting rates. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Obligations - Claims incurred but not reported were estimated by the Plan's consultant.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such a manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 4. TAX STATUS

The Plan obtained its latest determination letter on January 16, 2002 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 501(c)(9) of the Internal Revenue Code and was, therefore, not subject to tax under present Federal income tax laws. The Plan has been amended since receiving the determination letter. The Plan's Trustees and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 4. TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 5. CASH CONCENTRATIONS

The Plan places its cash with a financial institution deemed to be creditworthy. Cash balances exceeded the insured deposit limit of \$250,000 in a single bank at December 31, 2024 by \$0.

NOTE 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6. FAIR VALUE MEASUREMENTS (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the period.

For the years ended December 31, 2024 and 2023 there were no transfers in or out of levels 1, 2, or 3.

* Each year while the fixed rate fund is active all eligible participant withdrawals are paid daily at book value up to 10% of the opening balance adjusted for contributions and other withdrawals all other withdrawals are at fair market value.

The Prudential Fixed Rate Fund's primary investment objective is to provide liquidity and a competitive rate of return with safety of principal for eligible participant withdrawals.

NOTE 7. RELATED PARTY TRANSACTIONS

For the year ended December 31, 2024 and 2023, the Plan received \$0 and \$16,955, respectively, of interest payments from UAW Local 2326 per the Tolling Agreement (see discussion in Note 9). No principal payments have been received on the amount due from UAW Local 2326. The amount due is \$183,868 and \$140,324 at December 31, 2024 and 2023, respectively.

The Plan maintains a custodial relationship with Morgan Stanley Bank NA (Morgan Stanley) and invests in a money market account managed by Morgan Stanley. The Plan invests in a Prudential fixed rate fund managed by Empower Annuity Insurance Company. Therefore, these transactions qualify as party-in-interest transactions and have been denoted as such in the supplemental Schedule of Assets Held at End of Year.

The transactions identified above qualify as transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 8. RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The benefit obligations are reported based on certain assumptions pertaining to interest rates, health care inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 9. PROHIBITED TRANSACTION

During the period from January 1, 2001 through March 31, 2012, the Plan approved and paid health and welfare benefits for approximately eight UAW Local 2326 (the Union) employees/enrollees for whom no contributions were submitted to the Plan. UAW Local 2326 is a party-in-interest to the Plan. The financial statement for the year ended December 31, 2011, reported \$447,259 as a receivable from UAW Local 2326. Since that time, the Fund office has analyzed participation by Union enrollees from January 1, 2001 through March 31, 2012 and estimated that the amount receivable from the UAW Local 2326 is \$898,055 (with interest), which has been recorded as receivable from UAW Local 2326 as of December 31, 2013 and 2012.

The Plan made a formal demand against the Union for the full amount of the prohibited transactions, plus interest and attorneys' fees. Counsel for the Union, the Plan, and the U.S. Department of Labor have engaged in a cooperative review of all records in the possession of the Union and the New Jersey Attorney General's Office to identify relevant evidence that would support or contradict the amount of the Plan's demand. On January 7, 2015, the Plan entered into a Tolling Agreement with the Union. In the Tolling Agreement, the Union admitted liability to unpaid contributions for the period of January 1, 2006 through March 31, 2012 in the amount of \$540,254, which amount includes interest calculated in accordance with Section 502(g) of ERISA (the federal short term rate plus 3 percentage points). The Tolling Agreement acknowledges that the Union and the Plan dispute the amount of contributions owed for the period of January 1, 2001 through December 31, 2005. Under the Tolling Agreement, the Union has agreed to make monthly interest payments in an amount equal to the admitted liability (\$540,254) multiplied by the ERISA 502(g) rate to allow the Union and the Plan to negotiate the amount of contributions owed from January 1, 2001 through December 31, 2005, and an appropriate payment obligation for the admitted liability.

During the year ended December 31, 2023, the Union made the agreed upon monthly interest payments. The total paid for 2024 and 2023 was \$0 and \$16,955, respectively. At December 31, 2024 and 2023, the Union owed \$183,868 and \$140,324, respectively, in interest payments to the Plan.

On April 2, 2020, the Plan received a payment of \$401,823 in settlement of its fidelity bond claim relating to this prohibited transaction. In connection with that settlement, the Plan assigned 75% of future payments from the Union under the Tolling Agreement to National Union Fire Insurance Company of Pittsburgh "National Union".

On October 9, 2014, the Plan filed an action against Sergio Acosta (the Plan's former Union Trustee and Plan Administrator), Lawrence Ackerman (the owner of ABA and AMA, sham companies used by Ackerman to enroll ineligible individuals in the Plan's health coverage), and William J. Bacheler and Bacheler & Co., P.C. (the Plan's former independent auditor) in the United States District Court for the District of New Jersey, Docket No. 2:14-cv-06247. The Plan served all defendants and filed a First Amended Complaint on February 9, 2015. The Plan subsequently filed a Second Amended Complaint on October 19, 2015. In its Second Amended Complaint, the Plan asserted claims against Sergio Acosta for Breach of the Trust Agreement and ERISA fiduciary duties relating to causing the Plan's prohibited transaction with the Union, as well as the enrollment of ineligible participants in the Plan. \$500,000 was received during the year ended December 31, 2023 from William J. Bacheler and Bacheler & Co., P.C.

NOTE 9. PROHIBITED TRANSACTION (continued)

On February 4, 2016, in light of an ongoing criminal investigation of Acosta and Ackerman by the U.S. Attorney's Office in the District of New Jersey, U.S. District Judge Wigenton issued an order administratively terminating the Plan's above-described action, with the understanding that any party may request to reopen the action at any time. The Plan requested to reopen the case on August 1, 2020 and Judge Wigenton subsequently reopened the case on August 3, 2020. The Plan filed a Third Amended Complaint on August 6, 2020. With respect to the prohibited transaction with the Union, the Plan's Third Amended Complaint seeks a judgment for the full amount of the Union's delinquent contributions plus pre-and post-judgment interest. Prior to the Plan's reopening of the case, on January 9, 2017, a grand jury in the District of New Jersey issued an indictment against Sergio Acosta relating to both the enrollment of the ineligible ABA/AMA Enrollees and Acosta's failure to cause the Union to make contributions toward the cost of coverage for its enrollees. In April of 2018, Acosta pled guilty to knowingly converting the Fund's assets to his own use or to the use of another relating to his failure to cause the Union to make contributions toward the cost of coverage for its enrollees. Acosta was sentenced on January 15, 2019 and was ordered to pay \$32,000 in restitution to the Plan. Acosta made payments of \$2,200 during 2023, and the receivable balance was \$28,450 on the statement of net assets available for benefits as of December 31, 2023. Acosta made payments of \$2,400 during 2024, and the receivable balance was \$26,050 on the statement of net assets available for benefits as of December 31, 2024. In December of 2018, Ackerman pled guilty to one count of knowingly and intentionally executing a scheme or artifice to defraud a health care benefit program. On May 13, 2021, Ackerman was ordered to pay \$486,400 in restitution to the Plan. In connection with the settlement of the Plan's fidelity bond claim described above, effective March 28, 2020 the Plan assigned 75% of any restitution payments made to the Plan by Acosta to National Union Fire Insurance Company of Pittsburgh.

The Plan settled a portion of its claims brought in the litigation described above in February 2023 and subsequently settled the remaining claims in September 2023. The total amount the Plan received in settlement was \$875,000. \$10,000 was over accrued during the year ended December 31, 2022 and was written off during the year ended December 31, 2023.

NOTE 11. FEE MANDATED BY THE PATIENT PROTECTION AND AFFORDABLE CARE ACT

The Plan is subject to certain fees mandated by the Patient Protection and Affordable Care Act. Fees payable to the Patient-Centered Outcomes Research Institute (PCORI) are equal to \$3.00 per covered life for the 2023 calendar year, and \$3.22 per covered life for the 2024 calendar year. For the years ended December 31, 2024 and 2023, the Plan paid \$4,508 and \$4,883 in PCORI fees.

NOTE 12. LOANS PAYABLE

On February 16, 2012, the Plan entered into a loan agreement with UAW International Union for \$750,000. On October 23, 2012, the Plan entered into a loan agreement with UAW International Union for \$300,000. The purpose of these loans is to assist with the payment of operating expenses. The Plan shall commence repayment of the loans once the Plan's liquidity position has been stabilized and the Plan has accumulated reserves of at least six months of anticipated claims and administrative expense reserves. The terms of the loans are intended to comply in all respects with the Amendment to Prohibited Transaction Exemption 80-26 (PTE 80-26) for certain Interest Free Loans to Employee Benefit Plans which was published on April 4, 2006. No payments were made on these loans payable during the years ended December 31, 2024 and 2023.

NOTE 13. COMMITMENTS AND CONTINGENCIES

Effective July 1, 2011, the Plan has an Administrative Services Agreement with Horizon Blue Cross Blue Shield of New Jersey in the amount of \$36 per member per month to administer claims. As of December 31, 2023, the rate paid by the Plan to Horizon for administrative fees was \$28.33 per member per month and continues through December 31, 2025. These fees are guaranteed for a three year period. For the years ended December 31, 2024 and 2023, administrative fees paid to Horizon were \$523,610 and \$487,323, respectively.

NOTE 14. DEPOSITS WITH HEALTH INSURANCE PROVIDER

During June 2011, the Plan paid a deposit of \$750,000 to Horizon Blue Cross Blue Shield of New Jersey in connection with the Administrative Services Agreement and the change to self-insured medical benefits. As of December 31, 2024 and 2023, the deposit with Horizon Blue Cross Blue Shield of New Jersey was \$507,401 and \$444,310, respectively.

NOTE 15. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
