Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tangram Interiors Employees Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Tangram Interiors Employees Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

General

New Tangram, LLC, doing business as Tangram Interiors, (the Company) is the sponsor of the Plan. The Plan is a defined contribution plan covering substantially all employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

Empower Trust Company LLC (ETC) and Empower Annuity Insurance Company of America (EAICA), hold all assets of the Plan in accordance with the service provider contract with the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Full-time employees of the Company who have 60 days of service and are age 21 or older are eligible to participate in the plan.

Contributions

Eligible employees of the Company may elect to contribute either a specific dollar amount or whole percentages of pretax or after-tax (Roth) compensation, subject to statutory limitations. The Plan allows participants age 50 and over to make additional salary deferrals (referred to as employee catch-up contributions), subject to statutory limitations.

The Plan provides for an automatic enrollment, whereby the Company will automatically withhold a specific % of each eligible employee's compensation and deposit the amount into the Plan as an employee elective deferral, as defined in the Plan documents. The eligible employees automatically enrolled in the Plan may then elect to either (a) not to have elective deferrals made to the Plan under automatic enrollment, or (b) to have elective deferrals made at a different percentage.

Participants may also contribute amounts representing distributions from other qualified plans, which are reflected as rollover contributions in the Statement of Changes in Net Assets Available for Plan Benefits.

The Board of Directors of the Company may elect to make a discretionary employer matching contribution, profit-sharing contribution and/or a discretionary 401(k) bonus contribution to the Plan. No discretionary employer matching, profit sharing or discretionary 401(k) bonus contributions were made during the 2024 plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, if any, and an allocation of net Plan earnings. Participant accounts are charged with allocations of the Plan's losses and with administrative fees associated with loan requests and/or other participant requests, if any. Allocations are based on participant earnings or losses based on the specific investment options selected. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are immediately 100% vested in the amount of their contributions and actual earnings thereon.

Participants are vested in their discretionary employer matching contributions and profit-sharing contributions in accordance with the following schedule:

Vesting Service (in Years)	Vesting Percentage (%)
Less than 1	-
1 but less than 2	25
2 but less than 3	50
3 but less than 4	75
4 years or more	100

Participants receive one year of vesting service upon completion of 1,000 hours of service for a 12-consecutive month period, ending on the last day of each plan year.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

Forfeitures

Any participant who terminates his/her employment prior to the completion of the minimum number of applicable years forfeits his/her unvested employer contributions under the Plan. Forfeitures shall be used, first, to pay administrative expenses incurred by the Plan and, second, to

restore previous forfeitures of participants' accounts. Any remaining forfeitures will, at the direction of the Company be allocated to participants or used to reduce employer matching or discretionary contributions.

There were \$7,247 and \$7,150 of forfeitures included in Plan assets on December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$51 of forfeitures were used to pay administrative expenses, restore previous forfeitures of participants' accounts, or reduce employer contributions.

Revenue Credits

The Plan's trust agreement with Empower provides for a participant revenue credit arrangement, whereby Empower allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds or pay administrative expenses. There were \$67,609 and \$43,275 of unallocated revenue credits included in Plan assets on December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$49,500 were used to pay administrative expenses related to plan investments.

Notes Receivable from Participants

Notes receivable from participants consist of participant loans that are secured by the balance in the participant's account. Participants are permitted to borrow from their fund accounts a minimum of \$500 up to a maximum of (1) 50% of the participant's vested account in the Plan, or (2) \$50,000, reduced by the highest loan balance during the previous 12 months. The maximum number of Notes outstanding at any one time is two. Loans must be repaid within five years (unless loan proceeds are used to purchase a principal residence, which extends the repayment term up to 15 years). The notes are repaid in scheduled payments through regular payroll deductions. The loans bear a reasonable rate of interest (1% above prime rate), as determined at the time of the loan by the Plan Administrator. The loans are subject to certain restrictions as defined by the Plan Document and the applicable restrictions under the IRC.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts, which are reported at contract value (Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation

policies utilizing information provided by its investment advisers, and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Administrative expenses paid by the Plan totaled \$121,815 for the year ended December 31, 2024. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and the ERISA-required Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company LLC, and Empower Annuity Insurance Company of America as qualified institutions.

4. Contracts with Insurance Company

The Plan invests in a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America, formerly known as Prudential Retirement Insurance and Annuity Company, by investing in the Guaranteed Income Fund (GIF) totaling \$3,928,064 and \$3,458,631 at December 31, 2024 and 2023, respectively. Empower maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the issuer or otherwise.

The GIF specifies that generally there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The crediting interest rate of the contract is based on an agreed-upon formula with the custodian. The crediting interest rate was 2.10% as of December 31, 2024. Such interest rates are reviewed on a semiannual basis for resetting.

5. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used on December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSAs) - Pooled separate accounts are valued at the net asset value of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by EAICA is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by EAICA or their subsidiaries and affiliates, who also earn fees for providing recordkeeping and administrative services. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts. The Plan sponsor will facilitate the distribution of account balances in single lump sum payments to each participant in accordance with Plan provisions until all assets have been distributed.

9. Tax Status

The Plan has adopted a non-standardized Pre-approved Profit Sharing plan with CODA, which received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the preapproved plan is in compliance with applicable sections of the IRC. The Plan has since been amended. The Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for federal or state income taxes is reflected in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tangram Interiors Employees Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

1. Description of the Plan

The following description of the Tangram Interiors Employees Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

General

New Tangram, LLC, doing business as Tangram Interiors, (the Company) is the sponsor of the Plan. The Plan is a defined contribution plan covering substantially all employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

Empower Trust Company LLC (ETC) and Empower Annuity Insurance Company of America (EAICA), hold all assets of the Plan in accordance with the service provider contract with the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Full-time employees of the Company who have 60 days of service and are age 21 or older are eligible to participate in the plan.

Contributions

Eligible employees of the Company may elect to contribute either a specific dollar amount or whole percentages of pretax or after-tax (Roth) compensation, subject to statutory limitations. The Plan allows participants age 50 and over to make additional salary deferrals (referred to as employee catch-up contributions), subject to statutory limitations.

The Plan provides for an automatic enrollment, whereby the Company will automatically withhold a specific % of each eligible employee's compensation and deposit the amount into the Plan as an employee elective deferral, as defined in the Plan documents. The eligible employees automatically enrolled in the Plan may then elect to either (a) not to have elective deferrals made to the Plan under automatic enrollment, or (b) to have elective deferrals made at a different percentage.

Participants may also contribute amounts representing distributions from other qualified plans, which are reflected as rollover contributions in the Statement of Changes in Net Assets Available for Plan Benefits.

The Board of Directors of the Company may elect to make a discretionary employer matching contribution, profit-sharing contribution and/or a discretionary 401(k) bonus contribution to the Plan. No discretionary employer matching, profit sharing or discretionary 401(k) bonus contributions were made during the 2024 plan year.

Notes to Financial Statements

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, if any, and an allocation of net Plan earnings. Participant accounts are charged with allocations of the Plan's losses and with administrative fees associated with loan requests and/or other participant requests, if any. Allocations are based on participant earnings or losses based on the specific investment options selected. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are immediately 100% vested in the amount of their contributions and actual earnings thereon.

Participants are vested in their discretionary employer matching contributions and profit-sharing contributions in accordance with the following schedule:

Vesting Service (in Years)	Vesting Percentage (%)
Less than 1	-
1 but less than 2	25
2 but less than 3	50
3 but less than 4	75
4 years or more	100

Participants receive one year of vesting service upon completion of 1,000 hours of service for a 12-consecutive month period, ending on the last day of each plan year.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

Forfeitures

Any participant who terminates his/her employment prior to the completion of the minimum number of applicable years forfeits his/her unvested employer contributions under the Plan. Forfeitures shall be used, first, to pay administrative expenses incurred by the Plan and, second, to

restore previous forfeitures of participants' accounts. Any remaining forfeitures will, at the direction of the Company be allocated to participants or used to reduce employer matching or discretionary contributions.

There were \$7,247 and \$7,150 of forfeitures included in Plan assets on December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$51 of forfeitures were used to pay administrative expenses, restore previous forfeitures of participants' accounts, or reduce employer contributions.

Revenue Credits

The Plan's trust agreement with Empower provides for a participant revenue credit arrangement, whereby Empower allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds or pay administrative expenses. There were \$67,609 and \$43,275 of unallocated revenue credits included in Plan assets on December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$49,500 were used to pay administrative expenses related to plan investments.

Notes Receivable from Participants

Notes receivable from participants consist of participant loans that are secured by the balance in the participant's account. Participants are permitted to borrow from their fund accounts a minimum of \$500 up to a maximum of (1) 50% of the participant's vested account in the Plan, or (2) \$50,000, reduced by the highest loan balance during the previous 12 months. The maximum number of Notes outstanding at any one time is two. Loans must be repaid within five years (unless loan proceeds are used to purchase a principal residence, which extends the repayment term up to 15 years). The notes are repaid in scheduled payments through regular payroll deductions. The loans bear a reasonable rate of interest (1% above prime rate), as determined at the time of the loan by the Plan Administrator. The loans are subject to certain restrictions as defined by the Plan Document and the applicable restrictions under the IRC.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts, which are reported at contract value (Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation

policies utilizing information provided by its investment advisers, and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Administrative expenses paid by the Plan totaled \$121,815 for the year ended December 31, 2024. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and the ERISA-required Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company LLC, and Empower Annuity Insurance Company of America as qualified institutions.

4. Contracts with Insurance Company

The Plan invests in a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America, formerly known as Prudential Retirement Insurance and Annuity Company, by investing in the Guaranteed Income Fund (GIF) totaling \$3,928,064 and \$3,458,631 at December 31, 2024 and 2023, respectively. Empower maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the issuer or otherwise.

The GIF specifies that generally there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The crediting interest rate of the contract is based on an agreed-upon formula with the custodian. The crediting interest rate was 2.10% as of December 31, 2024. Such interest rates are reviewed on a semiannual basis for resetting.

5. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used on December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSAs) - Pooled separate accounts are valued at the net asset value of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by EAICA is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by EAICA or their subsidiaries and affiliates, who also earn fees for providing recordkeeping and administrative services. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts. The Plan sponsor will facilitate the distribution of account balances in single lump sum payments to each participant in accordance with Plan provisions until all assets have been distributed.

9. Tax Status

The Plan has adopted a non-standardized Pre-approved Profit Sharing plan with CODA, which received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the preapproved plan is in compliance with applicable sections of the IRC. The Plan has since been amended. The Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for federal or state income taxes is reflected in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.
