Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of IATSE Local No. 30 Health and Welfare Fund (the Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Fund's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Fund, and determining that the Fund's transactions that are presented and disclosed in the financial statements are in conformity with the Fund's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTE 1 DESCRIPTION OF FUND

The following description of the International Alliance of Theatrical Stage Employees and Motion Picture Operators of the United States and Canada (IATSE) Local No. 30 Health and Welfare Fund (the Fund) provides only general information. Participants should refer to the fund qualification requirements for a more complete description of the Fund's provisions.

General

The Fund is a joint union-management operated health and welfare fund utilizing employer and employee contributions to purchase insurance for participants and their dependents to provide life and medical benefits. The Fund was established on June 1, 1979. The Fund is subject to the provisions of ERISA, as amended. A related voluntary employees' beneficiary association trust (VEBA trust) was established to hold the Fund's assets. The Fund's affairs are administered by a Board of Trustees comprised of an equal number of representatives from the participating unions and the contributing employers.

In general, the Fund allows employees to participate in the Fund once they have at least \$30,000 in gross wages from November 1 to October 31 in the previous period. Eligibility for the Fund only terminates if Fund premiums are not paid or if the employee's gross wages fall below \$30,000 from November 1 to October 31 in the previous period.

Contributions

Participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Employer contributions are based on percentages of employee gross wages as established in collective bargaining agreements with the remaining cost being covered by participants. The Fund allows nonworking members otherwise ineligible for benefits to make voluntary contributions, which provide coverage under group insurance contracts. A nonworking member can maintain eligibility in the event the member was eligible in a prior period.

Benefits

The Fund provides fully insured health benefits (medical, vision, dental, and outpatient clinic) and life insurance benefits to eligible members and to their beneficiaries and dependents. The Fund purchases annual insurance contracts for these insured benefits. Premiums for group health and life insurance programs are paid to the insurance company from the assets of the Fund.

The Fund also provides a wellness program. The Fund pays an established monthly fee to the wellness provider for these services.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Fund are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Fund administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Concentration of Credit Risk

The Fund's cash balances are held at a single financial institution. Accounts at this institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. The balances in these accounts routinely exceed this FDIC insurance coverage limit; however, the Fund does not anticipate nonperformance by the institution.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fund administrator determines the Fund's valuation policies utilizing information provided by the financial institution. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Contributions due but not paid prior to year-end are recorded as contributions receivable. Contributions are due from employers and employees as specified in the collective bargaining and/or participation agreements. Delinquent contributions are individually analyzed for collectability. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was insignificant.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Employee Deposits

Employees have a "customer account" to allow for the billing and collection of employee contributions. All employees receive monthly statements detailing activity in their accounts and indicating the employee's share/liability to the Fund each month for coverage elected. Employees can make payments directly to the Fund or instruct their employer to withhold and remit amounts. As employers often withhold a set percentage of employee wages as dictated by the employee, amounts may be withheld and remitted which exceed the employee's share/liability to the Fund. Employee Deposits reflect the amount of employee contributions received by the Fund in excess of employee premiums charged to the employee's account. If an employee has been charged for premiums in excess of the amount paid into the Fund, then the employee will have Contribution Receivable due to the Fund.

Payment of Benefits

Premiums paid by the Fund are recorded as premium payments in the accompanying the statements of changes in net assets available for benefits.

Administrative Expenses

The Fund pays administrative expenses that consist primarily of an allocation of the cost of administrative services provided to the Fund by employees of IATSE Local No. 30 (the Union). See Note 6 for discussion of these expenses. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

Subsequent Events

The Fund has evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Cash – Interest-Bearing: Investments in interest-bearing cash are valued based on cost, which approximates fair value in a noninflationary environment and is protected by the FDIC.

NOTE 5 TAX STATUS

The VEBA trust funding benefits of the Fund received an exemption letter from the Internal Revenue Service (IRS) dated May 14, 1981, stating that the VEBA trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Fund's funding policy, from time to time the VEBA trust may be subject to income taxes. For the years ended December 31, 2024 and 2023, no federal or state income taxes have been recorded for unrelated business taxable income.

In addition, the Fund and VEBA trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the VEBA trust. The Fund administrator believes that the Fund is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related VEBA trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Fund management to evaluate tax positions taken by the Fund and recognize a tax liability (or asset) if the Fund has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 FUND TERMINATION

Although it has not expressed any intention to do so, the Fund has the right to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Fund subject to the provisions of ERISA. In the event of termination of the Fund, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Fund may revert to the Union or be used for purposes other than for the exclusive benefit of the Fund's participants.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

As described in Note 2, the Fund has several arrangements with service providers. The Union provides the Fund with administrative services, data processing services, and the use of office equipment. During the years ended December 31, 2024 and 2023, the Fund incurred \$15,892 and \$17,185, respectively, relating to such services.

The Fund leases its office space from the Union on a month-to-month basis for \$200 per month which includes all related expenses (utilities, taxes, etc.). No formal written agreement between the Fund and IATSE Local No. 30 exists at December 31, 2024 and 2023. Total expense incurred under this lease for the years ended December 31, 2024 and 2023 amounted to \$2,400 for each year. At December 31, 2024 and 2023, \$18,292 and \$19,585, respectively, was payable to IATSE Local No. 30 in connection with the above-mentioned services and lease. These transactions are party in interest transactions under ERISA.
