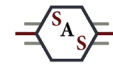

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

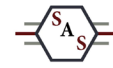

Notes to Financial Statements

1. Description of the Plan

The following description of the Marco Display Specialists, L.P. 401(k) Employees' Saving Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with a 401(k) deferral feature covering all full-time employees of Marco Display Specialist LP, Thermell Manufacturing Products LLC, and Kideye Holdings LLC, (collectively the "Company") who have one month of service and are age twenty one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Each year, participants are allowed to defer up to 75 percent of pretax eligible compensation subject to annual limits imposed by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions subject to annual limits imposed by the Internal Revenue Service. Participants are allowed to rollover amounts from other plans and IRA's. Participants direct the investment of their contribution into various investment options offered by the Plan. The Company may make discretionary contributions to the Plan at the option of the Company's board of directors and are subject to certain limitations. \$163,774 in discretionary contributions were made during 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of plan earnings (losses) net of an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company discretionary contributions plus actual earnings thereon is based on years of service, whereby a participant is 100% vested after six years of credited service. 2024 forfeitures totaled \$11,952. In 2024, the Company applied \$45,000 of forfeitures towards Company contributions.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participants account and bear interest at a fixed rate of one percent above the prime interest rate as published in the Wall Street Journal at the time of the loan unless otherwise determined by the trustee. Principal and interest are repaid ratably through payroll deductions over a term of no greater than five years (10 years for purchase of a primary residence).

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of these financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported revenues and expenses during the reported period. Actual results could differ from those estimates.

Participant Loans

Loans to participants are reported at their unpaid principal balances and collateralized by the balance in their individual account.

Investment Valuation and Income Recognition

Investments are reported at fair value as determined by quoted prices in an active market. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from employee deferral contributions are recorded in the period in which they become obligations to the Plan.

Administrative Expenses

The Company pays certain recurring administrative expenses of the Plan. Expenses not paid by the Company are paid by the Plan in accordance with the Adoption Agreement and amounted to \$27,612 during 2024.

Payment of Benefits

Benefits are recorded when paid.

3. Investments

All investments of the Plan are held in participant directed accounts. Investments are reported at fair value as measured by quoted market prices in an active market as follows at December 31:

4. Fair Value Measurements

The Plan follows FASB Accounting Standards Codification Topic 820, Fair Value Measurement (ASC 820). ASC 820 defines fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into the following three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are derived principally from or corroborated by observable market data, and Level 3 inputs are unobservable and have the lowest priority. The Plan has no investments valued with Level 2 or Level 3 inputs.

All investments of the Plan are held by the Trustee in participant-directed accounts. All investment transactions are performed by the Trustee.

The accompanying financial statements, supplemental schedule, and certain notes to these financial statements were prepared in part or entirely from information certified by the Trustee in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under the Employee Retirement Income Securities Act of 1974.

6. Party-in-Interest Transactions

Fidelity Management Trust Company accounts for all investment transactions and is the investment custodian as defined by the Plan. Plan investments in certain mutual and money market funds, sponsored and managed by Fidelity Management Trust Company, qualify as exempt party-in-interest transactions.

7. Income Tax Status

The Plan operates in accordance with Fidelity's Basic Plan Document No. 17. The Trustee received a favorable advisory letter dated June 30, 2020, in which the Internal Revenue Service stated that the basic plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). During 2022, Fidelity's Basic Plan Document No. 17 was amended to allow employees to be eligible for participation in the Plan from six months of services to one month of service. Although the basic plan document has been amended since receiving the advisory letter, the Plan administrator and the Trustee believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Management evaluates the Plan's tax positions and concluded that the Plan has taken no uncertain tax positions that require adjustment to the financial statements to comply with the provision of this guidance. Generally, the Plan is no longer subject to examination by taxing authorities for tax years prior to 2021.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

9. Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits. At December 31, 2024, participant directed investments include seven mutual funds amounting to \$4,469,987 in aggregate, each of which exceed 5% of net assets, and are considered individually significant to these financial statements. At December 31, 2023, participant directed investments include four mutual funds amounting to \$3,120,318 in aggregate, each of which exceed 5% of net assets, and are considered individually significant to these financial statements.

10. Subsequent Events

The Plan has evaluated subsequent events through July 17, 2025, which is the date the financial statements were available to be issued. Management is not aware of any material subsequent events.
