We have performed audits of the financial statements of Primo Medical Group, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

### 1. Description of Plan

#### *General*

The following description of the Primo Medical Group, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. The plan administrator controls and manages the operation and maintenance of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### *Eligibility*

The Plan is a defined contribution plan covering all full-time employees of Primo Medical Group, Inc. and Marver Cam Co., Inc. (collectively, the “Company”) who have three months of service and are 18 years of age or older.

#### *Contributions*

Contributions to the Plan are made by both the Company and participants. Participants may contribute up to 100% of their eligible compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations. The Plan automatically enrolls all new employees into the Plan with a deferral rate of 3% of their compensation unless they elect otherwise. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2024, the Plan allows Roth 401(k) deferrals, from which participants may now take hardship distributions, in-service distributions, and loans. The Plan also accepts direct rollovers from other Roth 401(k) and 403(b) plans.

The Company may, at its discretion, elect to contribute a profit-sharing contribution to the Plan, and the contribution is determined annually by the Board of Directors. The Company’s contribution is credited to each participant’s account based upon the ratio that each eligible participant’s eligible compensation for the plan year bears to the total eligible compensation paid to all eligible participants for the plan year. The Company may make a discretionary matching contribution equal to 25% of a participant’s contribution to the Plan, not to exceed 1.5% of compensation. For the year ended December 31, 2024, the Company made no profit sharing or discretionary matching contributions to the Plan.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in any company contributions is based upon years of service.

A participant is 100% vested in their portion of the Company's contribution after six years of credited service in accordance with the following schedule:

<i>Years of Service</i>	<i>Percent Vested</i>
Less than two years	0%
Less than three years	20%
Less than four years	40%
Less than five years	60%
Less than six years	80%
Six or more years	100%

In the event of death, permanent disability, or retirement, a participant's employer contribution account becomes fully vested.

### *Forfeited Accounts*

A participant who leaves the Company forfeits any non-vested balance. The Plan uses such forfeitures to first reduce administrative expenses. Any remaining forfeitures will be used to reduce future company contributions. During the 2024 plan year, no forfeitures were used to pay administrative expenses or reduce company contributions. At December 31, 2024 and 2023, there was a balance of \$40,071 and \$38,111, respectively, in the forfeitures account.

### *Notes Receivable from Participants*

Participants may only borrow from their accounts for reasons qualifying as hardships under the Plan. Qualifying participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Loans are repayable over a period of up to five years unless the monies are used for the purchase of a principal residence, which can be up to 30 years. Principal and interest are paid ratably through weekly payroll deductions.

### *Payment of Benefits*

On termination of services due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a certain period, not to extend beyond the life expectancy of the participant or the joint life expectancy of the participant and his or her beneficiary. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution.

### *Contributions Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit sharing contributions are recorded in the relevant period in accordance with the terms in the plan document.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The investments of the Plan are reported at fair value, except the fully-benefit responsive investment contract. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's fully-benefit responsive investment contract with Transamerica Life Insurance Company ("Transamerica") (Note 5) is valued at contract value. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals and expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

### *Subsequent Events*

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

The plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica, a qualified institution, has certified as to the completeness and accuracy of the investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **4. Fair Value Measurement**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following valuation methodologies are used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

### *Pooled Separate Accounts*

The pooled separate accounts are reported at net asset value ("NAV"). The NAV, as provided by the custodian, is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is considered a readily determinable fair value as it is publicly published by the fund administrator and is the basis for current transactions.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation method is appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Investment Contract with Transamerica

The Plan entered into a fully-benefit responsive investment contract with Transamerica. Transamerica maintains the contributions in a group annuity contract. The account is credited with participant contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that adjusts monthly. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan's documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing

investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer. This contract meets the fully-benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

### **6. Related-Party and Party-in-Interest Transactions**

Certain plan investments are in investment contracts and pooled separate accounts managed by Transamerica, who is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their company contributions.

### **8. Tax Status**

The plan sponsor adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan, and the Internal Revenue Service ("IRS") has issued an opinion letter dated June 30, 2020, stating that the plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

## Notes to Financial Statements

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **10. Prohibited Transactions**

The Company determined that certain remittances of employee deferrals for the plan year ended December 31, 2024, were not made timely in accordance with DOL guidelines. Under ERISA regulations, late remittances of plan contributions are considered prohibited transactions. During the year ended December 31, 2024, a total of \$32,168 of employee contributions were remitted to the Plan after the ERISA requirement. To ensure that employee plan contributions are deposited in accordance with ERISA requirements, the Company has reviewed its internal processes and strengthened internal controls around the remittance of employee contributions to the Plan.
