## INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor and Participants  
Parker Oil Company, Inc. 401(k) Plan  
South Hill, Virginia

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Parker Oil Company, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Parker Oil Company, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Parker Oil Company, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Parker Oil Company, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**December 31, 2024**

**1. Plan Description**

The following brief description of the Parker Oil Company, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan documents for more complete information.

The following is a summary of the Plan and its provisions:

*Sponsoring Corporation:* Parker Oil Company, Inc.

*Effective Date:* January 1, 1960

*Anniversary Date:* December 31

*Eligibility:* Any employee who has completed 12 months of service and has attained the age of 21 becomes eligible to participate in the Plan on the next entry date. Effective December 1, 2022, an employee who has completed 6 months of service and has attained the age of 21 becomes eligible to participate in the Plan on the next entry date. Entry date is the first day of each month of the Plan year.

*Compensation:* W-2 wages, including any overtime, commissions, or bonuses, but excluding contributions by the employer to the Plan and all payments made to any health or welfare plan and 401(k) contributions.

*Retirement Benefits:* At the applicable retirement date, each participant shall be entitled to receive his vested interest in his Trust account. Such interest at the election of the participant shall be payable (i) in one sum in cash or (ii) in substantially equal annual installments which do not exceed the life expectancy of the participant or the joint life expectancy of the participant and spouse.

*Payment of Benefits:* Upon termination of service due to death, disability, or retirement, participants or their beneficiaries will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant will receive the value of the vested interest in their account after the participant has incurred a one-year break in service. Terminated participants with account balances of less than \$5,000 will be automatically rolled out of the Plan via a lump-sum distribution. Hardship distributions are permitted from a participant's elective deferral account and balance originating from the Company Stock Account of the ESOP. In-service distributions are permitted for participants who have not separated from service provided they have attained age 60.

*Participant Contributions:* Each year, participants may contribute up to the maximum allowable amount as determined by the Internal Revenue Code (IRC), including deferrals of up to 100% of any bonus. However, total deferrals in any taxable year may not exceed the dollar limit set by law. A participant may make catch-up contributions if they have attained age 50 by the end of the calendar year. Participants are 100% vested in all elective deferrals made to the Plan and any investment earnings on these deferrals.

*Safe Harbor Matching Contributions:* The employer will make a safe harbor matching contribution equal to 100% of the participant's salary deferral that does not exceed 5% of the participant's gross compensation. This contribution is immediately fully vested.

**1. Plan Description - Continued**

*Participant Accounts:* Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Notes Receivable from Participants:* Loans are not permitted under the Plan.

*Death Benefits:* If a participant dies before the normal retirement date, the designated beneficiary would vest 100% in the participant's account as of the valuation date following the date of death. Within 60 days thereafter, the Trustee shall make payment of such vested interest.

*Vesting:* Parker Oil Company, Inc. 401(k) Plan was merged with Parker Oil Company, Inc. Employee Stock Ownership Plan and Trust in 2011. The ESOP component of the Plan was terminated in 2020. Participants are vested immediately in their contributions and balances originating from the Company Stock Account of the ESOP plus actual earnings thereon. Employer contributions, other than safe harbor matching contributions, shall vest in accordance with a participant's years of continuous service with the employer as follows:

Less than 2 years of service	0%
2 years of service	20%
3 years of service	40%
4 years of service	60%
5 years of service	80%
6 or more years of service	100%

*Forfeitures:* The nonvested account of a participant will be forfeited at the time he ceases to be an employee of the Plan sponsor. All forfeitures are allocated as of the last day of the Plan year in which such forfeitures arise and are applied to reduce the earliest employer contribution made after the forfeitures are determined.

**2. Summary of Significant Accounting Policies**

*Basis of Accounting:* The Plan prepares its financial statements on the accrual basis whereby revenue is recognized when earned and expenses are recognized when incurred.

*Investment Valuation:* Investments are valued at quoted market prices, if available. The values of some mutual funds are reported using a unit value giving consideration to the income, cost, and sales comparison approaches of estimating property value. Purchases and sales of units are recorded on valuation dates.

*Administrative Expenses:* All expenses of maintaining the Plan are paid out of the Trust assets. The Company may, however, pay all or any portion of such expenses directly, and payment of expenses by the Company shall not be deemed to be employer contributions.

**2. Summary of Significant Accounting Policies - Continued**

*Forfeitures:* There are no forfeited nonvested accounts at December 31, 2024 or 2023. Funds in these accounts may be used to reduce future employer contributions and fees. No forfeitures were used during the year ending December 31, 2024.

*Benefit Payments:* Benefits are recorded when paid.

*Estimates:* The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Evaluation of Subsequent Events:* Management has evaluated subsequent events through September 3, 2025, which is the date the financial statements were available to be issued.

**3. Certified Investments (Unaudited)**

Certain information related to investments are disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus LLC, an authorized representative of Ascensus Trust Company (the custodian of the Plan):

**4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10-50, "*Fair Value Measurements and Disclosures*", establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or 2 inputs are not available.

Level 1 inputs are based on quoted prices in active markets for identical assets that the Plan has the ability to access at year-end.

Level 2 inputs are based on prices other than quoted prices within Level 1, such as quoted prices for similar assets, which are observable at year-end. There are no Level 2 inputs for the years ended December 31, 2024 or 2023.

Level 3 inputs are unobservable and there is little or no market activity at year-end. There are no Level 3 inputs for the years ended December 31, 2024 or 2023.

**5. Parties-in-Interest**

Clearstead Advisors, LLC (previously known as Wilbanks, Smith & Thomas Asset Management, LLC) manages Plan investments. Clearstead Advisors, LLC is a service provider of the Plan; therefore, transactions qualify as party-in-interest transactions. Fees paid to this service provider by the Plan totaled \$33,553 for the year ended December 31, 2024.

WellsColeman performs the audit for the Plan. WellsColeman is a service provider of the Plan; therefore, transactions qualify as party-in-interest transactions. Fees were paid by the Plan sponsor for the year ended December 31, 2024.

The Vanguard Group, Inc. ("Vanguard") is the recordkeeper of the Plan. Vanguard is a service provider of the Plan; therefore, transactions qualify as party-in-interest transactions. Fees paid to this service provider by the Plan totaled \$3,643 for the year ended December 31, 2024.

Ascensus Trust Company ("Ascensus") is the custodian of the Plan. Ascensus is a service provider of the Plan; therefore, transactions qualify as party-in-interest transactions. Fees were paid by the Plan sponsor for the year ended December 31, 2024.

Blue Ridge ESOP Associates manages the Plan administration. Blue Ridge is a service provider of the Plan; therefore, transactions qualify as party-in-interest transactions. Fees paid to this service provider by the Plan totaled \$2,340 for the year ended December 31, 2024.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. Tax Status**

The Plan obtained its latest determination letter on September 18, 2013, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and Plan sponsor believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
