## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Triangle Insurance Company, Inc. Co-op 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **Note 1: Plan Description**

The following description of the Triangle Insurance Company, Inc. Co-op 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan is a contributory, defined contribution plan covering substantially all employees of Triangle Insurance Company, Inc. (the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility.** Employees are eligible to participate and may begin receiving matching contributions and making salary deferral contributions to the plan upon attainment of age 21 and completion of 180 consecutive days of service. Plan entry dates are on the first day of each calendar month.

**Contributions.** Participants may contribute between 1% and 50% of their pretax and/or after-tax (Roth contributions) compensation annually. The maximum combined limit for pretax and Roth contributions is 50%. Participants may change their contribution percentages at any time, with the changes becoming effective as of the next payroll period.

The Sponsor makes matching contributions equal to 100% of the first 5% that each participant contributes to the Plan. The Sponsor may also make discretionary profit-sharing contributions to the Plan, as determined annually.

**Participant Accounts.** Each participant's account is credited with the participant's contributions, the related Sponsor matching contributions and any profit-sharing contributions, as well as the investment earnings or losses thereon, and allocations of any administrative expenses. Sponsor profit sharing contributions, if any, are allocated pro rata based on participant compensation.

**Vesting.** Participants are always vested in their accounts, including their contributions and Sponsor contributions made on their behalf, along with any earnings thereon.

**Notes Receivable from Participants.** Participants can borrow from their individual account limited to the lesser of \$50,000 or 50% of the participant's vested account balance, with a minimum of \$1,000. A participant may not have more than one loan outstanding at any time. Loans are repaid through payroll deductions and are credited to the participant's accounts with interest at a rate of prime plus 1%, as published in the *Wall Street Journal* on the day the loan is requested.

Participants are also allowed in-service withdrawals in instances of financial hardship, as defined by the Plan, requiring approval by the Plan administrator.

**Payment of Benefits.** Upon retirement, death, disability, or termination of employment, the vested benefits, as defined, are paid to the participant or their beneficiaries, either in a lump sum or other mode of settlement.

**Amendment or Termination.** Although they have no intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA.

**Note 2: Summary of Significant Accounting Policies**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), including specialized industry practices as specified in the American Institute of Certified Public Accountants audit and accounting guide titled Audits of Employee Benefit Plans.

**Note 2: Summary of Significant Accounting Policies (continued)**

**Use of Estimates.** Financial statements prepared in conformity with GAAP require management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Values.** Investments are stated at fair value. Shares of mutual funds and money market funds are valued at the net asset value of shares held by the Plan at year end. Dividends are recorded on the ex-dividend date.

**Administrative Costs.** Certain administrative services and the use of office fixtures and equipment are provided to the Plan by the Sponsor, with no provision for these costs included in the accompanying financial statements. These costs were not significant for the years ended December 31, 2024 and 2023. All other administrative expenses are recognized when incurred.

**Prohibited Transactions.** A “party-in-interest” is a fiduciary or employee of the Plan, any person who provides services to the Plan, the Sponsor or an employee association whose members are covered by the Plan, a person who owns 50 percent or more of the Sponsor or such employee association or relatives of such person just listed. Under ERISA, a Plan fiduciary is prohibited from causing the Plan to engage in the following transactions with a party-in-interest, with certain conditional exemptions provided by ERISA:

- A sale, exchange, or lease of property;
- A loan or other extension of credit;
- The furnishing of goods, services, or facilities;
- A transfer of plan assets to a party-in-interest for the use or benefit of a party-in-interest; or
- An acquisition of employer securities or real property.

A fiduciary is also generally prohibited from using the Plan’s assets for his or her own interest or account, acting in any Plan transactions on behalf of a party whose interests are adverse to those of the Plan or its participants and receiving consideration for his or her own account from a party dealing with the Plan in connection with a transaction involving the Plan’s assets.

The Plan did not engage in any prohibited transactions for the years ended December 31, 2024 and 2023.

**Income Tax Status.** The Internal Revenue Service (IRS) has issued an opinion letter determining that the non-standardized profit-sharing plan and trust is acceptable under Section 401(a) of the Internal Revenue Code (the Code). It is not a ruling or determination as to whether the Plan itself is qualified; however, an employer adopting this plan will be considered to have a qualified plan. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Although the Plan has been amended since receiving the opinion, the Plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable authorities. There are currently no audits for any tax periods in progress. Generally, the Plan’s tax returns are subject to examination for three years after they are filed.

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

**Note 5: Reconciliation of Financial Statements to Form 5500**

The Form 5500 is a joint-agency form, developed by the IRS, the U.S. Department of Labor, and the Pension Benefit Guaranty Corporation, which may be used to satisfy the annual reporting requirements of the Code and Titles I and IV of ERISA. The Plan is required to file a Form 5500 annually, with audited financial statements enclosed. There were no reconciling items between the Form 5500 and the accompanying financial statements for the years ended December 31, 2024 and 2023.

**Note 6: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7: Subsequent Events Evaluation**

Management has evaluated subsequent events through August 11, 2025, the date which the financial statements were available to be issued. No material subsequent events have occurred during this time which would require recognition in the financial statements or footnotes as of and for the year ended December 31, 2024.
