## 1. Description of Plan

The following description of the 3V Sigma USA Inc. Profit Sharing/401(k) Plan (the “Plan”) provides only general information. Participants may refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan, which provides retirement benefits to full-time employees of 3V Sigma USA Inc. and 3V Tech USA, Inc. (collectively the “Company”) who meet the eligibility requirements of the Plan as described below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### Contributions

Participants may contribute any percentage greater than or equal to 1% of their pretax compensation to the 401(k) portion of their account and any percentage greater than or equal to 1% of their after-tax compensation to the ROTH 401(k) portion of their account within the Plan, subject to contribution limitations specified by applicable laws and regulations. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions, up to the maximum annual amount permitted by statute. Participants may also contribute amounts representing distributions from other qualified employee benefit plans and individual retirement accounts. Participants who do not choose a specific deferral rate are automatically enrolled into the Plan at a deferral rate of 3% of their pretax compensation, unless they opt for a different deferral rate.

The Company's contributions to the Plan are discretionary and are funded in the year subsequent to the Plan year for which contributions are made. For the years ended December 31, 2024 and 2023, the Company elected to contribute an amount equal to 50% of each participant's deferral up to the first 6% of eligible compensation, as defined by the Plan.

### Participant Accounts

Each participant's account is credited with the participant's elective deferral contributions, an allocation of the Company's discretionary contributions, if any, and an allocation of Plan earnings or losses. Participants' accounts are charged with an allocation of administrative expenses incurred by the Plan. Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Eligibility

The Company's employees are eligible to participate in the Plan and make contributions on the date they begin employment. Participants are eligible to receive employer contributions on the first day of each calendar month of the Plan year after completing six months of service and attaining 20 years of age. In order to receive employer contributions, Plan participants must be employed on the last day of the Plan year.

**Participant Loans**

Participant loans are not permitted under this Plan.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts is based on the following schedule:

**Investment Options**

The Plan allows individual participants, upon enrollment, to self-direct their accounts by investing in one or more of the mutual funds and money market fund selected by the Plan administrator. Participants should refer to investment provider information for a detailed description of the Plan's investment options.

**Distribution of Benefits**

Upon termination of service due to death, disability or retirement, a participant may elect to receive, dependent on the participant's marital status, either a lump sum amount equal to the value of the participant's vested interest in his or her account, annual installments, a joint and survivor annuity, or a life annuity.

**Forfeited Accounts**

Forfeitures are retained in the Plan and may be used to reduce future employer contributions. Employer contributions were not reduced during the years ended December 31, 2024 and 2023, from forfeited non-vested accounts. There were no unallocated forfeited non-vested accounts at December 31, 2024 and 2023.

## **2. Basis of Presentation and Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("GAAP").

### **Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the Plan year. The net appreciation/depreciation in fair value of investments represents (1) the difference between the fair value of the investments held at year-end and either the fair value at the end of the preceding year or the actual cost if purchased later, and (2) realized gains or losses on sales of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received.

### **Risks and Uncertainties**

The Plan may invest in investment securities that are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that these changes could materially affect the amounts reported in the 2024 statement of net assets available for plan benefits.

### **Administrative Expenses**

The Plan paid approximately \$60,000 and \$63,000, annually, for custodian, recordkeeping, and certain professional fees during the years ended December 31, 2024 and 2023, respectively. The Company pays for certain other professional fees. These transactions qualify as party-in-interest transactions but are exempt from the prohibited transaction rules of ERISA.

### **3. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for plan benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs to the valuation methodology are unobservable. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. All of the Plan's investments are considered Level 1 assets.

Realized and unrealized gains and losses, which are included in the changes in net assets available for plan benefits, are reported in the net appreciation in fair value of investments.

### **4. Certified Information**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, net appreciation in fair value of investments, and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Matrix Trust Company, LLC (the custodian of the Plan).

### **5. Filing Status**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified at December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.
