Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fremont Beef Company Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. Description of Plan

The following description of the Fremont Beef Company Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of its provisions.

- A. General. Effective January 1, 2023, the Plan was amended to include Aurora Packing Company as a participating employer. The Plan is a defined contribution plan covering all employees of Fremont Beef Company and the non-bargaining employees of Aurora Packing Company, who have achieved six months of service. Fremont Beef Company and Aurora Packing Company are collectively referred to as the “Company” or “Employer”. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions. Participants may contribute a percentage of their annual pay, as defined in the Plan, not to exceed limitations set by the Internal Revenue Service, through either pre-tax or after-tax Roth contributions. Participants aged fifty and older by the end of the calendar year may contribute catch-up contributions. Participants may also contribute rollover contributions from other qualified plans. The plan operates under a Qualified Automatic Contribution Arrangement. This arrangement requires the following:
- Eligible participants will have an automatic and minimum salary deferral of 3% with automatic increases of 1% annually up until the participant defers 6% unless they affirmatively elect not to participate in the Plan.
 - The Company will match participant deferrals by 100% of the first 1% of deferrals, and 50% of the next 5% of deferrals.

Participants direct the investment of their contributions and company matching contributions into various investment options offered by the Plan.

- C. Participant Accounts. Each participant account is credited with the participant’s contribution and the Company matching contributions, Plan earnings or losses, and is charged with an allocation of administrative expenses. Plan earnings or losses and administrative expenses are allocated based on each individual participant account balances to the total Plan balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. Vesting. Participants are immediately vested in their individual contributions and related earnings or losses. Employer matching contributions will vest with the employee 50% after one year of service and 100% after two years of service, so a participant is fully vested after two years of credited service as defined by the Plan.

1. Description of Plan – Continued

- E. Notes Receivable from Participants. Participants may borrow a minimum of \$1,000 up to a maximum equal to fifty percent of their vested account balance or \$50,000, whichever is less. Loan terms range from one to five years. The balance in the participant's account secures the loans. Principal and interest are paid ratably through payroll deductions and bear interest ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the trustee.
- F. Payment of Benefits. On separation of service, if the vested account is greater than \$5,000, the participant or beneficiary may elect to receive either a lump-sum payment or various forms of annuity payments, as defined in the Plan. The duration of installments may not exceed the participant's life expectancy or the joint life and last survivor expectancy of the participant and his designated beneficiary. Vested accounts of less than \$5,000 are paid in a lump-sum distribution upon separation of service.
- G. Forfeited Accounts. Forfeited balances of non-vested accounts are used to either pay Plan administrative expenses or reduce future Company contributions. There were no significant forfeiture balances outstanding as of December 31, 2024 and 2023 or used during 2024 and 2023.

2. Summary of Accounting Policies and Procedures

- A. Basis of Accounting. The financial statements are prepared on the accrual basis of accounting.
- B. Investment Valuation and Income Recognition. Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- C. Payment of Benefits. Benefits are recorded when paid.
- D. Use of Estimates. The preparation of financial statement in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

- E. Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.
- F. Administrative Expenses. Certain expenses of maintaining the Plan are paid by the Plan, except the Plan Sponsor, at its discretion, may pay certain administrative costs. Costs directly related to notes receivable from participants are charged to the borrowers' account. Investment related expenses are included in net appreciation of the fair value of investments.
- G. Subsequent Events. Management evaluated transactions and events occurring through September 5, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

3. Investments

Investments disclosed in the financial statements and supplemental schedule at December 31, 2024 and 2023, were obtained or derived from information supplied by the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust (CT): Valued at NAV, based upon the market value of underlying investments, which may include separate accounts, equities, preferred stock, bonds, real estate, mutual funds, investment contracts, and security-backed contracts. The CT NAV is provided by the sponsor, Great Gray Trust Company, LLC, and is not a publicly quoted price in an active market.

5. Group Annuity Contract with Great-West Life & Annuity Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West totaling \$194,813 and \$47,863 as of December 31, 2024 and 2023, respectively. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 and 2023 is 1.42% and 1.23%, respectively. The guaranteed investment contract allows the Plan sponsor or Great-West to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) Plan sponsor events (for example, sale, merger, divestitures, or spin-offs) that cause a significant withdrawal from the Plan, or (4) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Related Party Transactions

Plan investments are managed by Great-West and Empower. The Plan made direct payments of approximately \$25,800 and \$24,100 to Great-West in 2024 and 2023, respectively. These transactions, therefore, are party-in-interest transactions.

7. Plan Termination

The Company has the right to reduce, suspend, or discontinue its contributions at any time. Although it has not expressed any intent to do so, the Company could terminate the Plan subject to the provisions of ERISA. In the event of termination, participants become 100% vested in their accounts.

8. Tax Status

The Plan is a pre-approved non-standardized plan adopted by the Company on January 1, 2022. On June 30, 2020, the Internal Revenue Service stated this pre-approved plan adopted by the Company, as then designed, qualifies under Section 401(a) of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan. Although the Plan has been amended since receiving the advisory opinion, the Plan administrator believes the plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by tax authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan provides for investment options which are exposed to interest rate, market and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the value of investments will occur, and such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

10. Assets Transferred from Another Plan

On October 2, 2024, \$2,000,854 was transferred in from Aurora Packing Company, Inc. 401(k) Plan. The Aurora Packing Company, Inc. 401(k) Plan was for employees of Aurora Packing Company, Inc., which is a subsidiary of SFA, Inc., the parent company of Fremont Beef Company, Inc. This transfer was made as a result of the merger of the Aurora Packing Company, Inc. 401(k) Plan and the Fremont Beef Retirement Savings Plan. The assets transferred were measured at fair value on the date of the transfer was between related parties under common control.
