#### **NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### ***Basis of Accounting***

The financial statements are prepared on the accrual basis of accounting.

##### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation or depreciation in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan provides for various investment options in a combination of various funds. These investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of those investments, it is at least reasonably possible that changes in the values of investments in the near term would materially affect participants' account balances and the amounts report in the Statements of Net Assets Available for Benefits and the Statement of Changes in the Net Assets Available for Benefits.

##### ***Payments of Benefits***

Benefits are recorded upon distribution.

##### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the Plan's financial statements and related notes. Actual results could differ from those estimates.

##### ***Subsequent Events***

In preparing its financial statements Gardens Alive 401(k) Salary Savings Plan has evaluated events subsequent to the date of the statement of net assets available for benefits through September 8, 2025, which is the date the financial statements were available to be issued.

#### **NOTE 2 DESCRIPTION OF THE PLAN**

##### ***General***

The following description of the Gardens Alive 401(k) Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description.

The Plan is a defined contribution plan covering all employees, with the exception of those covered by collective bargaining agreements or non-resident aliens, of Gardens Alive, Inc., Rostam Direct, LLC, Melville Direct LLC, Paragon RI LLC, Steinbeck, LLC, Early Morning LLC, and WOW Grapes LLC (collectively, the Company) who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Committee, which is composed of members of the Company's management, is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### ***Contributions***

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). Section 414(v) of the Internal Revenue Code of 1986 as amended allows a maximum catch-up contribution of \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes a Roth feature whereby participants are able to pay taxes on qualifying contributions when made.

The Company contributes 100% of the first 3% of eligible compensation that a participant contributes to the Plan, plus 50% of elective deferrals between 3% and 5% of eligible compensation, with participant compensation and contributions being measured on an annual basis. Additional discretionary profit sharing contributions may be contributed at the option of the Company's Board of Directors and are allocated to participant's accounts based on the participant's annual earnings. For the years ended December 31, 2024, and 2023, there were no discretionary contributions to the Plan. Participants direct the investment of the Company's contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting and Forfeitures*

Participants are immediately vested in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions is based on years of credited service. Participants vest in the Company's discretionary profit sharing contributions and actual earnings thereon as follows:

A participant also becomes 100% vested if the Plan is terminated, the participant reaches age 59 ½ while employed, or the participant dies or becomes disabled.

##### *Administration*

The Plan is administered by certain members of the Company's management. Expenses incurred in the administration of the Plan are paid by the Plan to the extent they are not paid by the Company.

##### *Withdrawals and Benefits*

Upon death, disability, retirement, or termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants who have attained age 59 ½ are permitted to make in-service withdrawals of the portion of their account attributable to the Company's discretionary profit sharing contributions. Participants may withdraw all or part of their vested account balance if financial hardship exists, subject to the limitations of the Plan and the Internal Revenue Code.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,687 and \$11,138, respectively. These amounts will be used to offset administrative expenses or reduce future employer contributions. In 2024, \$1,785 of administrative expenses were reduced from forfeited nonvested accounts.

##### *Termination*

The Company anticipates that the Plan will continue without interruption, but it reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

##### *Reclassifications*

Certain amounts in the 2023 financial statements have been reclassified for comparative purposes to conform to the 2024 presentation.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Applicable GAAP (Generally Accepted Accounting Practices) for Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the applicable GAAP for Fair Value Measurements and Disclosures are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. (Mutual funds, common stocks, corporate bonds, US government securities, etc.)

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

*Mutual funds:* Valued at the quoted closing net asset values of the funds on the last day of the Plan fiscal year.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 5 RELATED-PARTY TRANSACTIONS**

Plan investments are held in a Trust exclusively managed by Empower Trust Company. Empower Trust Company is the trustee and record keeper as defined by the Plan, and therefore these transactions qualify as party-in-interest.

Certain Plan expenses were paid by the Company. The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it is not compensated.

#### **NOTE 6 TAX STATUS OF THE PLAN**

The Plan Sponsor has adopted the prototype plan which has received an opinion letter from the Internal Revenue Service dated November 14, 2022, which states that the provider's prototype, as designed, is in compliance with the applicable requirement of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. There are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is not currently under audit by any taxing jurisdictions. The Plan's tax returns are subject to review and examination by Federal authorities.

#### **NOTE 7 GUARANTEED INVESTMENT CONTRACT**

The Plan entered into a benefit-responsive investment contract with Empower Annuity Insurance Company of America ("Empower"). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed contract ("GIC") issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is considered to be fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) transfers to the fixed account from other plan sources greater than permitted, (2) competing investment options or deletion of equity wash provisions, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at the contract value with participants, is probable.
