**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Rainbo Oil Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rainbo Oil Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

NOTE 1—DESCRIPTION OF PLAN

The following description of the Rainbo Oil Co. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan, permitting contributions for all employees of the Rainbo Oil Company (the Company), who are age 21 or older and have completed 3 months of service. Employees of MF Enterprises, P&K Enterprises, ROC, Inc., Erthal Oil, Plymouth Lubricants, and Industrial Fluid Solutions are also eligible to participate in the Plan. Employees of MW Lubricants LLC became eligible employee as of May 11, 2023. Participants are eligible to participate for purpose of elective deferral on the first day of the month following or coincident with the date of satisfaction of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2024 the Plan implemented SECURE Act and SECURE 2.0 Act provisions including updating the dollar limit for mandatory distributions (\$5,000 to \$7,000) and plan eligibility for long-term part-time employees.

*Contributions.* Participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who do not return an election form that opts out of the Plan or otherwise states how much they would like to defer will be auto-enrolled into the Plan at a 3% deferral rate after becoming eligible. The Company makes safe harbor contributions in the amount 100% of participant's elective deferrals not to exceed 3% of the participants compensation, plus 50% of each participant's elective deferral in excess of 3% but not in excess of 5% of the participant's compensation. The Company may elect to make discretionary matching contributions based on participant deferrals. The Company may also elect to make non-elective contributions using a four-tiered permitted disparity allocation formula. The Company elected not to make any discretionary matching or non-elective contributions for the year ended December 31, 2024.

*Participant Accounts.* Each participant's account is credited with participant contributions and Company matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from each participant's vested account.

*Vesting.* Participants are immediately vested in their contributions as well as safe harbor contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in those accounts after 6 years.

*Forfeited Accounts.* At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$755 and \$887, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. In 2024, expenses of \$1,665 were paid from forfeited nonvested accounts.

*Notes Receivable from Participants.* Participants may borrow from their accounts an amount equal to the lesser of \$50,000 or 50% of the present value of their vested account balance (and a minimum of \$1,000). A participant may have no more than three loans outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

*Payment of Benefits.* On termination of service due to death, disability, or retirement, participants with an account balance greater than \$7,000 may elect to receive either a lump-sum amount equal to the value of his or her account or monthly, quarterly, or annual installments over a fixed reasonable period of time. Under the default automatic rollover provisions, distributions less than \$7,000 will be made to an Individual Retirement Account (IRA) without participant consent, if a participant does not make a different distribution election after receiving the required notification.

*Hardship Withdrawals.* Participants may elect to withdraw all or a portion of their vested balance if they incur a financial hardship. Participants may also withdraw match funds after 60 months of participation if the funds are 100% vested. The amount is limited to that necessary to meet the financial need. A hardship is any one of the following: deductible medical expenses or cost of post-secondary education tuition, room and board, and related educational fees for the participant, spouse, or dependents, the purchase (excluding mortgage payments) of a participant residence for the participant, burial or funeral expenses for the participant, spouse, or dependents, payment of expenses for the repair of damage to a principal residence that would qualify for the casualty deduction under Code 165, or payment needed to prevent eviction of the participant from his principal residence.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions Receivable**

The Plan uses the ERISA definition of plan assets to determine whether an accrual should be made for employee or the related employer contributions receivable based on when amounts have been withheld from employee compensation. A defined contribution plan can elect to recognize the employee and the related employer matching contribution either (1) in the period related to the participant's service or compensation (even if not yet withheld), or (2) in the period the employee contribution is withheld if the policy is applied on a consistent basis.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023 and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's board of trustees determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments to participants or beneficiaries are recorded when paid. There were no requested distributions that were not paid out by December 31, 2024.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. For 2024, the expenses paid by the Plan include recordkeeping fees, investment management service fees, custodial fees, and distribution fees. All those fees are charged directly to the participant's account and are included in administrative expenses.

**Date of Management's Review**

The Plan has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued

**NOTE 3—FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

*Level 1 Fair Value Measurements*

*Mutual funds and Money Market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. NOTE 5—TAX STATUS

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.
