The sum of Cash Balance Credits and Earnings Credits. As of November 30, 2024, Cash Balance Accounts, excluding Cash Balance Credits for the year, totaled \$884,209.

**CASH BALANCE CREDITS**

Cash Balance Credits shall be credited to eligible participants' Cash Balance Accounts for the year, based on the plan document's provisions. For the 2023 plan year, Cash Balance Credits totaled \$0.

**EARNINGS CREDITS**

Earnings Credits shall be credited to participants' Cash Balance Accounts based on the September 30-year Treasury rate.

**NORMAL RETIREMENT AGE**

The attainment of age 62.

**BENEFIT AMOUNT**

The Cash Balance Account, or its actuarial equivalent payable as an annuity, subject to IRS maximums. Benefits are payable immediately following termination of employment or while in service for participants who have reached age 62.

**VESTING**

Each participant is 100% vested in his or her Cash Balance Account upon completion of three years of service, attainment of Normal Retirement Age, disability, or death.

**STATUTORY LIMITS**

For 2023, the maximum compensation limit under IRC section 401(a)(17) is \$330,000, and the maximum benefit payable under IRC section 415(b) is \$265,000.
