Note 1 - Description of the Plan

The following brief description of the Carrabbas 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Mangia Beve, Inc. dba Carrabbas and its wholly-owned subsidiaries (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on July 1, 2000, and has since been amended and restated.

Plan Administration

Mr. Johnny C. Carrabba, III serves as the trustee for the Plan. An employee of the Company is appointed to serve as the plan administrator. Effective December 15, 2024, Ascensus Trust Company (Ascensus) serves as the Plan's asset custodian and the Plan entered into a recordkeeping agreement with Vanguard Group, Inc. (VGI), whereby VGI has subcontracted with Ascensus, LLC, an agent of Ascensus Trust Company, to provide the recordkeeping for the Plan.

Prior to December 15, 2024, American Trust Company served as the Plan's asset custodian and AT Retirement Services, LLC provided recordkeeping services.

Eligibility

The Plan is provided for all eligible employees of the Company. All employees aged 21 and older, with the exception of nonresident aliens and employees covered by a collective bargaining agreement, may participate in the Plan on the first day of each plan quarter coinciding with or following the date on which the employee has completed three months of service. The Plan includes a savings feature designed to permit the employee and the Company to contribute to the Plan at amounts allowable under Section 401(k) of the Internal Revenue Code (IRC).

Contributions

Upon satisfying the eligibility requirements, participants may defer up to 100% of their compensation, as defined, on a pre-tax basis and/or as Roth contributions, subject to amounts allowed under the IRC. In addition, eligible employees who have attained age 50 prior to the close of the plan year are eligible to make catch-up contributions subject to the limitations under the IRC.

The Company makes safe harbor matching contributions each pay period equal to 100% of each participant's contributions up to 3% of eligible compensation, as defined, plus 50% of each participant's contributions between 3% and 5% of the participant's eligible compensation.

Effective December 15, 2024, the Plan was amended to eliminate discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Vesting

Participants are fully vested at all times in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon.

Forfeitures

Forfeitures may be used to pay administrative expenses of the Plan and/or to reduce employer contributions. The balance in the forfeiture account was \$14,540 and \$17,137 at December 31, 2024 and 2023, respectively. Forfeitures totaling \$2,597 were utilized to pay administrative expenses or reduce employer contributions during 2024.

Participant Accounts

Upon enrollment in the Plan, a participant may direct the asset custodian with regard to the investment of his or her account balances into various investment options offered by the Plan. Participants may change their investment options daily.

Separate accounts are maintained for each participant. Earnings and losses are allocated daily to the participants' accounts according to an allocation formula provided in the plan document.

Benefit Payments

Distributions may be made to participants or their beneficiaries, as applicable, upon termination of employment, retirement, disability or death. Withdrawals may be made by active participants who have attained the normal retirement age of 65, or due to financial hardship, subject to the provisions of the plan document. In-service distributions are permitted after attainment of age 59½. Upon termination, participants with an account balance of \$1,000 or less receive an automatic lump sum distribution from the Plan. For participants with an account balance greater than \$1,000 but less than \$7,000, the plan administrator makes a direct rollover into an individual retirement account. For participants who terminate with an account balance of more than \$7,000, the plan administrator must obtain written consent from the participant prior to processing a distribution. Upon withdrawal from the Plan or termination of employment, participants may be subject to federal income tax on contributions and income earned.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains and losses on investments sold during the year as well as unrealized gains or losses on investments held at the end of the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Fees and expenses incurred in the administration of the Plan, to the extent not paid by the Company at its discretion, are paid by the Plan.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investment in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the financial statements.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 10, 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by the Plan's Asset Custodians

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Ascensus, LLC, on behalf of Ascensus Trust Company as of December 31, 2024, and for the period from December 15, 2024, through December 31, 2024, and from American Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that all of the information provided is complete and accurate. Information included in the financial statements and the accompanying notes to the financial statements as to investments, investment income and all information in the supplemental schedule of assets (held at end of year), is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-Bearing Cash and Mutual Funds: These funds are valued daily, based on their quoted market prices.

Common/Collective Trust Fund: This fund is valued at its net asset value (NAV) as determined by the issuer, based on the value of each of the underlying investments, less applicable fees charged by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

Note 5 - Federal Income Tax

Prior to December 15, 2024, the Plan operated under a pre-approved plan document that received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. Effective December 15, 2024, the Plan was amended and restated via its adoption of another standard pre-approved plan. This pre-approved plan received an opinion letter from the IRS dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan has been amended since receiving the IRS letter; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any employer discretionary profit-sharing contributions.

Note 7 - Party-in-Interest Transactions

Certain mutual funds offered by the Plan are issued by VGI, a party-in-interest with respect to the Plan. Certain plan investments are held in interest-bearing accounts managed by Ascensus Trust Company, the Plan's asset custodian. Transactions involving these investments are covered by an exemption from the "prohibited transactions" provisions of ERISA and the IRC.
