We are required to be independent of Dudek Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Dudek Employee Stock Ownership Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Dudek Employee Stock Ownership Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Schedule Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1 – The Plan and Its Significant Accounting Policies

**General** – The following description of the Dudek Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a nonparticipant directed employee stock ownership plan that was established on January 1, 2003, by DUDEK (the Company) to provide benefits to eligible employees including its subsidiary companies, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In September 2021, the Plan acquired 98,110 shares of the outstanding common stock of the Company. The purchase was funded by an inside loan from the Company of approximately \$14,746,000, transfers of approximately \$3,366,000 from the Company 401(k) Plan, and approximately \$2,000,000 in cash held by the Employee Stock Ownership Plan (ESOP). As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible participants' accounts in accordance with applicable regulations under the Code.

The borrowings are collateralized by the unallocated shares of common stock and are guaranteed by the Company. The note holders have no rights against the shares of common stock once they are allocated under the Plan. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, separately presents the assets and liabilities, and changes therein, pertaining to:

- a. the accounts of participants with rights in allocated common stock (allocated), and
- b. common stock not yet allocated to participants (unallocated), including shares that are committed to be released.

Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Approximately \$790,000 was transferred from the Plan to the Dudek 401(k) Plan during 2024. This transfer relates to participants who were no longer eligible to be participants in the Plan due to their termination and subsequent accounts were transferred to the Dudek 401(k) Plan.

**Administration** – Under the terms of the Plan, the Board of Directors (the Board) of the Company has appointed an external trustee to control the operation, administration, and investment direction of the Plan. The external trustee has contracted with Charles Schwab (Schwab) to act as the Plan's custodian. A third-party administrator, appointed by the Board, processes and maintains the records of participant data. Expenses incurred for administering the Plan are paid by the Plan to the extent they are not paid by the Company.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with GAAP.

**Forfeited accounts** – Nonvested accounts of terminated employees are allocated to eligible participants annually. The Plan allows for terminated employee accounts to be reinstated if the employee participant is rehired within a five-year consecutive period from the last date of termination. The company tracks the accounts of terminated employees for five consecutive years before forfeiture.

**Investment valuation and income recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Investment dividends are recorded on the ex-dividend date, and dividends on Company stock are recorded on the date declared. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

**Income taxes** – The Plan has been restated since receiving its latest favorable determination letter dated February 24, 2014. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Risks and uncertainties** – The Plan provides for various investment options in any combination of investment securities offered by the Plan. In addition, Company common stock is included in the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, credit risks, future cash flow for the Company, and industry factors. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Subsequent events** – The Plan has evaluated subsequent events through August 26, 2025, which is the date the financial statements were available to be issued.

### Note 2 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

**Level 1** – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

**Level 2** – Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly;

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Company common stock* – Valued by an annual independent appraisal utilizing income and market-based approaches. Specifically, the guideline public-company method and discounted cash-flow method were used. Final valuation gives equal weight to each of the two methods.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Bank sweep account – interest-bearing* – Valued at fair value as reported to the Plan by Schwab, represents deposits made into the account, plus interest, less withdrawals and administrative expenses.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 3 – Participation and Benefits

**Employer contributions** – Contributions to the Plan are made by the Company as determined by the Board. Contributions can be made in cash, Company common stock, or other property. The Company made a total contribution of approximately \$3,394,000 for the year ended December 31, 2024.

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after completing 1,000 hours of service. Entry into the Plan will occur on January 1, or July 1, upon satisfaction of the minimum age requirement and service requirements. Employees that are part of a collective bargaining agreement cannot participate in the Plan. Leased employees also cannot participate in the Plan. A participant will share in the current plan year allocation of plan contributions only if the participant is still employed on the last day of the plan year and has accumulated 1,000 or more hours of service during the year.

**Vesting** – Participants are fully vested in the employer contributions allocated to their account after five years of credited service.

**Participant accounts** – Each participant's share of plan assets is recorded in two accounts: (a) the Company stock account, which generally represents the participant's allocable portion of the Company common stock included in plan assets, and (b) the other investment account, which generally represents the participant's share of investments other than Company common stock, net income or loss of the Trust, or cash dividends, if any, Company contributions, and forfeitures in other than Company common stock.

Each participant's account is credited with an allocation of: (a) the Company's contribution, if any, (b) an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts, and (c) unrealized appreciation in the value of the Plan's investments. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation of Company contributions and shares released. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

**Put option** – The Company stock that is held by the Plan and its participants is not readily tradable on an established market, or is subject to trading limitations, and includes a put option upon distribution. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Payment of benefits** – Distributions are made in cash or stock to plan participants or their beneficiaries upon termination, retirement, permanent disability, or death. In the event of the termination of a participant's employment by reason of retirement, death, or permanent disability, a participant's benefits will be distributed not later than five years after the close of the plan year. The Plan allows for the automatic lump-sum distribution of participant vested account balances that do not exceed \$1,000.

**Diversification** – Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account over a six-year period. In each of the first five years, a participant may diversify by withdrawing up to 25% of the balance of their Company Stock Account, less amounts previously withdrawn. In the sixth year, the withdrawal percentage increases to 50%. Participants who elect to diversify will receive a cash distribution.

**Voting rights** – Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interests of plan participants and beneficiaries.

### Note 4 – Related-Party Investments and Notes Payable

The value of the Plan's investment in Company common stock is determined by an independent appraisal, in the absence of readily ascertainable market values, and was as follows at December 31:

In September 2021, the Plan acquired 98,110 shares of the outstanding common stock of the Company. The purchase was funded by an inside loan from the Company of approximately \$14,746,000 to purchase 71,984 shares of Company stock, transfers of approximately \$3,366,000 from the Company 401(k) Plan based on participant elections to purchase 16,420 shares of Company stock, and approximately \$2,000,000 in cash held by the ESOP, a portion of which was still accrued for as a liability of approximately \$516,000 at December 31, 2021, to purchase 9,706 shares of Company stock. The inside loan bears interest at 2.07% and is payable in twenty annual installments of approximately \$895,000. Two loan payments of principal and interest were made to the Plan in 2024 totaling approximately \$1,789,000.

One of the Plan investments (bank sweep account – interest-bearing) is held by Schwab, the custodian of the Plan. Any transactions in this account, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### **Note 5 – Plan Termination or Modification**

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of the Board. Upon termination of the Plan, the Board of Directors directs the Trustee to pay all liabilities and expenses of the Plan and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code.

### **Note 6 – Reconciliation to Form 5500**

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
