## INDEPENDENT AUDITORS' REPORT

To the Participants and Board of Trustees of  
AMSCO Windows 401(k) and Profit-Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be

independent of AMSCO Windows 401(k) and Profit-Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about AMSCO Windows 401(k) and Profit-Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about AMSCO Windows 401(k) and Profit-Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



#### 1. Description of Plan

---

The following description of the AMSCO Windows (Company) 401(k) and Profit-Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all full-time employees of the Company who have three months of service and are age eighteen or older and part-time employees who have completed 1,000 hours of service in any given year and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participant accounts** - Each participant's account is credited with the participant's contribution and Company match contributions, as well as allocations of plan earnings and forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Contributions** - All eligible employees may make elective deferral contributions, up to 90 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make an election to match contributions on employee elective deferral contributions. For the plan year December 31, 2024, the Company matched 5%. Contributions for profit sharing into the Plan are completely discretionary. The Company will decide each year, to what extent, if any, it will contribute to the Plan. An eligible participant must be employed on the last day of the Plan year to receive a contribution.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance and need a minimum vested balance of \$2,000. A participant can only have one loan outstanding from the Plan at any given time. The loans are secured by the balance in the participant's account and bear interest at the prime rate as listed at the end of the month. Principal and interest is paid ratably through bi-weekly payroll deductions. Repayment terms are determined by the participant but may not be greater than five years unless the loan qualifies as a home loan. All loan applications are charged a fee of \$75 for loan processing and \$12 quarterly for loan maintenance.

**Vesting** - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service with zero percent vested until the third year of service.

**Payment of benefits** - On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

#### 2. Significant Accounting Policies

---

**Basis of accounting** - The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** – Investments at fair value consist of investments in registered investment companies (mutual funds), pooled separate accounts, and common collective trusts. Investments in Pooled Separate accounts are measured at net asset value of shares held by the Plan at year-end, which has a readily determinable fair value. Common collective trusts are measured at the net unit value, which is based on the fair value of the underlying assets of the account. See Note 12 for discussion of fair value measurements.

Investments at contract value consist of investments in a guaranteed investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to full benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the ex-dividend date on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

**Corrective benefits payable** – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded a liability with corresponding increase to distributions.

**Payment of benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Administrative and recording keeping fees paid by the plan in 2024 total \$70,915 and are included in these financial statements. Fees related to the administration of notes receivables from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

---

## 3. Forfeitures

---

At December 31, 2024, forfeited non-vested accounts totaled \$153,683. Forfeited non-vested accounts are to be redistributed among active participants in accordance with the plan documents. The amount of \$131,826 from the balance on December 31, 2024 was redistributed among active participants in 2025. Current year forfeitures totaled \$125,095 while prior year forfeitures were \$84,814. In 2024, \$51,057 was used to offset plan expenses and \$29,983 was used to offset matching contributions. In 2024, there were no participants who were paid excess match contributions. These excess match contributions would be forfeited from the participants account into the forfeiture account in 2025 if there were any.

## 4. Invesco Stable Value Fund

---

Contributions to the Invesco Stable Value Fund (SVF) are invested solely in units of a collective trust (the "Trust"). The Unit Value is determined from the fair value of the

underlying Trust as adjusted to account for the reinvestment of distributions from the underlying Trust and the deduction of Fund expenses. The Trust invests in U.S. Government and Agency Obligations, corporate debt, mutual funds, insurance company common/collective trusts, and similar investments. Most of these are classified by the Trust as level 2 investments. Because of the indirect holdings of the Plan, this investment is not considered to be a fully benefit-responsive investment contract.

Withdrawals from this Sub-account are subject to the same restrictions that apply to the underlying Trust. Withdrawals are generally made at the current Unit Value on a daily basis. Payment of “Individual Participant Directed Withdrawals”, as defined in the underlying Trust’s Declaration of Trust, may be delayed for up to thirty calendar days in the event that the Trustee determines in its discretion that an earlier withdrawal may have an adverse impact of the Trust. Payment of “Participating Plan Direct Withdrawals”, as defined in the underlying Trust’s Declaration of Trust, may be delayed up to 12 months at the discretion of the Trustee (for example, the Plan adding competing investments options). Alternatively, unit holders may elect to receive payment without such delay, subject to the application of a market value adjustment factor to the amount of the requested withdrawal if, at the time the withdrawal is to be made, the market value of the net assets of the Trust is less than its contract value. Where such, or any, restrictions or price adjustments are invoked by the underlying Trust with respect to a particular withdrawal under particular Contract, the custodian will apply such restrictions or price adjustments to those withdrawals.

No market adjustment would have been required at December 31, 2024.

The Plan Trustee does not believe that any events which would limit the Plan’s ability to transact at unit value with participants, such as terminated of the plan, bankruptcy of the sponsor, terminated of the contract with BAML, and other matters are probably at present.

There are no reserves against unit value for credit risk of the contract issuer or otherwise.

This information is only a summary of certain key provisions of the SVF, and participants should refer to the SVF for a complete review of its provisions, including the impact of Investing Fiduciary Initiated Events (such as mergers, layoffs, bankruptcy, full or partial Plan terminations, and early retirement incentive programs) as defined there in.

In 2024 due to the change in custodians from BAML to Principal, the Stable Value fund was under contract and no new contributions were allowed with the new custodian due to a put on the investment for one year.

---

#### **5. Related Party Transactions and Party in Interest**

---

In June 2024 the Plan changed the third-party administrator (TPA), trustee, and custodian. The prior TPA and custodian was Bank of America Merrill Lynch (BAML) and the current TPA is HUB International and the trustee and custodian is Principal Life Insurance Company.

Certain Plan investments are managed by the respective trustee and custodian at the time during the year. BAML, HUB and Principal were the trustee and record keeper for the Plan at some point during the year and thereon, these transactions qualify as party in interest transactions.

BAML, HUB and Principal provided certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and respective trustee and custodian. BAML and Principal received revenue from mutual fund service providers for services BAML and Principal provided to the funds. This revenue is used to offset certain amounts owed to BAML and Principal for its administrative services to the Plan.

If the revenue received by custodian from such mutual fund service providers exceeds the amount owed under the MSA, the custodian remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 there were no excess amounts. The Plan or Plan Sponsor may make a payment to trustee and custodian for administrative expenses not covered by revenue sharing.

As such, the Plan's independent accountants did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

---

#### **8. Plan Termination**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

---

#### **9. Tax Status**

---

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **10. Participant Directed Investments**

---

The Plan provides that participants may direct how their account balance is invested among the investment alternatives offered by the Plan. The Plan administrative committee selects the investment alternatives.

---

#### **11. Risks and Uncertainties**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

---

#### **12. Fair Value Measurements**

---

As noted in Note 2 above, the accompanying Statements of Net Assets Available for Benefits report the Plan's investments at fair value or contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believe its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

##### **Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

##### **Level 2**

Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### **Level 3**

Inputs to the valuation methodology are unobservable and significant to their fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### **Registered Company Shares (mutual funds)**

Reported at fair value based on daily quoted market price of the fund and classified within Level 1 of the valuation hierarchy, as of December 31, 2024. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled separate accounts:** Valued using the published daily value of underlying assets. These investments are determined to have a readily determinable fair value and are classified within Level 2 of the valuation hierarchy as of December 31, 2024.

#### **Stable Value Fund:**

Valued generally by reference to a Collective Trust which is the only investment of the fund (see Note 4), using the unit price quoted daily by custodian.

#### 13. Principal Guaranteed Option Contract

---

In 2024, the Plan entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because these are the amounts received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract values represent contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract issuers are contractually obligated to repay the principal and interest at specified interest rates that are guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuers, but may not be less than one percent. The crediting rates are reviewed on an annual basis for resetting or more frequently, as appropriate. The contract cannot be terminated before the scheduled maturity dates.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include- (1) breach of contract (2) amendments to the plan, (3) if the plan sponsor retains a record keeper other than Principal Life Insurance Company and it is determined that the recordkeeper has misrepresented information (4) failure to provide information which is reasonably requested to perform the contracts obligations (5) communications to participants from an employer, plan sponsor, plan fiduciary, or person acting on behalf or pursuant to an understanding or agreement with the Plan Sponsor or Plan fiduciary that influence Participants to withdraw or transfer all or a portion of Participants' Interests. The Plan administrator believes that no events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

As of December 31, 2024 and 2023, the contract value of the guaranteed investment was \$300,571 and \$-0- , respectively.
