

**NOTE 1 – DESCRIPTION OF PLAN**

Pilgrim's Pride Retirement Savings Plan (the Plan) is a defined contribution plan adopted by Pilgrim's Pride Corporation (the Plan Sponsor) and participating employers: Pilgrim's Pride Corporation of West Virginia, Inc., JFC LLC, and Gold n Plump Farms, LLC (collectively, the Company). The Plan was originally established by the Company effective January 1, 1969, and was most recently restated effective August 1, 2021. The Plan was amended effective January 1, 2024. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the terms of the plan document for a more complete description of the Plan's provisions.

Administration: The Plan is administered by the JBS Investment Committee (the Committee) which is composed of employees of the Company. The Committee is responsible for the operation and administration of the Plan and the management of the Plan's assets. Empower Trust Company, LLC acts as trustee and Empower Annuity Insurance Company of America acts as recordkeeper for the Plan.

Plan Amendments: Effective January 1, 2024, the Plan was amended for several key changes to the Plan:

- Eligibility for elective deferrals was expanded by removing all age and service requirements, and the eligibility criteria for employer matching and nonelective contributions was simplified to 12 months of service with no minimum hours requirement. Retroactive service credit was granted to certain outsourced personnel hired after January 1, 2023.
- Vesting schedules for matching and nonelective contributions were amended for a 5-year graded schedule (0%, 20%, 40%, 60%, 100%) beginning after two years of service.
- Minimum elective deferral of 1% and the maximum deferral limit was increased to 75% of compensation, and after-tax employee contributions were permitted.
- Certain previously excluded groups, such as temporary employees, were included under updated eligibility rules, while exclusions for leased, Puerto Rico, and penal release employees were maintained.
- Distribution provisions were updated to apply the Life Expectancy Rule to beneficiary distributions and to restrict post-severance and lifetime RMD payments to lump-sum or installment forms only.

Eligibility: Employees of the Company and participating employers who are not non-resident aliens who have no earned income from sources within the United States, leased employees, reclassified employees, North Carolina penal work release employees, employees working in Puerto Rico, and union employees except as explicitly required by the terms of a collective bargaining agreement, are eligible to make elective deferrals upon their date of hire. Based on the same criteria noted above, employees are also eligible to receive matching or nonelective contributions once they have completed 12 months of service. Upon meeting the eligibility requirements, employees can enter the Plan immediately. Refer to the Plan Sponsor's collective bargaining agreements for specific eligibility requirements related to elective deferrals and employer matching and nonelective contributions.

Contributions: A participant may elect to contribute, on a pre-tax basis, up to 75% of the participant's eligible compensation to the Plan. Certain participants covered under collective bargaining agreements have varying maximum pretax deferral rates. Participants may also designate some or all of their contributions as after-tax deferrals. An employee's contribution cannot exceed the annual dollar limitation set forth by Internal Revenue Code (IRC) section 402(g). Participants who have attained or will attain age 50 by the end of the calendar year may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company makes matching contributions in accordance with the Plan agreement and collective bargaining agreements under which the participant is eligible. Effective January 01, 2024, for employees covered under the core Plan or specific collective bargaining agreements, the Company makes a fixed matching contribution equal to 50% of participant contributions (excluding catch-up contributions). The Company will not make a contribution above 4% of the employee's compensation. Before January 01, 2024, for employees covered under the core Plan or specific collective bargaining agreements, the Company made a fixed matching contribution equal to 30% of participant contributions (excluding catch-up contributions), up to 6% of the employee's compensation.

The Company also contributes an additional non-discretionary amount as determined by certain collective bargaining agreements. These contributions range from a fixed employer contribution of \$0.15 to \$0.30 per hour, after participants attain various service requirements.

The Company may also make discretionary matching or nonelective contributions. In order to receive the discretionary nonelective contribution, the participant must be employed on the last day of the year. For 2024, the Company did not make a discretionary matching or nonelective contribution to the Plan

Participant Accounts: Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, Plan earnings and losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are vested immediately in their elective deferrals, including catch-up and after-tax contributions, and rollover contributions, plus actual earnings or losses thereon. Effective January 1, 2024, matching and nonelective contributions and earnings, vest according to a 5-year graded vesting schedule (0%, 20%, 40%, 60%, 100%) beginning after two years of service for employees covered under the core Plan. Matching and non-discretionary contributions received by employees who are members of certain collective bargaining agreements are subject to the vesting schedule based upon that agreement. Matching and nonelective contributions in the Plan prior to January 1, 2024, will vest according to a 5-year graded vesting schedule (20%, 40%, 60%, 80%, 100%) beginning after one year of service.

Participants become fully vested in all accounts in the event of death, disability, or attainment of normal retirement age while actively employed.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may redirect future contributions or exchange existing balances among available investment options at any time.

Effective October 2008, contributions are no longer allowed to be invested into Pilgrim's Pride Corporation common stock (Pilgrim's Stock); however, any existing contributions invested in Pilgrim's Stock may remain until the participant elects to either sell and reinvest the funds in a different investment option or sell and take a distribution. Any cash dividends earned or proceeds received from the sale of the investment in Pilgrim's Stock may not be reinvested in Pilgrim's Stock.

Notes Receivable from Participants: Participants may request a participant loan from the Plan. No loan in an amount less than \$1,000 will be made. Any new loan will be limited to the lesser of \$50,000 reduced by the highest outstanding loan balance during the prior 12-month period or 50% of the participant's vested interest in the Plan. Loans are adequately secured by the vested interest in the participant's account and bear an interest rate charged on similar loans under like circumstances by persons in the business of lending money. Loan terms may not exceed five years unless the loan is used to purchase a principal residence. Loan principal and interest repayments are made via payroll deductions. Participant's may only have two loans outstanding at any given time.

Payment of Benefits: Upon termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive the value of vested interest in his or her account as a lump sum distribution. If a participant's vested account balance exceeds \$7,000, they may elect to receive a distribution in a single lump-sum payment in cash or property, or installments over a period of time. If the participant does not consent to a distribution of their vested account balance, their balance will remain in the Plan. If a participant's total vested account balance under the Plan is between \$0.01 and \$7,000 as of the distribution date and they do not consent to a distribution of their vested account balance, their vested benefit automatically will be rolled over to an IRA selected by the Company. Participants may receive an in-service withdrawal prior to termination of employment with the Company if they have attained age 59 ½ or incurred a financial hardship. Effective January 1, 2024, and in accordance with Section 314 of the SECURE 2.0 Act of 2022, the Plan adopted to allow penalty-free distributions to participants who are victims of domestic abuse.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and distributions will be made as soon as administratively practicable after the Plan terminates.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Forfeited Accounts: Forfeitures are retained in the Plan and may be used to pay administrative expenses or used to reduce future employer contributions payable under the Plan.

Subsequent Events: The Plan has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued. No events have occurred that would require adjustment to or disclosure in the financial statements.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive investment contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest and other income are recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, the Plan reported deemed distributed loans totaling \$2,465,377 and \$2,460,608, respectively. These amounts are included in notes receivable from participants on the statements of net assets available for benefits.

Benefits Paid: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and global event risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- *Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability as a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* - Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the closing price reported on the active market on which the individual securities are traded (Level 1 inputs).

Common Stock: The fair values of Pilgrim's Pride common stock are determined by obtaining quoted prices from a nationally recognized exchange (Level 1 inputs).

**NOTE 5 – GUARANTEED INTEREST FUND**

The Plan holds a fully benefit-responsive guaranteed investment contract, Guaranteed Interest Fund, with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in a general account. The account is credited with earnings or losses on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting rate is reviewed on a quarterly basis for resetting. The average yield earned by the Plan was 1.66% for 2024 and 1.48% for 2023.

The contract meets the fully benefit-responsive traditional investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on EAICA's ability to meet its financial obligations. EAICA's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with EAICA. Such events include, but may not be limited to, spin-off, sale, merger, full or partial termination including distribution of assets performed by a qualified termination administrator, terminating union or participating employer in a multiple employer plan, or a layoff of at least 20% of work force in any twelve month period.

The Company believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with EAICA and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow EAICA to terminate the contract with the Plan and settle at an amount different from contract value. Examples of circumstances which would allow EAICA to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. The Company believes that any events allowing EAICA to terminate the contract and settle at an amount different from contract value are not probable of occurring.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Empower Trust Company, LLC and EAICA are service providers of the Plan, and, therefore, the Plan's payment of fees to these service providers qualifies as party-in-interest transactions. Investments in the Pilgrim's Stock and notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – TAX STATUS**

The Company adopted a non-standardized pre-approved profit sharing/money purchase/CODA prototype, sponsored by Spencer Fane LLP. The pre-approved plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was acceptable under section 401 of the IRC for use by employers for the benefit of their employees. Although the Plan has been amended from the original non-standardized pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
