The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of the Hualalai Investors 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document, including amendments, for more complete information.

General

The Plan, effective as of June 1, 2006, is a defined contribution plan covering substantially all employees (except employees covered by the Four Seasons Hotel Limited Plan) of Hualalai Investors, LLC (Company or Employer), who have completed three consecutive calendar months of service. The trustee of the Plan is Transamerica Life Insurance Company, Inc. (Transamerica) and the Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Effective December 21, 2014, benefits ceased for the Company's resort division (Resort) employees and highly compensated employees, as defined in the plan document. Resort employees became fully vested in their benefit in the Plan and began to benefit under the Four Seasons 401(k) Plan on December 21, 2014.

Additionally, effective December 21, 2014, the Plan was amended to exclude bonuses and commissions from the definition of plan eligible compensation.

Contributions

Each year, participants may contribute up to 90% of their pre-tax annual compensation, as defined in the Plan (Elective Employee Contributions), subject to the limit imposed by the Internal Revenue Code (IRC), as defined (\$23,000 in 2024). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of up to \$7,500 in 2024. Effective January 1, 2024, the plan was amended to allow participants to make Roth contributions to the plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company contributes, on behalf of each participant, an amount equal to the lesser of 50% of the Elective Employee Contributions or 3% of the participant's compensation, as defined in the Plan, for the plan year (Matching Employer Contributions). Additional amounts may be contributed at the discretion of the Company (Discretionary Employer Contributions). No Discretionary Employer Contributions were made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the Elective Employee Contributions, allocations of the Matching and Discretionary Employer Contributions and allocations of plan earnings (losses) and plan expenses. Allocations are generally based on account balance or participant earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant may direct their contribution into various investment options offered under the Plan. The participant may also change the investment elections at any time.

Vesting

Participants are vested immediately in their Elective Employee Contributions plus actual earnings thereon. The Matching and Discretionary Employer Contributions portion of their accounts shall become vested as follows:

Notes Receivable From Participants

Participants may borrow, from their fund accounts, the lesser of \$50,000 or 50% of the present value of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with the prevailing interest rate charged by persons in the business of making loans under similar circumstances. Generally, loan terms range from 1 to 5 years unless used to acquire a personal residence, in which case the term of such loan will be determined by plan management. At December 31, 2024, the interest rates on the notes ranged from 4.25% to 9.50%.

Payment of Benefits

Payment of benefits will commence no later than the 60th day after the close of the plan year in which occurs the latest of (1) attainment of age 65, (2) the 10th anniversary of the date on which the participant commenced participation in the Plan or (3) the termination of the participant's service with the Employer. Benefits are payable in a lump sum equal to the value of the participant's vested account balance. Terminated employees may leave their balances with Transamerica, if greater than \$5,000, until their normal retirement date.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$67 and \$6,736, respectively. These accounts will be used to reduce future employer contributions and administrative expenses. In 2024, employer contributions were reduced by \$6,196, from forfeited nonvested accounts and \$967 of forfeitures were used to pay plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit responsive investment contract which is reported at contract value. The pooled separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Fully benefit-responsive investment contracts are valued at contract value which is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are reflected on a trade-date basis. The realized gains or losses on the sale of securities are based upon average cost. Income from investments is recorded as earned on the accrual basis. Net appreciation (depreciation) in the value of investments for the year reflected in the statements of changes in net assets available for benefits, includes the Plan's gains on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of the Plan are paid by the Employer. Included in these expenses are costs related to certain employees of the Employer who perform administrative and trustee services for which the Plan does not reimburse the Employer. Certain investment management fees are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded when such distributions are paid.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Note 3. Investment Contract With Insurance Company

The investment in the general account, the Transamerica Stable Value Advantage Option, is considered fully benefit-responsive; therefore, contract value is considered the relevant measurement. Transamerica maintains the contributions in a general account. It invests primarily in guaranteed investment contracts, money market investments and other cash equivalents. The investments are credited with earnings on

underlying investments and charged for plan withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The value of the investment is not guaranteed and is subject to the claims paying ability of Transamerica. There are no reserves against the contract for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. The guaranteed rate of interest shall not change during the six-month period for which it is effective. There is no stated minimum or maximum interest rate for the Stable Value Advantage Option.

Note 4. Information Certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Life Insurance Company, Inc., a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, full-time employees become fully vested in their respective account balances.

Note 6. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype defined contribution plan and trust sponsored by Transamerica Retirement Solutions Corporation. This prototype plan document has been filed with the appropriate agency and the prototype sponsor has obtained an opinion letter from the Internal Revenue Service, dated June 30, 2020, stating that the prototype constitutes a qualified plan under Section 401k of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date.

Note 7. Party-in-Interest Transactions

Certain plan investments are pooled separate accounts managed by Transamerica Life Insurance Company. Transamerica Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees other than investment management fees were \$14,721 for the year ended December 31, 2024. Fees paid by the Plan during the year for administrative services were rendered by parties-in-interest.

Note 8. Risk and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through June 30, 2025, which is the date the financial statements were available to be issued.
