Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Vyve 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Vyve 401(k) Plan (the "Plan") is provided for general purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Northland Cable Television Inc. and Eagle Broadband Investments, LLC (collectively the "Companies" or "Employers"). An employee is eligible for participation in the Plan upon attainment of age 18 and after completing 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, a participant may elect to contribute from 1% to 90% of their eligible compensation on a pre-tax or Roth basis, as defined in the Plan. There is an annual limit as to the amount that can be deducted from the compensation that is determined by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

Unless a participant elects otherwise, the Plan provides for automatic enrollment upon eligibility at a pre-tax deferral rate of 4% of their eligible compensation. Effective May 1, 2023, the Plan was amended to add an automatic escalation feature whereby participant's deferrals will increase by 1% annually up to 10% of their eligible compensation.

Employer matching contributions are made to participants as 100% of their elective deferrals up to a maximum of \$1,250 per plan year.

The Employers may also make a discretionary profit sharing contribution to the Plan. For the year ended December 31, 2024, the Employers did not make any discretionary profit sharing contributions to the Plan.

Vesting

Participants are vested immediately in their contributions and Employer matching contributions plus allocated earnings thereon. Participants vest in the discretionary profit sharing contributions based on a three-year cliff vesting schedule.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount of the lesser of \$50,000 or 50% of the participant's vested account balance, reduced by, if any, of the participant's highest outstanding loan balance from the Plan during the previous one-year period. Loans must be repaid over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the term is not to exceed 30 years. Principal and interest is paid ratably through periodic payroll deductions.

1. Description of Plan (*continued*)

Participant Accounts

Each participants account is credited with the participant's contributions and allocations of (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. In-service withdrawals may be taken by a Participant in the event of hardship, as defined or after age 59 ½.

Forfeiture Account

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and can be used to: reduce Plan expenses; reduce future Employer contributions; or allocate back to participants. At December 31, 2024 and 2023, forfeited accounts totaled \$17,733 and \$11,377. During 2024, \$216 of forfeitures were used to reduce Employer contributions and none were used to reduce Plan expenses or were allocated back to participants.

Plan Expense Account

The Plan Expense Account is a nonparticipant directed account within the Plan and is used to record the redistribution of Plan-generated fund revenue that exceed the costs associated with Plan administration. The Plan Expense Account balance was \$3,886 and \$3,794 at December 31, 2024 and 2023. During 2024, the account was credited with \$30,020 and \$30,020 from the Plan Expense Account were used to reduce administrative expenses incurred by the Plan.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Also, certain administrative expenses of the Plan are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. The mutual funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient and is based on the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

5. Common/Collective Trust

The Wilmington Trust CIT III for MetLife Group Annuity Contract No. 25554, (the “Fund”) is a common/collective trust that was formed for the purpose of allowing collective investments by plan sponsors of retirement plans. Wilmington Trust, N.A. serves as trustee of the Fund.

Units of the Fund are valued each day on which the New York Stock Exchange (“NYSE”) is open for trading in accordance with the valuation procedures established by the trustee. The NAV per unit of the Fund is calculated as of the close of trading on the NYSE. The NAV per unit is computed by dividing the total value of the assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. The Fund sells new units and repurchases outstanding units on a daily basis. Unit purchases and redemptions are transacted at the NAV of the Fund determined as of the close of business each day. Investment income earned is reinvested in the Fund and included in the determination of unit values.

6. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

7. Tax Status

The prototype plan document preparer, ADP, LLC, has obtained an opinion letter dated October 6, 2020 from the Internal Revenue Service (“IRS”) stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

9. Risks and Uncertainties (*continued*)

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
