### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of New Jersey Property-Liability Insurance Guaranty Association (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Notes to Financial Statements

Years ended December 31, 2024 and 2023

**1. Description of Plan**

The following description of the Insurance Company Supported Organizations 401(k) Savings Plan, as adopted by the New Jersey Property-Liability Insurance Guaranty Association (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established January 1, 2000 and restated effective September 23, 2021, for the benefit of the employees of Insurance Company Supported Organizations, as adopted by the New Jersey Property-Liability Insurance Guaranty Association (the Company). The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's Sponsor. The operations of the Plan are directed by the Plan Trustee and the Named Fiduciaries of the Insurance Company Supported Organizations 401(k) Savings Plan (the Named Fiduciaries), a majority of whom are executive officers of certain employers that have adopted the Insurance Company Supported Organizations 401(k) Savings Plan. The Plan's Trustee is Voya Retirement Insurance and Annuity Company (Voya). Its third party administrator is Angell Pension Group. The Named Fiduciaries are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

The Plan covers all employees of the Company, with the exception of leased employees, residents of Puerto Rico, independent contractors, and non-regular employees. There is no age or service requirement. Participants may immediately defer a portion of their annual compensation upon becoming eligible to participate.

**1. Description of Plan (continued)**

**Contributions**

Contributions from plan participants and the contributions from the employer are recorded in the year in which the employee contributions are withheld from the compensation. Each year, participants may contribute up to 100% pre-tax or post-tax annual compensation, as defined in the Plan limited by the provisions of the IRC. Voluntary (after tax) contributions are limited to 75% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions. Active participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with a deferral rate of 6% of annual compensation unless they affirmatively elect not to participate in the Plan. The Company will contribute a Safe Harbor matching contribution amount equal to 100% of the participant's elective deferral until such deferral equals 5% of the participant's compensation. The Company will also make a nonelective contribution of 3% of eligible compensation for all employees, provided they are still employed as of year-end. Company contributions are invested directly into the investment options selected by the participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations and nondiscrimination requirements.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company Safe Harbor contributions, as well as Company qualified non-elective contributions and non-elective allocation contributions, when applicable, and Plan earnings.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's contribution plus actual earnings thereon occurs based on years of continuous service. A participant is 100 percent vested after two years of service.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11 and \$12, respectively. These accounts will be used to reduce employer contributions or pay qualified plan expenses. During the year ended December 31, 2024, \$3 of forfeitures were used reduce employer contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. One outstanding loan is allowed at a time. Loan terms range from one to five years and are repaid in equal payroll period installments. The loans are secured by the balance in each participant's account and bear interest at rates of 4.25% to 9.50%. The interest rate on any loan to a participant shall be a reasonable interest rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money. For the year ended December 31, 2024, the interest rate is set at 1% over the prime interest rate.

**Payment of Benefits**

On termination of service due to retirement, death, disability or termination of employment, participants may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum distribution, partial payment, or installment payments. A single lump-sum distribution will be made to terminated participants whose vested balance is less than \$7,000 unless alternative instructions are provided by the participant within a reasonable period of time.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments, other than the fully benefit-responsive investment contract discussed in Note 4, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Named Fiduciaries determine the Plan's valuation policies utilizing information provided by investment advisors, Trustee and insurance company. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to August 11, 2025, the Plan did not have any material recognizable subsequent events.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2        Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. Guaranteed Investment Contract with Prudential Bank & Trust, FSB (Prudential)**

The Plan is invested in a Synthetic Guaranteed Investment Contract (GIC) with Prudential. Under the terms of the contract, a crediting rate is established for amounts invested in the GIC and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Contract value is also often referred to as "book value." The contract meets the fully benefit responsive investment contract criteria, notwithstanding the contract provisions that limit the ability of the plan to transact at contract value when a market value event occurs.

Because the GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. The GIC is presented on the face of the statements of net assets available for benefits at contract value.

No events limit the ability of the Plan to transact at contract value so long as the contract remains in force. Except for events which may result in termination for cause, as outlined in the Prudential GIC (e.g. Plan termination or merger, early retirement incentive, layoffs, etc.), Prudential may not cause the contract to be terminated at an amount other than contract value. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring. None of these events occurred during 2024.

**5. Plan Termination**

Although they have not expressed any intent to do so, the Named Fiduciaries and the Company have the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**7. Tax Status**

The Plan has not requested a determination letter from the Internal Revenue Service (IRS) regarding the Plan's exemption from federal income tax under Section 401(a) of the IRC. The Plan has adopted a non-standardized pre-approved profit sharing plan sponsored by Angell Pension Group, Inc. The non-standardized pre-approved profit sharing plan has received an opinion letter from the IRS as to the plan's qualified status. The non-standardized pre-approved profit sharing plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and as such, no provision for income tax has been included in the Plan's financial statements.

**8. Accounting for Uncertainty in Income**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**9. Related Party Transactions and Party In Interest Transactions**

Certain Plan investments are managed by Voya, the Plan's Trustee. Transactions involving these investments are considered to be party in interest transactions. Total fees paid for administrative services amounted to \$33,320 for the year ended December 31, 2024.

**10. Information Certified by Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya (the Trustee of the Plan), a qualified institution.


