### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Insurance Company Supported Organizations 401(k) Savings Plan as adopted by AIPSO (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### ***Basis for Opinion***

Notes to Financial Statements

Years ended December 31, 2024 and 2023

**1. Description of Plan**

The following description of the Insurance Company Supported Organizations 401(k) Savings Plan as adopted by AIPSO (the Plan) provides general information only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established October 1, 2000, and restated effective September 21, 2021, for the benefit of the employees of Automobile Insurance Plans Service Office (the Employer or Plan Sponsor). The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The operations of the Plan are directed by the Plan Trustee and the Named Fiduciaries of the Insurance Company Supported Organizations 401(k) Savings Plan (the Named Fiduciaries), a majority of whom are executive officers of certain employers that have adopted the Insurance Company Supported Organizations 401(k) Savings Plan. The Plan's Trustee is Voya Retirement Insurance and Annuity Company (Voya). Its third-party administrator is Angell Pension Group. The Named Fiduciaries are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

The Plan covers all employees of the Employer, with the exception of leased employees, officers or directors who do not receive any salary, employees who are paid compensation for which federal taxes are not withheld by the employer pursuant to Code Sections 3401-3404, residents of Puerto Rico, and independent contractors. All eligible employees may become participants and defer a portion of their annual compensation on the date they first perform an hour of service as an eligible employee.

**1. Description of Plan (continued)**

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Each year, participants may elect to make pre-tax and after-tax contributions to the Plan up to 75% of their compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan thirty days after becoming eligible unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of their compensation. The Employer will contribute a matching contribution amount equal to 100% of participant's contributions up to 6% of compensation. Discretionary non-elective contributions may be contributed at the discretion of the Employer. The Employer did not make discretionary non-elective contributions for the year ended December 31, 2024. Participants direct the investment of all contributions to their accounts into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations and nondiscrimination requirements of the Code.

**Participant Accounts**

Participants' accounts are credited with their contributions, the Employer's matching contributions, their share of the Plan's earnings or losses and charged with an allocation of administrative expenses for participant account related fees. Allocations of Plan earnings or losses, administrative expenses for transaction fees and other investment related expenses are based upon the participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. If hired on or before December 31, 2021, participants are 100% vested in Employer's matching and non-elective contributions, plus actual earnings thereon. If hired after December 31, 2021, participants will become 100% vested in Employer's matching and non-elective contributions, plus actual earnings thereon, after completing three years of service.

**Forfeitures**

Forfeitures of employer contributions are used to reduce future match contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,347 and \$82, respectively. During 2024, employer contributions were reduced by \$40,326 from forfeited nonvested accounts.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in each participant's account and one outstanding loan is allowed at a time. Loan terms range from one to five years and are repaid in equal payroll period installments. The interest rate on any loan to a participant shall be a reasonable interest rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money. For the year ended December 31, 2024, the Plan used the bank prime rate plus 1%. Loans outstanding as of December 31, 2024, have interest rates of 4.25% - 9.5%.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive the value of the participant's vested interest in his or her account in a lump sum, in annual installments, or it can be rolled to another retirement plan, if applicable. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In certain hardship situations, as described in the Plan document, participants may withdraw part of their account balances while actively employed.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract discussed in Note 4, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Named Fiduciaries determine the Plan's valuation policies utilizing information provided by the investment advisers, Trustee, and insurance company. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to July 30, 2025, the Plan did not have any material recognizable subsequent events.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Interest bearing cash:* Valued at the closing account balance held by the Plan at year end.

*Common stocks:* Valued at the closing price reported in the active market in which the individual securities are traded.

*Corporate bonds:* Valued at the closing price reported in the active market in which the bond is traded.

*Cash equivalents:* Valued at the closing account balance held by the Plan at year end.

*U.S. Government securities:* Valued at the closing price reported in the active market in which the individual securities are traded.

*Corporate debt instruments:* Valued at the closing price reported in the active market in which the instrument is traded.

**4. Guaranteed Investment Contract with Prudential Bank & Trust, FSB (Prudential)**

The Plan has entered into a Synthetic Guaranteed Investment Contract (GIC) with Prudential, provided through a group annuity contract. Under the terms of the group annuity contract, a crediting rate is established for amounts invested in the GIC and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Contract value is also often referred to as "book value". The contract meets the fully benefit-responsive investment contract criteria, notwithstanding the contract provisions that limit the ability of the plan to transact at contract value when a market value event occurs.

Because the GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. The GIC is presented on the face of the statements of net assets available for benefits at contract value.

No events limit the ability of the Plan to transact at contract value so long as the contract remains in force. Except for events which may result in termination for cause, as outlined in the contract (e.g. Plan termination or merger, early retirement incentive, layoffs, etc.), Prudential may not cause the contract to be terminated at an amount other than contract value. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring. None of these events occurred during 2024.

**5. Plan Termination**

Although they have not expressed any intent to do so, the Named Fiduciaries and the Employer have the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be fully vested in their accounts as of the date of such termination.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**7. Tax Status**

The Plan has not requested a determination letter from the Internal Revenue Service (the IRS) regarding the Plan's exemption from federal income tax under Section 401(a) of the IRC. However, the Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by Angell Pension Group Inc. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC, and as such, no provision for income tax has been included in the Plan's financial statements.

**8. Accounting for Uncertainty in Income**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**9. Related Party Transactions and Party In Interest Transactions**

Certain Plan investments are managed by Voya, the Plans' Trustee. Transactions involving these investments are considered to be party in interest transactions. Total fees paid for plan administration amounted to \$125,094, for the year ended December 31, 2024.

**10. Information Certified by Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya (the Trustee of the Plan), a qualified institution.
