Rationale for Selection of Actuarial Assumptions

Segment rates and mortality assumptions are prescribed with limited plan sponsor discretion. The applicable month for funding segment rates was selected based on budgeting convenience. The combined annuitant and non-annuitant mortality table for post-retirement was used due to simplicity. Pre-retirement mortality was not assumed as explained below.

Given the size of the covered population, pre-retirement decrements for retirement, termination, mortality and disability are not assumed. Therefore, all participants are assumed to retire at their Normal/Early Retirement Age.

Spousal assumptions are documented but do not impact the figures shown in the report since the full value of retirement benefits based on the participant's age are provided at death.

The lump sum form of payment is assumed to be elected by all participants, which is consistent with expectations given the size of this Plan.


