Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Noodle Partners, PBC (dba Noodle) 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of Plan

General

The following brief description of the Noodle Partners, PBC (dba Noodle) 401(k) Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions. The Plan was adopted by Noodle Partners, PBC (dba Noodle).

The Plan was established on March 1, 2022. The Plan is a defined contribution plan that covers substantially all employees of Noodle Partners, PBC and its affiliated companies (the Company or the Plan Sponsor). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective April 15, 2024, the assets of Meteor Learning, Inc. 401(k) Retirement Savings Plan were merged into the Plan. Contributions made prior to the merger became 100% vested.

Eligibility

Substantially all employees of the Company are eligible to participate in the Plan on the first day of the month coinciding with or following the employee having reached the age of 21 and having completed three months of service.

Participant Accounts

Each participant's account is credited with their deferral contributions, employer contributions, and the earnings thereon. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Contributions

The Plan provides each participant with an opportunity to make elective deferrals and Roth contributions to the Plan, subject to the limitations of the Internal Revenue Code. Each participant may contribute from 1% up to 100% of the participant's eligible compensation each year. Employees are automatically enrolled at a 5% pre-tax deferral percentage, unless the employee elects not to participate in the Plan.

The Company is permitted to make both discretionary matching and non-elective contributions for each plan year. For the 2024 plan year, the Company made discretionary matching contributions at the lower of 100% of the participant's total annual contribution or \$2,500. The Company did not make any discretionary non-elective contributions for the 2024 plan year.

Vesting

Participants are immediately vested in their own contributions and earnings thereon. For both employer matching and non-elective contributions, participants vest 20% after two years, with full vesting after three years of credited service (as defined). A year of service is defined as 1,000 credit hours of service during a plan year.

Forfeitures

The portion of a participant's balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. Forfeiture balances of terminated participants' nonvested accounts can be used to pay allowable administrative expenses or to reduce employer matching contributions, in accordance with the Plan document. For the year ended December 31, 2024, forfeitures from employees were \$187,512. For the year ended December 31, 2024 forfeitures of \$155,647 and \$27,054 were applied to reduce employer matching contributions and pay administrative expenses, respectively. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$10,662 and \$5,024, respectively.

Payment of Benefits

Upon termination, death, disability, or retirement, vested plan benefits will be distributed to a participant in a lump-sum distribution or periodic installments. Participants are eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A participant must repay any outstanding loan before a new loan can be made. Loans must be fully repaid through payroll deductions within five years, unless the loan is for the purchase of a primary residence, which must be repaid within a period of no more than 30 years. Loans are measured at their unpaid principal balance plus any accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. As of December 31, 2024 and 2023, the interest rate on the outstanding loans ranged from 4.25% to 9.50%.

Administrative Expenses

All transaction fees for loan and distribution requests are paid from participants' accounts. A portion of all other administrative expenses are paid by the Company.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation include the Plan's realized and unrealized gains and losses, respectively, on investments bought and sold as well as held during the period. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefits are recorded when paid.

Note 4. Fair Value Measurements

The framework of measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels are as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies of these items held at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price, as reported by the fund. The mutual funds held by the Plan are actively traded.

Pooled separate accounts: Valued at their accumulation unit value (AUV). The separate accounts are valued daily as the number of accumulation units held multiplied by the AUV. The AUV is determined daily based on the net asset value (NAV) of underlying shares of the underlying funds, the fund's dividends and the contract's separate account charges.

Self-directed brokerage accounts: Self-directed brokerage accounts include an exchange fund and money market fund, which are valued at quoted prices in an active market of the underlying investments held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is as least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Note 6. Related-Party Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Principal Life Insurance Company is the record-keeper for the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal amounted to approximately \$89,734 for the year ended December 31, 2024.

Fees paid by the Plan to The Benefit Practice for third party advisory services amounted to \$13,750 for the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 7. Tax Status

On June 30, 2020, the Internal Revenue Service stated that the non-standardized prototype plan adopted by the Plan, as then designed, qualifies under Section 410(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, however, the Plan's management believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Plan Termination

Although the Company has not expressed any intention to do so, it has the right to terminate the Plan in whole or in part at any time subject to the provisions set forth in ERISA. Upon termination, all participants become fully vested in their individual accounts.

Note 9. Subsequent Events

Plan management has evaluated subsequent events through September 8, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
