Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Ziegler Inc. Voluntary Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the Ziegler Inc. Voluntary Retirement Savings Plan (the “Plan”) provides only general information. Participants and other interested parties should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on June 26, 1984 and was restated January 1, 2016. The Plan is a defined contribution pension plan providing retirement and death benefits to eligible participants. The Plan covers eligible employees of Ziegler Inc. and certain related companies (the “Companies”). Participation in the Plan is voluntary for employees who are 18 years of age, have worked at least 30 days for a participating company and work a minimum of 1,000 hours per year. Newly hired eligible employees are automatically enrolled at a 5% deferral rate. Ziegler Inc. is the administrator and sponsor of the Plan and has appointed certain Company officers as trustees of the Plan. Effective, October 20, 2023, the Plan changed its trustee and custodian from Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, F.S.B., respectively, to Empower Trust Company, LLC. The Trustee and Custodian are responsible for holding the investment assets of the Plan. The Trustee and Custodian are also responsible for processing and approving Plan distributions in accordance with Plan provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Participants may contribute up to 75% of pre-tax annual compensation (salary reduction contributions), as defined in the Plan and participants age 50 or older may contribute catch-up contributions. Participants may also contribute up to 10% of gross income on a post-tax basis. The combined contributions of pre-tax and post-tax contributions may not exceed the lesser of 100% of gross income or \$54,000. Participants may also contribute amounts rolled over from other qualified plans. The Plan provides a safe harbor matching contribution consisting of 100% of the first 3% of the participant’s eligible pay that is deferred on a pre-tax basis and 50% of the next 2% of eligible pay that is deferred on a pre-tax basis. Participants are immediately vested in the safe harbor matching contribution, plus earnings thereon.

In addition, certain longer service employees are eligible for a supplemental transition benefit. The supplemental benefit was added in connection with changes to the Companies’ defined benefit pension plan. To be eligible for the supplemental annual contribution, an employee must be employed by the Companies on the last day of the calendar year. For those employees not covered by a collective bargaining agreement, the following chart for Years of Service was determined as of December 31, 2009. For those employees covered by a collective bargaining agreement, the following chart for Years of Service was determined as of December 31, 2010. Participants are immediately vested in the supplemental transition benefit, plus earnings thereon.

The Employer may make an additional discretionary non-elective contribution of up to 2% of the participants' compensation. The rate of contribution will be determined by subtracting each participant's average deferral rate for the Plan Year from 2%. There were \$935,031 and \$2,105,685 discretionary non-elective contributions made in 2024 and 2023, respectively.

Administrative Expenses

Administrative expenses of the Plan, except for participant loan processing fees and a portion of investment management fees, are paid by the Company, as provided in the Plan document. All investment management and transaction fees directly related to the Plan investments are paid by the Plan.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Participant Accounts

Each participant directs the investment of their participant contribution choosing from various investment options. Participants may change their investment options daily. Earnings from the funds are allocated on the basis of participant account balances invested in the respective funds. Participants are immediately vested in their salary reduction, safe harbor matching and rollover contributions, plus earnings thereon.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Interest on loans will be fixed at inception at the prevailing corporate prime rate in the local area plus 2% and repayment must be made in monthly installments over a period not to exceed five years. The loans are secured by the balance in the participant's account. Payments of principal and interest will generally be made ratably through payroll deductions.

Payment of Benefits

Upon death, disability, termination or retirement, as defined, a participant is entitled to receive benefits based on their account balances. Benefits may be withdrawn according to the terms of the Plan in a lump sum or an annuity may be purchased. Annuity payments will normally be paid as joint and survivor benefits with the participant's spouse as beneficiary. If the participant dies before retiring, the beneficiary is entitled to a total distribution of the value of the accounts. Participants experiencing financial hardship may withdraw a portion of their account balance as defined by the Plan. The Plan also allows in-service distributions in the event of financial hardship or if the participant has attained the age of 59½. The Plan generally requires distributions of account balances of less than \$5,000 upon termination. Automatic distributions greater than \$1,000 without the participants consent will be paid in a direct rollover to an Individual Retirement Account ("IRA").

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note D, Fair Value Measurements, for details on inputs, valuation techniques, and fair value measurement level within the fair value hierarchy. Purchases and sales of securities on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments included in the accompanying statements of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation in fair value of investments. Net unrealized appreciation in fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year, or the cost of the investment if purchased during the year.

Risks or Uncertainties

The Plan provides for investment in a variety of investment funds. Investments are subject to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. There was no allowance for credit losses recorded as of December 31, 2024 and 2023.

Benefits to Participants

Benefits are recorded when paid.

NOTE C - CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator determined that the certification received from Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, F.S.B., the Custodian and Trustee of the Plan, respectively, for the period of January 1, 2023 to October 20, 2023 and Empower Trust Company, LLC, the Custodian and Trustee of the Plan, as of December 31, 2024 and 2023, and for the period of October 21, 2023 to December 31, 2023, and for the year ended December 31, 2024, meet the requirements of ERISA Section 103(a)(3)(C). Accordingly, the Custodian and Trustee of the Plan, have certified to the completeness and accuracy of all investments and participant loans reported in the accompanying statements of net assets

NOTE D - FAIR VALUE MEASUREMENTS

The Plan follows U.S. GAAP for measuring, reporting, and disclosing fair value. These standards apply to all assets and liabilities that are measured, reported, and/or disclosed on a fair value basis. As defined in the accounting standards, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Assets and liabilities measured, reported and/or disclosed at fair value will be classified and disclosed in one of the following three categories:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds - Valued at the NAV as a practical expedient.

Pooled separate account - Valued at the NAV as a practical expedient.

Self-directed brokerage accounts - The self-directed brokerage accounts contain investments in corporate common stocks, mutual funds and interest-bearing cash. Corporate common stocks are

typically priced using the closing price from the applicable exchange, NYSE, NASDAQ, etc. Mutual funds are valued consistent with the methodologies noted above for mutual funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has an investment contract that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

Under the terms of the Plan's guaranteed investment contract, the contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a regular basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code ("IRC") or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; and
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract

3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

NOTE F - TAX STATUS

The Plan adopted the Empower Retirement, LLC prototype plan. The prototype plan obtained its latest opinion letter on September 16, 2022, in which the Internal Revenue Service ("IRS") stated that the underlying prototype plan document was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE H - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain of the Plan's investments are managed by the Custodian and Trustee, and therefore, these transactions qualify as party in interest transactions. The arrangements with Prudential Retirement Insurance and Annuity Company and Prudential Bank & Trust, F.S.B., for the period of January 1, 2023 to October 20, 2023, and Empower Trust Company, LLC, for the period of October 21, 2023 to December 31, 2024, are permitted by ERISA. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. There were no loans or fixed income obligations in default nor were there any lease transactions. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE I - SUBSEQUENT EVENTS

The Plan has evaluated events through September 2, 2025 which is the date that the financial statements were approved and available to be issued.

Effective January 1, 2025, the Plan amended its loan provisions to reduce the maximum loan amount available from \$50,000 or 50% of the participant's vested account balance to \$25,000 or 50% of the participant's vested account balance. The plan is not aware of any additional subsequent events which would require recognition or disclosure in the financial statements.
