We have performed audits of the financial statements of **American Stair 401k Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following brief description of the American Stair Corporation (Company) 401(k) Employee Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a Section 401(k) defined contribution plan with salary deferral provisions which was established on October 1, 1987. The Plan covers substantially all employees of the Company who have attained the age of 18 years old and have completed 500 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Reliance Trust Company (Reliance) is the Plan trustee and ADP Retirement Services (ADP) is the record-keeper of the Plan.

Contributions – Pre-tax deferred and Roth contributions in the form of salary reductions by participants are allowed. The amount contributed is determined by the participant, subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe-harbor matching contribution equal to 100% of employee salary deferrals up to 6% of eligible compensation per pay period. The Company may make a nonelective contribution at its discretion. No nonelective contributions were made during 2024. Each participant is able to allocate their Company contributions among the Plan's various investment accounts.

Participants' Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – A participant is fully vested in participant contributions as well as safe-harbor matching contributions, plus actual earnings, gains and losses thereon, at all times. Vesting in the Company's discretionary nonelective contribution portion of their accounts is as follows:

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1 percent above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits – A participant's account balance may be withdrawn upon retirement, death, disability, or termination of employment as defined by the Plan. Benefits are payable in either a single lump-sum amount or installment payments equal to the value of the participant's account. In-service withdrawals from transfer accounts, distributions after age 59½ and hardship distributions are also allowed by the Plan.

Forfeited Accounts – Forfeited balances of terminated participants' nonvested matching accounts are used to reduce the Company's safe harbor contribution. Any remaining forfeiture balance is used to pay administrative expenses of the Plan. \$16 of forfeitures were used to reduce the Company's safe harbor contribution during the year ended December 31, 2024. The accumulated forfeiture balance at December 31, 2024, was \$1,464 (\$1,441 in 2023).

Plan Termination – Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. The termination of the Plan is subject to the provisions of ERISA. In the event of Plan termination, all account balances as of the date of termination shall be payable to the participants and beneficiaries.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes to the Financial Statements (cont'd)

2. Summary of Significant Accounting Policies (cont'd)

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 for discussion of fair value measurement).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to withdrawals, other than loans, are shown as administrative expense and allocated to the applicable participants. Investment related expenses are included in net appreciation of fair value of investments. The Plan has a revenue-sharing arrangement whereas if the Plan's investments generate more revenue to the investment manager than is necessary to cover the costs of the investment related services, the excess amount will be credited to the Plan, included in other income, and used to pay the plan expenses. Excess funds received over Plan expenses paid are maintained in an unallocated "Plan Expense Account." The balance in the Plan Expense Account at December 31, 2024, is \$230,734 (\$192,893 at December 31, 2023).

CARES Act – On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act, ('CARES Act'), was passed by Congress. The CARES Act contains several provisions that temporarily impact 401(k) plans. The Plan elected to allow coronavirus-related distributions and the waiver of required minimum distributions. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

Subsequent Events – Subsequent events have been evaluated through September 3, 2025, which is the date the financial statements were available to be issued.

3. Information Prepared and Certified by Trustee

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from information prepared by Reliance Trust Company, the Plan's custodian, and furnished to the Company. The Company has obtained certifications from the custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024 that such information is complete and accurate.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Level 1 – Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 – Valuations are based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; and model-derived valuations whose significant inputs are observable.

Level 3 – Valuations are based on unobservable inputs for the asset or liability that reflect the reporting entity's own data and assumptions that market participants would use in pricing the asset or liability. These unobservable inputs are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements (cont'd)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These assets are categorized in Level 1 of the fair value hierarchy.

The common/collective fund is valued at the NAV of units of the collective trust, as provided by the trustee. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. The fund is a stable value fund composed primarily of a fully benefit-responsive guaranteed investment contract. These assets can be redeemed daily and there are no withdrawal restrictions.

5. Related-Party and Party-in-Interest Transactions

The Plan paid ADP \$9,763 related to various fees. These fees were allocated to the participants as discussed in Note 2. Investment related fees of \$51,153 were paid from the unallocated "Plan Expense Account" (See Note 2). The Company pays directly any other fees related to the Plan's operations.

6. Tax Status

The Plan has adopted a Prototype Non-standard Profit Sharing Plan. The Plan and related trust design is intended to be in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving a determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset), if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
