We have performed audits of the accompanying financial statements of Intrinsic Schools 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Intrinsic Schools 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **NOTES TO FINANCIAL STATEMENTS**

### **1. Description of the Plan**

The following description of Intrinsic Schools 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **General:**

The Plan is a defined-contribution plan covering all full-time employees of Intrinsic Schools (the School) who are citizens or residents of the United States of America, except leased employees, independent contractors, part-time employees and employees covered by a collective bargaining agreement. Employees are eligible to participate in the Plan after reaching 21 years of age and may enter the Plan on the date the requirement is met.

#### **Contributions:**

Participants may contribute up to 90% of eligible compensation (excluding bonuses and stipends) on a pre-tax and/or post-tax basis. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Contributions are limited in accordance with Internal Revenue Service (IRS) regulations.

The Plan permits employer contributions by the School. The School matches 100% of the participants' contributions, up to 4.5% of the participants' compensation for those participants that are not certified teachers and administrators with the State of Illinois and who do not participate in the Chicago Teachers' Pension Fund or those participants that are not part of the Intrinsic Schools 457(b) Plan (effective July 1, 2023).

The Plan also permits a profit-sharing contribution for all Plan participants that is calculated at the School's discretion.

#### **Participant accounts:**

Each participant directs their individual investments including their share of allocated School contributions into various investment options offered by the Plan. Each participant's account is credited with contributions, appreciation (depreciation) in fair value of investments and interest and dividend income. Allocations are based on participant earnings or account balances as defined by the Plan.

## **NOTES TO FINANCIAL STATEMENTS (CONTINUED)**

### **1. Description of the Plan (continued)**

#### **Vesting:**

Participants are immediately vested in their contributions and all employer contributions plus actual earnings thereon.

#### **Participant loans:**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans are required to be repaid within five years of the date of the loan, unless the loan is for the purchase of a primary residence, then the Plan Administrator may permit a longer repayment term, with only one outstanding loan allowable at any time. The loans are secured by balances in the participants' accounts and bear interest at the Prime rate (7.50% and 8.50% as of December 31, 2024 and 2023, respectively), plus 1% at the time of issuance. Principal and interest is paid ratably through payroll deductions. Outstanding loans must be immediately repaid upon termination of employment and loan defaults are treated as distributions.

#### **Payment of benefits:**

A participant becomes entitled to benefits under the Plan upon reaching normal retirement age (as defined by the Plan), death, permanent disability or resignation from the School, to be paid in a manner specified in the Plan.

The Plan also allows in-service withdrawals from a participant's account balance upon attaining age 59 ½.

### **2. Summary of significant accounting policies**

#### **Basis of accounting:**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

### **2. Summary of significant accounting policies (continued)**

#### **Investment valuation and income recognition:**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Payment of benefits:**

Benefits are recorded when paid.

#### **Notes receivable from participants:**

As described in Note 1, the Plan allows participants to borrow against their vested account balance and the loans are secured by the participants' account balances. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest.

#### **Contributions:**

Participant contributions are recognized by the Plan when withheld from the participants' paychecks by the School.

#### **Administrative expenses:**

All administrative costs, charges and expenses are paid by the Plan to the extent not paid by the School.

#### **Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits as of the end of the Plan year and the reported amounts of changes in net assets available for benefits during the period. Accordingly, actual results could differ from those estimates.

### **2. Summary of significant accounting policies (continued)**

#### **Subsequent events:**

The Plan Administrator has reviewed and evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

### **3. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **4. Investments (prepared and certified by Reliance Trust Company (the Trustee))**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in these financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee as of December 31, 2024 and 2023.

The Trustee certified the fair value of investments of \$4,369,469 and \$3,361,819 as of December 31, 2024 and 2023, respectively, and notes receivable from participants of \$69,524 and \$25,834 as of December 31, 2024 and 2023, respectively, and to the completeness and accuracy of the dividend and interest income of \$88,697, interest on notes receivable from participants of \$2,816 and net appreciation in fair value of investments of \$439,010 for the year ended December 31, 2024.

Interest rates on outstanding loans ranged from 6.50% to 9.50% at December 31, 2024 and 5.75% to 9.50% at December 31, 2023.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the market value of shares held by the Plan at year-end.

Common collective trust fund: Valued at the net asset value (NAV) of units held by the Plan at year-end. NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes that the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **6. Party-in-interest transactions**

The Plan's investments are managed by the Trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee for investment management services totaled \$24,493 for the year ended December 31, 2024.

### **7. Plan termination**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

### **8. Tax status**

The Plan currently operates under a Prototype Non-standardized Profit Sharing Plan with Cash or Deferred Arrangement, which has an opinion letter dated October 6, 2020. In the opinion letter, the IRS stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). The Plan has been amended since receiving the letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
