### **NOTE A – DESCRIPTION OF PLAN**

The following description of Gastroenterology Associates, P.A. (the “Employer”) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### GENERAL

The Plan is a defined contribution plan administered by the Employer for the benefit of its employees. An employee becomes eligible to participate in the Plan on the January 1 or July 1 coinciding with or immediately following the date on which he or she has attained the age of 20 1/2. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### CONTRIBUTIONS

The Employer contributes 3% of each participant’s compensation to the Plan (“safe harbor contribution”). In addition, the Plan permits the Employer, at its discretion, to contribute an additional amount to the Plan (“discretionary contribution”). Participants are enrolled at 3% of compensation under an automatic deferral provision (“deferral contribution”) unless they opt out or elect at least an equal deferral amount under a salary reduction agreement. Contributions are subject to certain limitations, and participants direct the investment of their contributions into various investment options offered by the Plan.

#### PARTICIPANT ACCOUNTS

Each participant’s account is credited with the Employer’s safe harbor contribution, the participant’s deferral contribution, investment earnings, and an allocation of the Employer’s discretionary contribution. Each participant’s account is debited for investment losses and an allocation of investment and administrative expenses. Allocations are based on participant account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTE A – DESCRIPTION OF PLAN (Continued)**

**VESTING**

Participants are immediately vested in their deferral contributions, the Employer's safe harbor contributions to their account, and the earnings on these amounts. A participant's vesting in the Employer's discretionary contributions to his or her account plus earnings thereon is based on the participant's years of credited service with the Employer. A participant is 100% vested after six years of credited service.

**PAYMENT OF BENEFITS**

Upon termination of service due to death, disability, retirement, or for other reasons, a participant with a vested account balance in excess of \$5,000 may elect to receive an amount equal to the value of the participant's vested interest in his or her account in (a) a single lump-sum payment, (b) substantially equal installments, or (c) partial withdrawals or installments under the required minimum distribution provisions of Sec. 401(a)(9) of the Internal Revenue Code. A participant electing installment payments will specify the period of time for those payments with such period not to exceed the participant's life expectancy or the joint life expectancy of the participant and his or her designated beneficiary.

Hardship and in-service distributions are also permitted by the Plan subject to certain requirements and limitations as specified in the Plan agreement.

**FORFEITURES**

Forfeitures due to nonvesting totaled \$47,268 and \$55,771 for the years ended December 31, 2024 and 2023, respectively. Employer contributions were reduced by current year and prior year forfeitures in the amounts of \$68,241 and \$38,200 for the years ended December 31, 2024 and 2023, respectively.

### **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **BASIS OF ACCOUNTING**

The financial statements of the Plan have been prepared on the modified cash basis of accounting. This basis differs from accounting principles generally accepted in the United States of America because the Plan has not recognized contributions receivable or payable. The modified cash basis differs from the cash basis because the investments are adjusted to fair value.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **ESTIMATES**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### **INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are stated at fair value, except for a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note C for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the modified cash basis or "when received". Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

CASH

The Plan considers all bank checking accounts, bank money market accounts, and brokerage cash accounts, which are not subject to withdrawal restrictions or penalties, to be cash.

CASH EQUIVALENTS

The Plan considers all money market mutual funds or similar accounts, which are not subject to withdrawal restrictions or penalties, to be cash equivalents.

PAYMENT OF BENEFITS

Benefits are recorded when paid by the Plan.

EXPENSES

Certain administrative expenses, including those pertaining to trustee fees, advisor fees, and contract administration, are paid by the Plan and charged to participants' accounts. Other administrative expenses are paid directly by the Employer and are excluded from these financial statements. In 2023 investment expense of \$624,118 related to contract termination is included in administrative expenses and the corresponding reimbursement is included in other investment income. Also see Note E. Other investment expenses are included in net appreciation (depreciation) in fair value of investments.

SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 1, 2025, the date the financial statements were available to be issued.

**NOTE E – STABLE VALUE INVESTMENTS**

The UTC Stable Value Trust common trust fund, a collective investment trust holding a fully benefit-responsive group annuity contract with Metropolitan Life Insurance Company, was terminated in February 2023 when the Plan changed trustees and service providers. The withdrawal resulted in a termination fee of \$624,118 which was reimbursed by Lincoln National Life Insurance Company (Lincoln).

Lincoln is the provider of the Lincoln Stable Value Account, an unallocated group fixed annuity contract. Lincoln maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a minimum guaranteed interest rate of 1%, however contract termination prior to the fifth anniversary date will result in payment less than the guaranteed value. This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value.

**NOTE F – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Several Plan investments were managed by the prior trustee, American Trust Company, N.A., and therefore, the related transactions qualified as party-in-interest transactions. Certain fees for the related investment management services are paid through revenue sharing, rather than a direct payment. Other related fees are not covered by revenue sharing and are paid directly by the Plan. The total fees, net of revenue sharing, are included in administrative expenses.

**NOTE G – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE H – PLAN RESTATEMENT**

The Plan was restated effective February 1, 2023 in order to change the Plan administrator from the employer to Pentegra Services, Inc.

The Plan was amended and restated effective January 1, 2022 in order to comply with the requirements of the 2017 Cumulative List (Notice 2017-37). Major changes under the restatement include allowing hardship distributions, the addition of a July 1 Plan entry date, and an automatic three-percent deferral provision.

**NOTE I – TAX STATUS**

The Employer has adopted the ADP Volume Submitter 401(k) Profit Sharing Plan. The Internal Revenue Service has determined by letter dated October 6, 2020, that this prototype plan document satisfies the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore the Plan continues to be qualified and the related trust continues to be tax-exempt.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

**NOTE J – RISKS, UNCERTAINTIES AND CONCENTRATIONS**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE K – CASH BALANCE DEFINED BENEFIT PLAN**

The Gastroenterology Associates, P.A. Cash Balance Plan was discontinued at the end of 2023. In January 2024 participants rolled assets totaling \$2,060,805 into the profit sharing plan and trust.

**NOTE L – SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. There were no amendments during 2024 and accordingly no material impact to the Plan's 2024 financial statements.
